To Whom It May Concern:

We are writing in response to IRS Notice CP-403 dated December 1, 2025 regarding the missing Form 5500-SF filing for the plan year ending December 31, 2023 for Dare Solutions LLC.

The retirement plan in question was fully **terminated following an Asset Purchase Agreement (APA) of Dare Solutions LLC**, after which all plan assets were properly distributed and the plan ceased to operate. At the time, we were unaware that we were still required to file a **final Form 5500-SF indicating zero end-of-year assets and marking the return as “final.”** Because of this misunderstanding, the final return was unfortunately not filed on time.

Now that we have been made aware of this requirement through the notice, we have taken steps to file the final Form 5500-SF as instructed.

We respectfully request that any associated penalties or fees be waived. The oversight was unintentional, occurred during the process of winding down the plan following the APA, and involved no remaining assets, participants, or ongoing plan activity. We have fully complied as soon as the issue was brought to our attention.
