INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
Health Fund 917

Opinion

We have audited the accompanying financial statements of Health Fund 917 (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of April 30, 2025 and 2024, and the changes in its net assets available for benefits and benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion


We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.





Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. The supplemental schedules of assets (held at end of year) as of April 30, 2025, and reportable transactions for the year ended April 30, 2025 are presented for purposes of additional analysis and are not a required part of the financial statements, but are supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the April 30, 2025 audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED APRIL 30, 2025 AND 2024

NOTE 1. DESCRIPTION OF PLAN

The following brief description of Health Fund 917 (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General - The Plan is a multiemployer defined benefit welfare fund established under the provisions of an Agreement and Declaration of Trust dated May 1, 1950, between the Teamsters Local Union 917 (the Union), affiliated with the International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America, and employers in the parking, automotive, and other industries who are parties to collective bargaining agreements or participation agreements requiring contributions to the Plan. The Union and the employers agreed to participate in the operation of a trust fund for the purpose of providing health and welfare benefits to eligible employees of contributing employers who are members of the Union. Effective January 1, 2011, the Plan, pursuant to a participation agreement between the New York Oil Heating Association and Local 553 IBT, began providing benefits to members of Local 553 IBT. The Plan is administered by a Board of Trustees (Trustees) consisting of Union and employer representatives and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits - The Plan provides health care benefits to eligible participants and their dependents. Benefits include medical, hospitalization, prescription drug, dental, optical, death benefits, and mental health and substance abuse treatment. These benefits are self-insured and paid out of the general assets of the Plan. To protect itself against high dollar claims, the Plan has obtained stop-loss insurance coverage. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The Plan fully insures its term life insurance and accidental death and dismemberment benefits as well as a portion of its dental benefits. Premiums paid to the insurance companies are paid out of the general assets of the Plan.

Funding Policy - Funding to provide the benefits is made through monthly contributions by participating employers as provided for in the applicable prevailing collective bargaining agreements or participation agreements with the Union. Contributions are also made by the Plan's sponsoring union and other related benefit funds in their capacity as employers, and by participants who have left covered employment and who elect to continue coverage with the Plan through the Consolidated Omnibus Budget Reconciliation Act (COBRA).



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting. Under this basis, revenue is recorded when earned and expenses are recorded when incurred, regardless of when cash is exchanged.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, including estimated amounts for claims incurred but not reported, postretirement benefit obligations, and disclosure of contingent assets and liabilities, if any, at the date of financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines its valuation policies utilizing information provided by the investment managers.

Purchases and sales of securities are recognized on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contribution Receivables - Contribution receivables are stated at the amount management expects to collect from balances outstanding at year end. Management assumes that current conditions as of the financial statement date do not change for the remaining life of the asset. When estimating expected credit losses, management considers subsequent collection activity after year end but before the Plan's financial statements are available to be issued. An allowance for expected credit losses is estimated on any uncollected balances using an adjusted historical loss rate and known contributing employer facts. The Plan has concluded that any expected credit losses on balances outstanding at year end will be immaterial to the financial statements as a whole.

Prescription Drug Rebates - The Plan uses a pharmacy benefit manager (PBM) which periodically provides rebates to the Plan based on the Plan's actual utilization pattern of specific drugs. Rebates due from the Plan's PBM are recorded when earned. Refunds due the Plan as of the financial statement dates have been reported as a receivable, with the offset being netted against benefits paid. Pharmacy rebates totaling \$1,639,196 and \$1,619,253 for the years ended April 30, 2025 and 2024, respectively, have been netted with benefits paid in the accompanying statements of changes in net assets available for benefits and benefit obligations.

Stop-Loss Insurance - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured medical and hospital benefits. Claims over a contractual amount (\$475,000) incurred per participant during a one-year period are reimbursed by the insurance company to the Plan. Premiums paid for the years ended April 30, 2025 and 2024, were \$595,277 and \$756,196, respectively. There were stop-loss recoveries of \$747,987 and \$0- for the years ended April 30, 2025 and 2024, respectively.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Claims Incurred but not Reported - Plan obligations at April 30, 2025 and 2024, for health claims incurred by active participants but not reported at those dates are estimated by the Plan's actuary in accordance with generally accepted actuarial principles that take into consideration prior claims experience and also include analyzing claim lag studies based on data provided by the Plan's third-party claims administrators. Such amounts are reported undiscounted as these obligations typically are payable within one year.

Payment of Benefits - Claim payments and insurance premiums are recorded when paid to the third-party claim processors and insurance companies, respectively. Amounts due to claim processors or the insurance companies at year end that have yet to be paid by the Plan are recorded as claims payable in the accompanying statements of net assets available for benefits and benefit obligations.

Administrative Expenses - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits and benefit obligations. The Plan shares certain administrative expenses with related benefit funds in accordance with a time allocation study.

Operating Leases - In its statements of net assets available for benefits and benefit obligations, the Plan records a right-of-use asset and related lease liability for the rights and obligations associated with operating leases where the Plan is lessee. The leases were initially measured at the present value of total lease payments using a risk-free rate that approximates the remaining term of the leases. The Plan considers the likelihood of exercising renewal or termination clauses (if any) in measuring its right-of-use assets and lease liabilities. A single lease cost is calculated so that the cost of the leases is allocated over the lease terms on straight-line basis. Related disclosures are not included in the financial statements for leases that are considered not material to the financial statements or consist of month-to-month leases that are not considered enforceable agreements. Additional lease disclosures can be found in Note 6.

New Accounting Pronouncement Adopted - During the year ended April 30, 2025, the Plan adopted the provisions of Accounting Standards Update 2025-05, *Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets* (the Update). The Update provides (1) all entities with a practical expedient and (2) entities other than public business entities (PBEs) with an accounting policy election when estimating expected credit losses for current accounts receivable and current contract assets arising from transactions accounted for under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 606, *Revenue from Contracts with Customers*. The Plan adopted the new standard effective May 1, 2024, using the prospective approach.

The Plan has elected to use the practical expedient to assume that current conditions as of the financial statement date do not change for the remaining life of the asset and the accounting policy election to consider subsequent collection activity after year end but before the Plan's financial statements are available to be issued.



NOTE 3. POSTRETIREMENT BENEFIT OBLIGATION

The amount reported as postretirement benefit obligations represents the actuarial present value of those estimated future benefits that are attributed under the terms of the Plan to certain eligible employees' service rendered to the date of the financial statements. Postretirement benefits include future benefits expected to be paid on behalf of and to (1) beneficiaries of currently retired participants and (2) beneficiaries of active employees after retirement from service with participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan's participating employers and from existing plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributable to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical data to estimate future mortality and to adjust such estimates for the time value of money (through discounts for interest). The postretirement benefit is a death benefit in the amount of \$2,500, applicable to the beneficiaries of a closed group of participants in the Plan.

In the event the Plan was to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations. NOTE 4. UNINSURED CASH BALANCES

The Federal Deposit Insurance Corporation (FDIC) insurance limit is \$250,000 per institution. Financial instruments that potentially subject the Plan to concentration of credit risk consist principally of cash held in a high-quality financial institution. The balance at times may exceed FDIC insured amounts. The Plan has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk.

NOTE 5. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include other significant observable inputs including:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.



NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan uses valuation techniques to measure fair value that are consistent with the market approach. The market approach uses prices and other relevant information generated by market transactions involving identical securities.

Accounting standards permit the Plan, as a practical expedient, to estimate the fair value of their investment in certain entities that calculate net asset value (NAV) per share by using the NAV as reported by the management of the entity.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Collective trust fund - Valued at the NAV per share at year end as reported by the collective trust fund (the Fund). The NAV, as provided by the Fund, is used as a practical expedient to estimate the fair value. The NAV is based on the fair value of the underlying investments held by the Fund.

Mutual funds - Valued at the daily closing price reported in the active market in which the funds are traded. The mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price and therefore are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. In addition, the inputs and methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities.

NOTE 6. OPERATING LEASES AS LESSEE

The Plan leases office space at 20 and 22 North Tyson Avenue, Floral Park, NY 11001 under operating leases, which it shares with three other related benefit funds. The terms of both operating leases are for five years each expiring on February 28, 2028. Both leases are non-cancelable. Operating lease expense totaled \$69,836 and \$66,993 for the years ended April 30, 2025 and 2024, respectively. The Plan had no variable or short-term lease expense in the years ended April 30, 2025 and 2024, and does not have any finance leases.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and to uncertainties in estimates and assumptions, it is at least reasonably possible that changes in the values of such investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and benefit obligations.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, mortality rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.



NOTE 8. TAX STATUS

The Plan has received an exemption letter from the Internal Revenue Service (IRS) stating that the trust established under the Plan was in compliance with the applicable requirements of Section 501(c)(9) of the Internal Revenue Code (IRC). The Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Trustees believe that the Plan, as amended, is operating in compliance with the applicable requirements of the IRC and, therefore, believe that the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 30, 2025 and 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan operates in the same office as other related benefit funds. Office salaries and overhead expenses which are common to all funds are apportioned on an equitable basis. The Plan acts as the paying agent for all shared administrative expenses. Consequently, the Local 917 Pension Fund, Local 868 IBT Pension Fund, and Local 816 Labor and Management Pension Trust Fund (affiliated benefit funds), reimburse the Plan for their estimated share of administrative expenses paid on their behalf, as determined by the Board of Trustees under a cost sharing agreement. Allocable administrative expenses include payroll and payroll related costs, employee benefits, occupancy costs, payroll audit fees, as well as other administrative expenses. Total reimbursable amounts from other affiliated benefit funds for shared administrative expenses for the years ended April 30, 2025 and 2024, totaled \$213,761 and \$232,078, respectively. Amounts due the Plan at April 30, 2025 and 2024, totaled \$13,890 and \$16,115, respectively. These amounts were subsequently received by the Plan.

The Plan pays certain administrative, investment, and professional fees to various service providers. These transactions are considered exempt party-in-interest transactions under ERISA.

NOTE 10. PRIORITIES UPON TERMINATION

Although they have not expressed any intention to do so, the Trustees, as Plan Sponsor, have the right under the Plan to modify the benefits provided to participants and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan will be used for purposes other than for the exclusive benefit of Plan's participants and reasonable administrative expenses.

NOTE 11. PARTICIPATION IN MULTIEMPLOYER PLANS

Defined Benefit Pension Plans

The Plan's office employees, which it shares with other affiliated benefit funds, are covered by multiemployer defined benefit pension plans. The risks of participating in a multiemployer plan are different from single-employer plans in the following aspects:

- Assets contributed to the multiemployer plan by one employer may be used to provide benefits to employees of other participating employers.
- If a participating employer stops contributing to the Plan, the unfunded obligations of the Plan may be borne by the remaining participating employers.
- If an employer chooses to stop participating in this multiemployer plan, the employer may be required to pay an amount, referred to as a withdrawal liability, based on the under-funded status of the Plan.

The Plan's participation in this plan for the years ended April 30, 2025 and 2024, is outlined in the table below. The "EIN and Pension Plan Number" rows provide the Employer Identification Number (EIN) and the three-digit plan number. The most recent Pension Protection Act (PPA) zone status available in 2025 and 2024 is for the multiemployer plans year ends at January 31, 2026 and 2025, respectively, and October 31, 2025 and 2024, respectively. The zone status is based on information that the Plan received from the multiemployer plans and is certified by the Plans' actuaries. Among other factors, plans in the red zone are generally less than 65 percent funded, plans in the yellow zone are less than 80 percent funded, and plans in the green zone are at least 80 percent funded. The FIP/RP Status row indicates whether a funding improvement plan (FIP) or a rehabilitation plan (RP) is either pending or has been implemented. In addition to regular plan contributions, the Plan may be subject to a surcharge if the Plan is in the red zone. The "Surcharge Imposed" row indicates whether a surcharge has been imposed on contributions to the Plan. There have been no significant changes that affect the comparability of 2025 and 2024 contributions. Contributions reported on the next page represent the Plan's proportionate share of the contributions made to this multiemployer plan.



