## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the Doma 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the financial statements of Doma 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Doma 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Doma 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Doma 401(k) Plan became effective January 1, 2022 as a savings/retirement plan for qualified employees of Doma Corporate, LLC (the Sponsor or Company) and affiliated companies. The Plan is a defined contribution plan covering all eligible employees of the Sponsor who have attained the age of 18, excluding employees covered by a collective bargaining agreement, non-resident aliens with no U.S. income, and certain interns, part-time and temporary employees. The Plan is subject to provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

The Company terminated several employees in 2023. In total, the participants who were terminated amounted to more than 20% of plan participants. Accordingly, the Plan Sponsor determined that a partial plan termination had occurred. All participants who were affected by the terminations were fully vested in their account balances.

In 2024, the Plan merged into the Title Resources Group 401(k) Plan. As such, there were no assets remaining as of December 31, 2024.

Fidelity Management Trust Company serves as the Plan's trustee and Fidelity Workplace Services LLC serves as the Plan's recordkeeper.

**Contributions** – Participants are permitted to make salary deferral contributions of up to 90% of their compensation to the Plan on a pre-tax or Roth basis, as defined by the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions up to the annual limit determined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified retirement plans and may direct the investment of their contributions into various options offered by the Plan. The Plan also has an auto-enrollment feature where upon reaching eligibility, all employees are enrolled at 3% pre-tax contribution unless electing out of the Plan. All participants will also have their contribution rate increased 1% each year until it reached 10%, unless the participant chooses to change this rate.

The Company makes safe harbor matching contributions equal to 100% of the first 1% of participant contributions and 50% of the next 5% contributed. The Company may also make discretionary matching contributions. For 2024, the Company made no discretionary matching contributions to the Plan.

**Participants' Accounts** – Each participant's account is credited with the participant's contribution and Plan earnings. The accounts are set up in participant-directed, individual accounts administered by the Plan recordkeeper. Contributions and earnings or losses are credited to the accounts as the amounts are received by the trustee. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting** – Participants are immediately 100% vested in all participant contributions and actual earnings thereon. The employee's interest in any matching or discretionary contribution will vest 100% after 2 years of vesting service.

**Investment Options** – Participants direct the investment of their contributions into selected investment products offered by the Plan trustee. The investment options include fixed income accounts and various income, growth, value, blend, and international mutual fund accounts. Participants may change their investment options daily.

**Payment of Benefits** – Benefits are payable to participants or designated beneficiaries upon retirement, death, disability, or termination of employment. Participants are entitled to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Benefits may also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

**Participant Loans** – The Plan allows loans to participants from their fund accounts up to a maximum equal to the lesser of (1) \$50,000, or (2) 50% of the current value of the vested account balance. Loans are secured by the participant's Plan benefit and a promissory note. Participants may not have more than one loan outstanding at any time. The interest rate is based on the prime rate plus two percentage points. Loans are repaid through payroll deductions within a 5 year period, unless the loan was made to acquire a primary residence, in which case the loan can be repaid within a period of no more than 30 years.

**Forfeitures** – If employment with the Company is terminated, the employee receives a distribution of the entire vested portion of the account but forfeits the non-vested portion. Forfeited nonvested accounts totaled \$0 and \$327,120 at December 31, 2024 and 2023, respectively. Forfeitures can be used to offset plan expenses or reduce Company contributions. Forfeitures of \$517,361 were used during 2024 to fund Company contributions.

**Plan Termination** – Although it has not expressed any intent to do so, the Sponsor has the right, under terms of the Plan, to terminate the Plan subject to the provisions of ERISA.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** – The financial statements are prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates** – The preparation of financial statements in conformity with accounting standards generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** – Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission (SEC). These mutual funds are required to publish their daily net asset value (NAV) and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

All investments are participant directed.

**Plan Administration Costs** – Administrative expenses of maintaining the Plan may be paid by the Company or the Plan, as provided by the Plan document. Expenses that are paid directly by the Sponsor are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits** – Benefits are recorded when paid.

**Subsequent Events** – Management has evaluated, for potential recognition or disclosure in the financial statements, subsequent events that have occurred through November 24, 2025, which is the date that the financial statements were available to be issued.

**NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)**

The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C). As permitted under such election, no independent auditing procedures were performed with respect to the information certified as complete and accurate by the Plan's trustee, Fidelity Management Trust Company (Fidelity). Fidelity has certified its statement of accounts as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The statement of accounts includes beginning and ending balances of investments held, notes receivable from participants, and detail of transactions during the period, including investment earnings and interest income on notes receivable from participants.

**NOTE 4 - INCOME TAX STATUS**

The Plan has adopted a prototype format and is relying on the prototype sponsor's IRS determination letter for qualification. In the prototype sponsor's tax determination letter dated June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

**NOTE 5 - FAIR VALUE MEASUREMENTS**

Fair value accounting guidance establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plans have the ability to access.

**Level 2** Inputs to the valuation methodology other than quoted prices included in Level 1 are observable for the asset or liability, each directly or indirectly, and include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used as of December 31, 2024 and 2023. The methods described above could produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan administrator believes these valuation methods are appropriate, the use of different methodologies or assumptions could result in different fair value measurements at the reporting date.

**Common and collective trusts (CCTs)** - Investments in CCTs are valued at the net asset value (NAV) of units of a bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. The unit value of each of these funds is determined on a daily basis. Units are issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value. Were the Plan to initiate a full redemption of a CCT, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Registered investment company funds** - Valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The registered investment company funds held by the Plan are deemed to be actively traded.

**Self-directed brokerage accounts** - Actively traded money market funds are measured at NAV. The fair value of common stock and exchange-traded funds are determined using quoted prices in active markets. The fair value of mutual funds is determined by the NAV which represents the exit price.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds by the plan trustee as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the Doma 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the financial statements of Doma 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Doma 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Doma 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Doma 401(k) Plan became effective January 1, 2022 as a savings/retirement plan for qualified employees of Doma Corporate, LLC (the Sponsor or Company) and affiliated companies. The Plan is a defined contribution plan covering all eligible employees of the Sponsor who have attained the age of 18, excluding employees covered by a collective bargaining agreement, non-resident aliens with no U.S. income, and certain interns, part-time and temporary employees. The Plan is subject to provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

The Company terminated several employees in 2023. In total, the participants who were terminated amounted to more than 20% of plan participants. Accordingly, the Plan Sponsor determined that a partial plan termination had occurred. All participants who were affected by the terminations were fully vested in their account balances.

In 2024, the Plan merged into the Title Resources Group 401(k) Plan. As such, there were no assets remaining as of December 31, 2024.

Fidelity Management Trust Company serves as the Plan's trustee and Fidelity Workplace Services LLC serves as the Plan's recordkeeper.

**Contributions** – Participants are permitted to make salary deferral contributions of up to 90% of their compensation to the Plan on a pre-tax or Roth basis, as defined by the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions up to the annual limit determined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified retirement plans and may direct the investment of their contributions into various options offered by the Plan. The Plan also has an auto-enrollment feature where upon reaching eligibility, all employees are enrolled at 3% pre-tax contribution unless electing out of the Plan. All participants will also have their contribution rate increased 1% each year until it reached 10%, unless the participant chooses to change this rate.

The Company makes safe harbor matching contributions equal to 100% of the first 1% of participant contributions and 50% of the next 5% contributed. The Company may also make discretionary matching contributions. For 2024, the Company made no discretionary matching contributions to the Plan.

**Participants' Accounts** – Each participant's account is credited with the participant's contribution and Plan earnings. The accounts are set up in participant-directed, individual accounts administered by the Plan recordkeeper. Contributions and earnings or losses are credited to the accounts as the amounts are received by the trustee. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting** – Participants are immediately 100% vested in all participant contributions and actual earnings thereon. The employee's interest in any matching or discretionary contribution will vest 100% after 2 years of vesting service.

**Investment Options** – Participants direct the investment of their contributions into selected investment products offered by the Plan trustee. The investment options include fixed income accounts and various income, growth, value, blend, and international mutual fund accounts. Participants may change their investment options daily.

**Payment of Benefits** – Benefits are payable to participants or designated beneficiaries upon retirement, death, disability, or termination of employment. Participants are entitled to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Benefits may also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

**Participant Loans** – The Plan allows loans to participants from their fund accounts up to a maximum equal to the lesser of (1) \$50,000, or (2) 50% of the current value of the vested account balance. Loans are secured by the participant's Plan benefit and a promissory note. Participants may not have more than one loan outstanding at any time. The interest rate is based on the prime rate plus two percentage points. Loans are repaid through payroll deductions within a 5 year period, unless the loan was made to acquire a primary residence, in which case the loan can be repaid within a period of no more than 30 years.

**Forfeitures** – If employment with the Company is terminated, the employee receives a distribution of the entire vested portion of the account but forfeits the non-vested portion. Forfeited nonvested accounts totaled \$0 and \$327,120 at December 31, 2024 and 2023, respectively. Forfeitures can be used to offset plan expenses or reduce Company contributions. Forfeitures of \$517,361 were used during 2024 to fund Company contributions.

**Plan Termination** – Although it has not expressed any intent to do so, the Sponsor has the right, under terms of the Plan, to terminate the Plan subject to the provisions of ERISA.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** – The financial statements are prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates** – The preparation of financial statements in conformity with accounting standards generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** – Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission (SEC). These mutual funds are required to publish their daily net asset value (NAV) and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

All investments are participant directed.

**Plan Administration Costs** – Administrative expenses of maintaining the Plan may be paid by the Company or the Plan, as provided by the Plan document. Expenses that are paid directly by the Sponsor are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits** – Benefits are recorded when paid.

**Subsequent Events** – Management has evaluated, for potential recognition or disclosure in the financial statements, subsequent events that have occurred through November 24, 2025, which is the date that the financial statements were available to be issued.

**NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)**

The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C). As permitted under such election, no independent auditing procedures were performed with respect to the information certified as complete and accurate by the Plan's trustee, Fidelity Management Trust Company (Fidelity). Fidelity has certified its statement of accounts as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The statement of accounts includes beginning and ending balances of investments held, notes receivable from participants, and detail of transactions during the period, including investment earnings and interest income on notes receivable from participants.

**NOTE 4 - INCOME TAX STATUS**

The Plan has adopted a prototype format and is relying on the prototype sponsor's IRS determination letter for qualification. In the prototype sponsor's tax determination letter dated June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

**NOTE 5 - FAIR VALUE MEASUREMENTS**

Fair value accounting guidance establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plans have the ability to access.

**Level 2** Inputs to the valuation methodology other than quoted prices included in Level 1 are observable for the asset or liability, each directly or indirectly, and include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used as of December 31, 2024 and 2023. The methods described above could produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan administrator believes these valuation methods are appropriate, the use of different methodologies or assumptions could result in different fair value measurements at the reporting date.

**Common and collective trusts (CCTs)** - Investments in CCTs are valued at the net asset value (NAV) of units of a bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. The unit value of each of these funds is determined on a daily basis. Units are issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value. Were the Plan to initiate a full redemption of a CCT, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Registered investment company funds** - Valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The registered investment company funds held by the Plan are deemed to be actively traded.

**Self-directed brokerage accounts** - Actively traded money market funds are measured at NAV. The fair value of common stock and exchange-traded funds are determined using quoted prices in active markets. The fair value of mutual funds is determined by the NAV which represents the exit price.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds by the plan trustee as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.
