Opinion on the Financial Statements

We have audited the financial statements of CollabraLink Technologies Health and Welfare Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in benefit obligations and net assets available for benefits (modified cash basis) for the year ended December 31, 2024 and for the period from October 1, 2023 through December 31, 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the plan benefit obligations and the net assets available for benefits (modified cash basis) of the Plan as of December 31, 2024 and 2023, and the changes in its plan benefit obligations and net assets available for benefits (modified cash basis) for the year ended December 31, 2024 and for the period from October 1, 2023 through December 31, 2023, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances.

Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Note 1. Description of Plan

The following description of the CollabraLink Technologies Health and Welfare Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was effective on October 1, 2019, and provides healthcare benefits for eligible employees, their spouses, and the eligible dependents of Groundswell (the "Sponsor" or "Employer"). A full-time employee who regularly works 30 or more hours of service per week is eligible to enroll for coverage under the Plan as of the first day of employment. Management believes that the Plan is an "Employees' Welfare Benefits Plan" of the *Employee Retirement Income Security Act of 1974* (ERISA) as amended. The Plan is subject to the provisions of ERISA.

The Plan's year end was changed from September 30 to December 31 following a short period from October 1, 2023 through December 31, 2023. As such, the accompanying financial statements include the short period from October 1, 2023 through December 31, 2023.

Administration of the Plan

The Plan is funded in part by Groundswell and by contributions made through payroll deductions by participating employees and those participants who have been separated from service pursuant to the *Consolidated Omnibus Budget Reconciliation Act* (COBRA). The employees' contributions are determined annually, in advance, by the Plan Sponsor. Employer contributions, representing the balance of funds necessary for the Plan's operations, are contributed as needed from the general assets of the Sponsor.

The Sponsor's human resources department oversees the enrollment of eligible employees and maintains records of plan participants. Routine administrative functions and benefit claims administration are provided by third party administrators. Funds used for benefit payment expenses in respect of the Plan were transmitted by the CollabraLink Technologies, Incorporated (doing business as Groundswell) Health Benefit Trust.

The Plan's record-keeping and adjudication and disbursement of medical expense claims is delegated to the administrators who provide the Sponsor a monthly accounting of the Plan's financial activity, including copies of check registers, a summary of expenses paid, a listing of persons for whom benefits are paid, and the amounts of such payments.

Benefits

The Plan provides health benefits (medical and prescription drugs). The Plan also provides continuation of certain benefits upon termination of employment through COBRA.

Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to or on behalf of participants. Despite the Plan's utilization of third-party claim processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Stop Loss Coverage

The Plan maintains excess risk insurance in an effort to limit its exposure for self-insured benefits including individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims. For the year ending December 31, 2024 and the period from October 1, 2023 through December 31, 2023, benefits paid for health claims exceeding \$100,000 and \$90,000, respectively, for any individual participant, up to a maximum aggregate benefit of \$1,000,000 per coverage period, are covered by the excess risk insurance and are reimbursable to the Plan. The Plan recorded reimbursements for excess risk insurance of approximately \$209,000 and \$20,000, which is reported as a reduction to health benefits payments in the accompanying statements of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024 and the period from October 1, 2023 through December 31, 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting, an accounting practice permitted by the Department of Labor. Consequently, contributions and reimbursements are recognized when received rather than when due and investment income is recorded when received rather than when earned. Accordingly, the accompanying financial statements are not intended to present the financial position and changes in net assets available for benefits of the Plan in conformity with accounting principles generally accepted in the United States of America (GAAP).

Interest-Bearing Cash

At times, interest bearing cash may exceed amounts insured by the Federal Deposit Insurance Corporation (FDIC). The Plan has not experienced losses in such accounts. The Plan believes it is not exposed to any significant credit risk on cash. Interest income is recorded when received.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates and assumptions. Areas requiring significant estimates include health claims incurred but not reported.

Payment of Benefits

Claim payments are recorded when paid by the third-party processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as claims payable. The excess of benefit obligations over net assets available for benefits will be funded by the Sponsor when claims are submitted for payment.

Rebates and Refunds

Rebates and refunds are recorded when paid. Rebates totaling approximately \$181,000 and \$20,000 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the year ended December 31, 2024 and the period from October 1, 2023 to December 31, 2023, respectively.

Stop Loss Coverage

Stop loss coverage premiums are recorded when paid as stop loss premium fees in the accompanying statements of changes in net assets available for benefits. Stop loss refunds are recorded when received as a reduction of health benefits expense.

Administrative Expenses

The Plan's administrative expenses consist primarily of fees paid to third-party claims administrators and other service providers. Administrative expenses are paid by the Plan and Sponsor, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Subsequent Events

The Plan has evaluated subsequent events through November 20, 2025, the date the financial statements were available to be issued.

Note 3. Health Claims Payable and Incurred but not Reported

Benefit obligations consist of claims for health benefits which have been reported, but remain unpaid, and an estimate of claims for benefits which may have been incurred but remain unreported as of December 31, 2024 and 2023. Plan obligations as of December 31, 2024 and 2023 for claims incurred but not reported are estimated by the Plan's administrators based on claims data. These amounts are paid by the Plan only if claims are submitted and approved for payment. The estimate is based upon the monetary value of claims reported during the year, the Plan's historical experience of lag time between date of eligible service and the related claim payment, as well as an estimate of healthcare cost increases based on industry experience.

Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these judgements and assumptions in the near term would be material to the financial statements.

Note 4. Exempt Party-In-Interest Transactions

The Plan does not consider employer contributions to the Plan to be party-in-interest transactions. The Sponsor provides certain accounting and administrative functions to the Plan for which no fees are charged. Additionally, the Sponsor pays certain administrative expenses of the Plan.

As described in Note 1, the Plan has arrangements with various service providers. These transactions are considered exempt party-in-interest transactions under ERISA.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 6. Tax Status

The provisions of Internal Revenue Code (IRC) 419A(g)(1), relative to unrelated business income of the Plan, and IRC 419A(c)(1), relative to qualified asset funding limitations are applicable for the Plan year ended December 31, 2024 and 2023. The Plan's resident assets at December 31, 2024 and 2023, did not exceed the qualified asset funding limitations prescribed and, therefore, no unrelated business income as defined in IRC 512(a)(3) or tax obligation was incurred. In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status. Neither the Plan nor the Trust has applied for an Internal Revenue Service (IRS) determination letter. However, the Plan has been designed and operated in accordance with IRS regulations. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
