Dear Sir or Madam,

I am writing to respectfully request **penalty relief** for the late filing of our Form 5500 for the plan year ending 2024. The delay was due to **reasonable cause** and not willful neglect.

Unfortunately, due to staffing issues which resulted in me having to juggle multiple roles, on top of a hectic personal circumstances (medical issues with daughter and unexpected mold issue/remediation/construction), it was an oversight on my part and not willingly neglected. We became aware of the oversight on November 21, 2025, and I took immediate steps to correct it by writing this letter in hopes of penalty relief and getting it filed ASAP.

I have implemented corrective measures to ensure timely compliance in the future by adding to my calendar alert reminders!

Given these circumstances, we respectfully request that the IRS consider our situation as reasonable cause under applicable guidelines and **waive the assessed penalties**. We have always endeavored to remain compliant with all filing requirements and regret this isolated oversight.
