Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **1. Plan Description**

The following brief description of Powell's Books, Inc. Retirement and 401(k) Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document and summary plan description for more complete information.

### **General**

The Plan is a defined contribution plan covering union and nonunion employees of Powell's Books, Inc. (the "Company" or "employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended ("ERISA"). The Company is the plan administrator as defined by ERISA and the plan document; accordingly, an administrative committee comprised of certain members of the Company's management is responsible for oversight of the Plan. The administrative committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. Charles Schwab Trust Bank is the Plan's trustee.

### **Eligibility**

Each nonunion employee of the Company is eligible to be a participant in the Plan and enters the Plan on their date of hire.

Each union employee of the Company who works more than 1,000 hours during a 12-month period, beginning with the date of employment, is eligible to be a participant in the Plan upon completion of one year of service. Union employees who qualify to become participants enter the Plan on January 1 or July 1.

### **Contributions**

Individual participants may elect to defer a percentage of their compensation for the plan year, not to exceed certain dollar amounts as determined by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from certain other qualified retirement plans ("Rollovers"). If an eligible nonunion employee elects to make participant deferrals to the Plan, the Company may contribute an employer matching contribution equal to 50 percent of such deferrals up to a prescribed discretionary limit as determined by the Company. In addition, each year the Company may elect to contribute to the Plan an additional supplemental contribution on behalf of all eligible nonunion employees based on the eligible compensation for each participant who is employed by the Company during the year. For the plan year ended June 30, 2025, the Company elected to contribute no discretionary supplemental profit sharing contributions on behalf of nonunion employees. For the plan year ended June 30, 2025, the Company elected to remit a discretionary matching contribution on behalf of eligible nonunion employees. Participants direct the investment of their contributions into various investment options offered by the Plan.

### **Contributions Required by Collective Bargaining Agreement**

The Company is required to remit to the Plan certain contributions on behalf of all eligible union employees based on the provisions of the collective bargaining agreement between the Company and the union which has been executed effective December 15, 2023 (the "CBA"). For each of the plan years ending June 30, 2024, 2025, 2026, and 2027, the most recently executed CBA requires the Company to remit, on behalf of each eligible union employee, an annual matching contribution in an amount equal to 50 percent of the participant's elective deferrals under the Plan up to a maximum of 1.85 percent of the participant's eligible compensation as defined by the plan document (the "Union

Contribution"). To be eligible to receive the annual matching contribution, union employees must perform at least 1,000 hours of service during the plan year, be employed by the Company on the last day of the plan year, and make elective deferrals during the plan year.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of any employer contributions, plan earnings, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are fully vested in their respective participant contribution accounts at all times. Effective July 1, 2000, participants who are employed by the Company on or after August 14, 2000 are fully vested in the employer contribution account. Participants who terminated employment with the Company prior to August 14, 2000 are vested in their employer contribution accounts based on years of service.

#### **Forfeited Accounts**

If a participant has terminated employment with the Company before he or she became fully vested, the unvested portion of his or her account is forfeited and the amount attributable to matching contributions is reallocated to the remaining participants in accordance with the provisions of the Plan.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates based on the prime rate, as stated in the Wall Street Journal, plus one percentage point. Principal and interest is paid ratably through payroll deductions. Loan terms may not exceed five years unless the loan is used to acquire a dwelling unit which will be used as the principal residence of the participant, as defined by the Plan, which may have a term of up to fifteen years.

#### **Payment of Benefits**

The amount of benefits payable under the Plan will be the vested amount in the participant's account as of the distribution date of a participant's retirement, death or disability benefit. If termination of employment occurs prior to normal retirement age, the vested amount in the participant's account is payable immediately based on the most recent valuation or at the next valuation date after termination. If the vested amount in the participant's account is greater than \$1,000 at termination, the participant may elect to keep the vested portion in the Plan. Distributions are made as soon as administratively feasible upon a participant's death or disability. Upon termination of service, a participant may elect to receive a single lump sum distribution or a direct rollover to an Individual Retirement Account ("IRA") or eligible retirement plan.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2025 or 2024. If a participant ceases to make loan repayments, and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced to zero and a benefit payment is recorded.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Personnel within the Company perform various administrative services for the Plan. The payroll and related overhead costs associated with these services are not included in the Plan's expenses and have not been otherwise disclosed or taken into account in the accompanying financial statements.

Investment related expenses are included in net appreciation of fair value of investments. Administrative expenses paid directly by the Plan consist primarily of custodial, recordkeeping, investment management, legal, and auditing fees. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

### **Subsequent Events**

Management has evaluated subsequent events through November 22, 2025, the date the financial statements were available to be issued.

## 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank.

## 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

**Level 1.** Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. Fair values are provided to the Plan by Charles Schwab Trust Bank for the Plan's investment assets as follows:

**Cash:** Deposits with no stated maturity, such as cash balances, are valued at the amount payable on demand.

**Registered investment companies:** Investments in registered investment companies, including money market accounts and other mutual funds, are valued at the daily closing price as reported by the respective fund. Registered investment companies held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5. Related Party and Party-In-Interest Transactions**

Certain investments consist of funds held and managed by affiliates of Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for certain investment expenses are included in net appreciation in fair value of investments, as they are paid through fees charged at the investment level rather than direct payments remitted by the Plan. The Plan made direct payments for plan administration, investment advisory, and accounting expenses totaling \$135,210 during the year ended June 30, 2025. The Company pays directly certain other fees related to the Plan's operations.

## **6. Plan Termination**

Although it has not expressed any intent to terminate the Plan, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become fully vested

in their accounts. The net assets of the Plan would be allocated and distributed to the participants and beneficiaries of the Plan in proportion to their interests.

**7. Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated September 6, 2013, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed, and currently being operated, in compliance with applicable sections of the IRC and, therefore, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
