NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Description of the Plan

The following description of the Patriot National, Inc. 401(k) Employee Savings Plan (the “Plan”) provides only general information. For a complete description of the Plan, participants should refer to the specific provisions of the Plan Agreement or Summary Plan Description, each of which is available from the plan administrator at 5900 North Andrews Avenue, 10th Floor, Fort Lauderdale, Florida 33309.

Effective July of 2018, the plan sponsor ceased operations, however, employer and employee contributions have been made since July, 2018 through December 31, 2019. The Plan remains a separate legal entity and continues to hold participant account balances, which are invested according to prior elections. No contributions were made during the year ended December 31, 2024.

General

Patriot National, Inc. and its affiliates (the “plan sponsor”) participate in a defined contribution plan covering all employees. The Plan covers all full-time employees of the plan sponsor who have completed one month of service and are age eighteen or older. The Plan became effective March 15, 1996 and was later amended as of March 1, 2016.

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Fidelity Management Trust Company (“Fidelity”) serves as the trustee of the Plan.

Eligibility

Employees become eligible to participate in the Plan after one month of employment and attainment of age 18. Once an employee has met this requirement, they are eligible to enter the Plan on the next Plan entry date. The Plan entry date is the first day of the month following the day the employee meets the participation requirements. These requirements are the same for eligibility to receive discretionary profit-sharing and employer match contributions. Interns and part-time employees are eligible to participate upon attainment of age 21 and have completed a minimum of 1,000 hours of service.

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Contributions

For the purposes of determining contributions, only compensation paid to employees for services performed while employed as an eligible employee shall be considered. Participants may elect to contribute the lesser of 100% of their eligible compensation or the Internal Revenue Service (IRS) maximum deferral, as defined by the Plan. Under IRS Code Section 402(g)(1), the maximum deferral of pretax earnings was \$23,000 for the year ended December 31, 2024.

Contributions (Continued)

Those participants who have attained age 50 before the end of the plan year are eligible to make an additional \$7,500 in catch-up contributions in 2024.

There are three types of contributions to the Plan:

a) Employee contributions - eligible employees are automatically enrolled in the Plan unless the employee elects otherwise. The automatic enrollment contribution is equal to 2% of eligible compensation, as defined in the Plan, subject to certain limitations. Employees may also designate some or all of their contributions as after-tax Roth contributions. Employee contributions totaled approximately \$0 for the year ended December 31, 2024.

b) Employer contributions - the plan sponsor made discretionary matching contributions to the Plan in an amount determined annually by the plan sponsor. Matching contributions totaled \$0 for the year ended December 31, 2024. Additional discretionary non-elective contributions may be funded at the option of the plan sponsor's Board of Directors for each Plan Year. The Company did not elect to make any discretionary non-elective contributions in 2024.

c) Rollover contributions - employees may also contribute any discretionary amounts into certain investments of the Plan from other qualified plans or individual retirement accounts. Rollover contributions totaled approximately \$0 for the year ended December 31, 2024. The Company determines which rollover contributions are acceptable and whether the rollover contribution fails to meet the requirements of the Plan and must be distributed. If the contribution is not a direct rollover (i.e., a cash distribution was received from the eligible retirement plan), it must be received by Fidelity within 60 days of receipt of the distribution.

Participant Accounts

Each participant's account is credited with the participant's elective contributions, the allocation of forfeitures of terminated participant's non-vested accounts and the participant's portion of the net Plan earnings. Allocations of forfeitures are made in the succeeding Plan year in the ratio which the compensation of each participant for the Plan year bears to the total compensation of all participants entitled to share in the contributions. Allocation of net Plan earnings is based on participant account balances and their specific investment choices.

Vesting

Participants are 100% vested in their contributions and earnings thereon regardless of length of participation.

Vesting (Continued)

Vesting in the employer discretionary profit sharing or matching contributions plus actual earnings is based on years of credited service. A participant is 100% vested after six years of credited service in any discretionary contributions as follows:

All employees hired prior to February 1, 2013 are 100% vested after three years of credited service.

Forfeitures

Forfeitures result from termination of employment before full vesting has occurred and are used to pay Plan expenses. Any remaining forfeitures will be used to reduce the employer's subsequent contributions to the Plan. For the year ended December 31, 2024, forfeitures totaling \$0, which was used to offset the discretionary employer matching contributions for the plan year.

Payment of Benefits

Benefits are payable from a participant's account under the Plan's provision, upon a participant's death, retirement, or other form of termination of employment. All vested account balances less than \$1,000 may be distributed automatically to the participant. Participants who have reached age 59½ may withdraw all or a portion of their vested accounts while still employed by the plan sponsor. Additionally, under certain circumstances of financial hardship, participants are allowed to withdraw funds from the Plan, in accordance with Plan provisions. Distributions and withdrawals are recorded when paid.

Administrative Expenses

The Company pays certain administrative expenses related to the Plan. The Plan incurred administrative fees of approximately \$7,200 for the year ended December 31, 2024.

Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (see Note 3 for discussion of fair value measurements). Shares or mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at the year end. Security transactions are recorded on a trade date basis, which is the date the order to buy or sell is executed. Interest income and expenses are accrued on a daily basis. Dividend income and distributions to participants are recorded on the ex-dividend date.

The common collective trusts are fully benefit-responsive investments with Galliard Capital Management. These investments are reported at contract value, which approximates fair value as of December 31, 2024 and 2023 (see Note 3 for discussion of fair value investments).

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to any of the various Fidelity investment options (see Note 2). Participants may change their investment options at any time.

Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in these risks and uncertainties in the near term would materially affect participant account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

The cessation of the plan sponsor's operations may affect the Plan's ability to continue in its current form. While participant account balances remain invested, the Plan's future depends on administrative decisions, including whether the Plan will be terminated.

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

NOTE 2. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

Fidelity Management Trust Company (Fidelity), the Trustee, held the Plan's investments as of December 31, 2024 and 2023. The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the schedule of Form 5500 – Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments (principally mutual funds) and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$565,777. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

NOTE 3. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual term), the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of the unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value.

Mutual funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued on the basis of the relative interest of each participating investor in the fair value of the underlying assets of each of the respective common/collective trusts. The underlying assets are valued based on the NAV as provided by the investment account manager. The NAV is used as a practical expedient to estimate fair value. The Plan invests in investment contracts through the Wells Fargo Stable Value Fund. Contract value is the relevant measurement of net assets available for benefits in a defined contribution plan that holds fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE 4. PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. The Company pays certain professional fees for the administration and audit of the Plan. Certain Plan investments are mutual funds and fully-benefit responsive investment contracts managed by Fidelity and Wells Fargo. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 5. TAX STATUS

The Plan obtained its latest determination letter in March 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan sponsor, as well as the plan trustee, believe the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 5. TAX STATUS (Continued)

Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken by the Plan. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6. OTHER MATTERS

ERISA Bond

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles plan assets be bonded to protect the plan against loss due to fraud or dishonesty. For the plan years ended December 31, 2019 through 2024, the auditor was unable to obtain evidence that a fidelity bond was in place covering individuals who may have had authority over plan assets.

The absence of a fidelity bond may represent a noncompliance with ERISA requirements. Management has indicated that the plan sponsor is no longer operational and that plan assets are held by a third-party custodian. However, as of the date of this report, no documentation has been provided to confirm that the plan itself was covered by a fidelity bond during the referenced periods.

Furthermore, since no employees of the Company who would normally have access to the handling of plan assets existed since 2019, there would be no need to provide a bond to secure the plan assets for that period through the date of the audited financial statements.

Termination of the Plan

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants' accounts will become fully vested in their accounts.

Bankruptcy

During the Plan year 2018, the plan sponsor filed for bankruptcy, which caused a significant increase in the Plan's benefits paid to participants as terminated employees closed their account balances by cash distributions or transferred their balances to other qualified employee benefit plans or individual IRAs.

Date of Management Review

Management has evaluated subsequent events through November 21, 2025, the date the financial statements were available to be issued.

The plan sponsor ceased operations in July of 2018. However, employer and employee contributions have been made since July, 2018 through December 31, 2019. The Plan administrator is evaluating options for future administration, including potential termination. The accompanying financial statements do not include any adjustments that might result from this uncertainty.
