Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Strategic Pharmaceutical Solutions 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Description of Plan

The following description of the Strategic Pharmaceutical Solutions 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Strategic Pharmaceutical Solutions, Inc. (the Company) who are at least 18 years of age. Employees are entitled to share in matching contributions upon satisfying the eligibility conditions described above. Employees are entitled to share in discretionary profit sharing contributions upon meeting the age requirement, as well as being employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is a Qualified Automatic Contribution Arrangement (QACA) safe harbor plan, which exempts the Plan from anti-discrimination requirements on accounts of highly compensated employees, while maintaining that the Company make minimum contributions to all participant accounts making elective contributions.

Contributions

A participant may elect to contribute up to the lesser of 96% of eligible compensation or the maximum allowed under the Internal Revenue Code (IRC) each year instead of receiving that amount in cash. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions include employee pre-tax salary deferral contributions, after-tax Roth deferral contributions, or a combination of both. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). The pre-tax amount deferred will not be subject to income tax until it is actually distributed to the participant. The amount deferred is, however, subject to Social Security tax at the time of deferral. The participant may change their deferral election each pay period.

Participants are automatically enrolled at a deferral rate of 3% of eligible wages. At the time of enrollment, the Plan automatically withholds 3% from each participant's compensation, unless the participant affirmatively elects to defer a smaller or larger percentage. Automatic enrollment contributions will begin the first pay period following the participant's date of hire, but not sooner than the participant's entry date.

The Company has elected to make QACA safe harbor matching contributions equal to 100% of the participant's contribution that are not over 2% of eligible compensation, plus 50% of the participant's contributions which are over 2% but not over 6% of eligible compensation. The Company made safe harbor matching contributions of \$1,962,883 for the year ended December 31, 2024. The Plan Sponsor may also provide a discretionary profit-sharing contribution, which is determined by the Board of Directors of the Company and is allocated to participants who are employed by the Company on the last day of the Plan year. There were no discretionary profit-sharing contributions made in 2024.

Investment Elections

The participant may choose from several combinations of registered investment companies, common collective trusts, and pooled separate accounts offered by Principal Trust Company, Principal Global Investors Trust Company, and Principal Life Insurance Company (the Custodians) as selected by the Plan Administrator. Upon enrollment in the Plan, participants may individually direct their investments. The Target Date Funds (based on estimated participant retirement date) are currently the Plan's designated default fund for those participants who have not selected an investment option otherwise. Employees have the opportunity to change their investments daily.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's matching contribution, (b) the Company's discretionary profit-sharing contribution, and (c) Plan earnings (losses) and expenses. Allocations are based on participant wages or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 and up to a maximum equal to the lesser of \$50,000 or 50% of the present value of the participant's vested account balance. The loans are secured by the balance of the participant's account and bear interest at a rate of prime plus 1%, which is commensurate with local prevailing rates. At December 31, 2024, the outstanding loans bear interest rates ranging from 5.25% to 10.50%. Principal and interest are paid ratably through semi-monthly payroll deductions.

Vesting

Participants are immediately vested in their voluntary, discretionary, qualified nonelective and rollover contributions plus actual earnings thereon. Participants are 100% vested in matching contributions after two years of service.

Forfeitures

At December 31, 2024, there were \$13,052 forfeited nonvested accounts (\$24,026 at December 31, 2023). During 2024, forfeitures of \$22,674 were used to reduce employer contributions.

Payment of Benefits

Upon termination of service due to termination of employment, disability, retirement, or death, a participant will receive a lump sum payment or may elect to receive equal monthly, quarterly, or annual installments over a period not to exceed the reasonable life expectancy of the participant or death beneficiary. The Plan may also make hardship distributions to participants in certain situations subject to defined limitations. The Plan will make mandatory distributions for terminated participants with balances of less than \$5,000. Account balances for terminated participants of less than \$1,000 are automatically distributed in a lump sum; otherwise, mandatory distributions will be subject to automatic rollover.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and the third-party administrator.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to distributions and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments. Investment advisor and recordkeeping fees are charged to participant accounts based on the balance of the account as a percentage of the total plan balance.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events have been evaluated through October 30, 2025, the date the financial statements were available to be issued.

Note 3 - Information Certified by the Custodians

The Plan's investments are held by Principal Trust Company, Principal Global Investors Trust Company, and Principal Life Insurance Company, the Custodians of the Plan. Investment decisions are made at the direction of the participants. The investments are credited for earnings thereon and charged for withdrawals and expenses as charged by the Custodians. The Plan Administrator has obtained a certification from the Custodians as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the following information provided to the Plan Administrator by the Custodians is complete and accurate:

Note 4 - Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability; 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts (CCT): CCTs invest in a variety of guaranteed investment contracts, domestic stocks, international stocks, mutual funds, bonds, and other securities. The majority of the underlying securities have observable level 1 quoted pricing inputs. While the underlying asset values are generally based on publicly quoted prices, the NAV of each individual CCT is not valued using publicly quoted prices.

The Plan has an investment in the Morley Stable Value Fund, which is a CCT fund that invests in conventional, synthetic, and separate account investment contracts issued by life insurance companies, banks, and other financial institutions. Characteristics of these contracts allow for their principal value to remain stable regardless of the volatility of the financial markets. The contracts are nontransferable but provide for benefit responsive withdrawals and participant transfers to noncompeting options by Plan participants at contract value. Contract value represents invested principal and accrued interest thereon. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Pooled Separate Accounts (PSA): PSAs invest in a variety of domestic stock, international stocks, mutual funds, bonds, and other securities. The majority of the underlying securities have observable level 1 quoted pricing inputs. While the underlying asset values are generally based on publicly quoted prices, the NAV of each PSA is not valued using publicly quoted prices. The NAV provided by the Custodians is used as the practical expedient to estimate fair value. PSAs can be redeemed on a daily basis and each PSA has its own investment strategy. Participants should refer to each PSAs prospectus for a description of the PSA and its investment strategy.

Note 5 - Tax Status

The Internal Revenue Service (IRS) has determined by an opinion letter dated June 30, 2020, that the Non-Standardized Profit Sharing Plan with CODA sponsored by Principal Life Insurance Company, which has been adopted by the Plan, is acceptable pursuant to section 401 of the IRC and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements at December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their employer contributions.

Note 7 - Party-in-Interest Transactions

Principal Life Insurance Company provides third-party administration and custodian services to the Plan, and TGP Financial Advisors, LLC provides investment advisory services to the Plan. Transactions with these entities qualify as party-in-interest transactions and are exempt from the prohibited transaction rules under ERISA.
