## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Columbus Community Hospital 401(k) Savings Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for plan benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institute or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from ADP Retirement Trust Services ("ADP Retirement") as of December 31, 2024 and for the period from February 17, 2024 to December 31, 2024, and Empower Retirement as of December 31, 2023 and for the period from January 1, 2024 to February 16, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the accompanying 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. **NOTE 1 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation:** The accounting records of the Columbus Community Hospital 401(k) Savings Trust (the “Plan”) were prepared on the accrual basis of accounting.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by Columbus Community Hospital (the “Sponsor”). Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Investment Valuation and Income Recognition:** Investments are reported at fair value (except for the fully benefit-responsive investment stable value account, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements and Note 7 and 8 for discussion of the contract value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Use of Estimates:** The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

**Payment of Benefits:** Benefits are recorded by the Plan when paid.

**Notes Receivable from Participants:** Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on a cash basis. Related fees are charged directly to the borrowing participants accounts. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**NOTE 2 - DESCRIPTION OF THE PLAN**

The following description of the Columbus Community Hospital 401(k) Savings Trust provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**NOTE 2 - DESCRIPTION OF THE PLAN (CONTINUED)**

**General:** The Plan is a defined contribution plan covering all eligible employees of the Sponsor. Eligible participants are at least 18 years of age and have completed 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective January 1, 2008, the Plan was restated into a Safe Harbor 401(K) Plan, thus allowing the Plan to meet certain provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001 ("EGTRRA"). Effective May 1, 2021, the Plan was restated to complete the Cycle 3 restatement as required by Internal Revenue Service (IRS) rules. Because there were no substantial legislative reforms impacting retirement plans enacted between the completion of the last restatement cycle and when the IRS began reviewing the new plan language, this restatement is simply referred to as the third restatement cycle.

Effective February 1, 2024, the Plan was restated to change the Plan name from Columbus Community Hospital 401(k) Savings Plan to Columbus Community Hospital 401(k) Savings Trust. Additionally, during the February 2024 amendment, Pentegra Services Inc was added as Plan Administrator and eligible participants are only required to have completed 60 days of service rather than 90 days of service. Effective August 1, 2024, the Plan was amended to include Roth Elective Deferrals as an allowable contribution type. Additionally, the Plan now includes a traditional Automatic Contribution Arrangement that was implemented prospectively, with an automatic deferral rate of 1% of compensation for each payroll period, with no automatic escalation featured.

**Acquisition:** On December 31, 2020, Empower Retirement acquired the retirement business of Massachusetts Mutual Life Insurance Company ("MassMutual"). Following an initial transition period, Empower Retirement became the sole administrator of this business in 2021. If the Plan utilizes an insurance product and the contract was issued by either MassMutual or by Talcott Resolution Life Insurance Company ("Talcott", formerly named Hartford Life Insurance Company) and administered by MassMutual. Effective April 23, 2022, the Plan fully transitioned from MassMutual recordkeeping system to Empower recordkeeping system.

**Change in Trustee:** In February 2024, the Plan Sponsor changed Trustees from Empower Retirement to ADP Retirement Trust Services. The change in Trustees did not alter the Plan Sponsor's reporting status. See Note 3 for discussion of certification from a qualified institution.

**Employers' Cash Contributions:** In order to maintain the Safe Harbor Plan status, the Plan Sponsor is required to make a safe harbor matching contribution equal to 100% of the participant's salary deferrals that do not exceed 3% of the participant's compensation plus 50% of the participant's salary deferrals between 3% and 5% of the participant's compensation. The safe harbor contribution is fully vested and is referred to as a Basic Matching Contribution. Additional amounts may be contributed at the discretion of the Sponsor's Board of Directors and are allocated to qualified participants as defined by the Plan. The Sponsor is not obligated to make future contributions to the Plan and has no control over the Plan assets other than through its ability to appoint administrators of the Plan.

**Employers' Cash Contributions (Continued):** For 2024 and 2023, the Plan Sponsor remitted contributions of \$379,821 and \$332,431, respectively, of which \$17,841 and \$13,624, respectively, are recorded in the employer contribution receivable on the statement of net assets available for plan benefits.

**Participants' Cash Contributions:** Active participants may contribute up to the maximum dollar amount as set forth by the Internal Revenue Code ("IRC"). The maximum amount a participant can contribute on a before-tax basis during the participant's taxable year is \$23,000 and \$22,500 during 2024 and 2023, in accordance with IRC Section 402(g)(3). For 2024 and 2023, the participants remitted contributions of \$612,857 and \$537,666, respectively, of which \$29,529 and \$21,763, respectively, are recorded in the participant contribution receivable on the statements of net assets available for plan benefits.

**Participant Rollovers:** Participants are allowed to rollover contributions into the Plan from other qualified plans.

**Catch-up Contributions:** All employees that are eligible to make elective deferrals under the Plan and who have attained the age of 50 before the close of the plan year are eligible to make catch-up contributions in accordance with, and subject to the limitations of IRC Section 414(v). The maximum catch-up contribution that a participant could defer during the Plan's year ended December 31, 2024 and 2023 was \$7,500 and \$7,500, respectively.

**Participant Accounts:** Each participant's account is credited with the participant's contribution and Sponsor matching contributions, as well as allocations of the Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits:** On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or receive monthly, quarterly or annual installments over a period of no more than your assumed life expectancy but must begin withdrawing funds from his or her account upon attaining age 70 and one-half. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution

**Forfeitures:** Forfeitures of terminated participants' nonvested employer contribution accounts are first to be applied to the payment of the Plan's administrative expenses and any excess available to be allocated to the employer contribution accounts of the remaining participants to reduce employer contribution on a per payroll period basis and on an annual basis. At December 31, 2024 and 2023, there was \$2,724 and \$2,688 in forfeited nonvested accounts, respectively.

**Vesting of Benefits:** Participants are immediately vested in their own contributions and rollover contributions, plus actual earning thereon. Employer nonelective contributions and matching contributions vest to participants in accordance with the following schedule:

2 Years, but less than 3	20%

**Notes Receivable from Participants:** Participants are able to borrow from their account balances with interest charged at a rate equal to the “prime rate” plus 1%, which remains in effect for the duration of the loan. Loan terms range from a minimum of 1 month and a maximum of 60 months for a non-residential loan and a minimum of 1 month and a maximum of 360 months for a residential loan. The minimum loan is \$1,000 and the maximum loan is the lesser of 50% of the account value or \$50,000. The loans are secured by the participant’s account balance less any current outstanding loan balance. Principal and interest are paid ratably through payroll deductions. Participants may have two loans outstanding from the Plan; however, that only one can be a residential loan. As of December 31, 2024 and 2023, the plan had notes receivable from participants of \$206,564 and \$183,988, respectively. The plan recognized \$1,327 and \$28,058 in deemed distributions related to defaulted loans for the year ending December 31, 2024 and 2023, respectively. These amounts are included in Benefits Paid to Participants on the statements of changes in net assets available for plan benefits.

**Hardship Distributions:** The Plan provides for participant withdrawals in the event of financial hardship. Financial hardships include the participant’s purchase, certain repairs of damage to principal residence, and educational, medical, burial or funeral expenses. Hardship withdrawals must be approved by the Sponsor. Hardship withdrawals may only be made from account funds which are 100% vested plus earnings. Participants must also be employed with the Sponsor at the time of the hardship distribution.

**NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN/TRUSTEE**

**NOTE 4 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Plan’s investments are shares of mutual funds managed by ADP Retirement Trust Services (“ADP Retirement”). ADP Retirement is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additionally, Pentegra Services Inc. is the Contract Plan Administrator as defined by the Plan and are considered a party-in-interest. Edward D Jones & Co. also received indirect payments from the plan and are considered a party-in-interest. Fees incurred by the plan for the investment management services are included in net appreciation (depreciation) in fair value of the investments as they are paid through revenue sharing rather than a direct payment. The plan made direct payments to Custodian of \$30,338 and \$2,444 for the years ending December 31, 2024 and 2023, respectively, which was not covered by revenue sharing. The Plan sponsor pays directly other fees related to the plan’s operations. See Note 2 to the financial statements for more information on the change in Trustee.

**NOTE 5 – TAX STATUS**

The IRS has determined and informed the Sponsor by a letter dated October 06, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted by the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 6 – FAIR VALUE MEASUREMENTS (CONTINUED)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

**NOTE 7 – GUARANTEED INVESTMENT CONTRACT WITH TALCOTT RESOLUTION LIFE INSURANCE COMPANY.**

In 2009, the Plan entered into a fully benefit-responsive guaranteed investment contract with Talcott Resolution Life Insurance Company. Talcott maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. See Note 2 to the financial statements for more information on the acquisition.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

The guaranteed investment contract is presented at contract value on the face of the statements of net assets available for benefits. Contract value, as reported to the plan by Empower, the prior Trustee, represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

RESOLUTION LIFE INSURANCE COMPANY (CONTINUED)**

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023 was \$-0- and \$869,578, respectively. The credited interest rate is based on a formula agreed upon with the issuer, but it may not be less than 4 percent. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include 1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), 2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions, 3) bankruptcy of the Plan sponsor or other Plan sponsor events that significantly affect the Plan's normal operations, 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or 5) premature termination of the contract. The Plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include 1) an uncured violation of the Plan's investment guidelines, 2) a breach of material obligation under the contract, 3) a material misrepresentation, and 4) a material amendment to the agreement without the consent of the issuer.

During February 2024 the guaranteed investment contract with Talcott Resolution Life Insurance Company ended as a result of the Plan changes trustees. See Note 2 to the financial statements for more information on the change in Trustee.

**NOTE 8 – STABLE VALUE ACCOUNT**

The Plan invested in a Lincoln Stable Value Separate Account, a fully benefit-responsive investment offered by ADP Retirement. The Lincoln Stable Value Separate Account invests in a broadly diversified portfolio of predominantly fixed income instruments with insulation from insurance company obligations through a separate account structure. The primary objective is to maximize investment income while maintaining preservation of capital. Interest credited to balances in the product will reflect both current market conditions and performance of the fund's underlying investments.

Because the Stable Value Account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Stable Value Account. The contract value of the Stable Value Account at December 31, 2024 and 2023 was \$858,833 and \$-0-, respectively.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant's account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 – TERMINATION OF PLAN**

Although it has not presently expressed any intent to do so, the Sponsor has the right under the Plan Agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, terminated participants will become 100% vested in their employer matching and profit sharing contributions accounts. Upon such termination of the Plan, after payment of all expenses and proportionate adjustments of accounts to reflect such expenses and fund losses or profits, each participant shall be entitled to receive any amounts then credited to the participant's account in the Plan. The participants' respective interests as they exist at the time shall be deemed fully vested. The Custodian of the Plan may make payments of such amounts in cash or in assets of the Plan or in the form of immediate or deferred annuities as the Plan Administrator shall in his sole discretion direct.
