I am closing my business effective immediately. Our client of over ten years had to close suddenly and we can no longer continue. In addition, I am taking care of my sister with special needs who also has pancreatic cancer.

I was unaware that the Form 5500 was not filed for 2024. I only discovered this when I called to terminate my 401k plan with ADP. My former payroll company filed these on my behalf and I assumed the same was true with ADP.

The last few years have been extremely difficult for me personally and my for my business. My mother passed away in 2023 and I took over the care of my adult sister with special needs. I became her conservator later that year. My sister was diagnosed with pancreatic cancer earlier this year and had major surgery a month ago. I am her primary care giver. In addition to this our other sister passed away last year and I assisted in closing out her estate. With everything going on in my personal life I just had no idea that this form was not filed for me in a timely manner. I am sincerely sorry for my oversight.

Please consider waiving the penalty. I would greatly appreciate it.
