Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Pharma Tech Industries 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Plan Description

The following description of the Pharma Tech Industries 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) Plan established effective January 1, 2006 by Broadview Investments, LLC (the "Company," "Sponsor," or "Employer"), to provide retirement benefits to employees who have attained three months of service and excludes leased employees and employees covered by a collective bargaining agreement. There is no minimum age requirement for participation. Eligible employees may enter the Plan on the first day of the month following completion of the service requirement.

The Plan is administered by the Company's Investment Committee and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective February 16, 2024, Lincoln Financial Group Trust Company, Inc. ("Lincoln Financial") became both the Plan's recordkeeper and custodian. Prior to this transition, Empower Annuity Insurance Company of America and its subsidiaries ("Empower") served as the Plan's custodian and recordkeeper. Lincoln Financial and Empower are considered "Qualified Institutions" under ERISA Section 103(a)(3)(C).

Contributions

Each year participants may contribute up to the maximum allowed by law, as defined in the Plan document, subject to Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts.

The Company contributes a discretionary matching contribution not to exceed 50% of a participant's salary deferrals up to 5% of compensation for all eligible participants. The Company may also contribute an additional discretionary profit-sharing contribution based on participant compensation in excess of the taxable wage base. The taxable wage base is subject to IRC determinations each year. During 2024, there was no discretionary profit-sharing contribution. Both contributions are included in the Employer contributions, in the statement of changes in net assets available for benefits. Contributions are subject to certain limitations.

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers pooled separate accounts and a guaranteed investment contract ("GIC") as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and plan earnings (losses), and charged with benefit payments, transaction fees related to distributions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always fully vested in their own salary deferrals and rollover contributions. Effective February 16, 2024, the Plan was amended to provide immediate 100% vesting in all matching contributions and employer contributions, regardless of the participant's length of service or employment status. This change applies to both current and prior contributions, meaning that any unvested balances under the previous graded vesting schedule are now fully vested.

This amendment supersedes the prior vesting schedule, which applied a six-year graded vesting formula to employer and matching contributions. The Plan no longer applies a vesting schedule to these contribution types, and participants now have full ownership rights to all such amounts once contributed to the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding balance of loans from the Plan to the participant during the one-year period ending on the day before the date of the loans or 50% of their vested account balance immediately preceding the date the loan is issued. The maximum term of repayment for a loan is five years, except if the loan is for purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at one percentage point higher than prevailing Prime interest rates at the time of origination. At December 31, 2024, outstanding loans bore interest rates ranging from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of employment, death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's account in either a lump-sum amount or partial withdrawal. Hardship distributions are permitted upon demonstration of financial hardship. Additional distribution options may apply under specific circumstances, including early retirement and qualified military service.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$130,000 and \$125,000, respectively. These accounts will be used to pay Plan expenses or reduce future Company contributions. During 2024, forfeitures of approximately \$8,000 were used to reduce plan expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan Document.

Payment of Benefits

Benefits are recorded upon distribution.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan Document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (distributions) are charged directly to the participant's account.

Note 3. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1:** Observable inputs such as quoted prices in active markets.
- Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan’s assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts

The Plan invests in pooled separate accounts for which quoted prices are not available in active markets for identical instruments. These investments are measured using the net asset value (NAV) per share (or its equivalent) as a practical expedient for fair value. The NAV is based on the fair value of the underlying assets held by each fund, less its liabilities, and is calculated by the investment manager. These investments are not categorized within the fair value hierarchy but are disclosed separately.

The pooled separate accounts are not required to be classified within a level of the fair value hierarchy.

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 4. Fully Benefit-Responsive Guaranteed Interest Account

As of December 31, 2023, the Plan held investments in a fully benefit-responsive investment contract (“GIC”) administered by Empower, with Massachusetts Mutual Life Insurance Company (“MassMutual) as the contract issuer. The contract met the criteria for fully benefit-responsive investment contracts and was reported at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. At December 31, 2023, the contract value of the Empower (MassMutual) GIC was \$2,200,903.

During 2024, following a change in recordkeeper and custodian, the Plan added investments in the Lincoln Financial Stable Value Fund and a MassMutual Fixed Account under a new contract. At December 31, 2024, the Plan held investments in the Lincoln Financial Stable Value Fund with a contract value of \$1,177,863 and the MassMutual Fixed Account with a contract value of \$299,239. Both contracts meet the criteria for fully benefit-responsive investment contracts and are reported at contract value.

These investment contracts held by the Plan are guaranteed investment contracts. The contract issuers are contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers, but it may not be less than 1%. Such interest rates are reviewed on a periodic basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, or (4) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation or (4) a material amendment to the agreements without the consent of the issuer.

Note 5. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules are complete and accurate:

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 6. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, and employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are funds managed by the custodians, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. The Company directly pays any other fees related to the Plan's operations.

The Plan paid approximately \$7,000 in recordkeeping fees to Empower, approximately \$21,000 in contract administrator fees to Lincoln National Corporation and Ascensus, and approximately \$19,000 in investment advisory and management fees to Merrill Lynch Pierce Fenner & Smith during the year ended December 31, 2024. These entities are considered parties-in-interest due to their roles in providing services to the Plan.

The Company provides certain administrative services at no cost to the Plan.

Note 7. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$5,349 and \$308 were not remitted within the required time period for the years ended December 31, 2024 and 2023.

Note 8. Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service ("IRS") stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020, that the prototype plan document was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the determination letter, the Plan Administrator believes that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC, and; believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 10. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.

Note 11. Subsequent Events

The Plan has evaluated subsequent events through December 1, 2025, the date the financial statements were available to be issued.
