Notes to the Financial Statements

Note 1: Description of Plan

The following description of the Health Benefits Plan for the Employees of Watkins Benefits, LLC formerly Watkins, Inc. (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

The Plan includes several companies owned by Watkins Benefits, LLC, ("the Employer") and covers all full-time employees and their dependents, if so desired, of these companies. Employees are eligible to participate in the Plan upon meeting the waiting period (not to exceed 90 days) requirements established by the Employer.

Contributions

The rates of contributions vary depending on the specific plan selected by the employee and the number of persons covered. To the extent permitted by the Plan, as adopted by the employer, the employer may require its employees to pay a portion of such contributions. The employer pays contributions monthly, including any employee contribution required by the employer.

Payment of Benefits

The Plan was established to provide for payment of hospitalization, illness, accident, and dental benefits to the Plan's eligible participants and their eligible dependents, as defined by the Plan.

The Plan purchases reinsurance for individual and aggregate stop losses each year effective January 1. The Plan is fully funded with no maximum limits. The employer purchases stop loss insurance to reimburse the employer for the employer funding of individual claims that exceed the stop loss individual threshold as established by the employer, which is currently \$80,000.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the accompanying financial statements in conformity with GAAP requires management to make certain estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Estimates and assumptions made by management include, but are not limited to, the claims incurred but not reported (IBNR). Actual results could differ from these estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Incurred but not Reported Claims (IBNR)

Plan obligations at December 31st for claims incurred but not reported are estimated through the use of benefit payment history data. Based on this information, an estimate of claims incurred but not reported is calculated. There is a reasonable possibility that a significant change in this estimate could occur in the near term.

Watkins Benefits, LLC is obligated to contribute amounts necessary to pay for the benefits of the Plan which may ultimately exceed the estimate.

Note 3: Cash and Cash Equivalents

Allegiance Benefit Plan Management, Inc. (Allegiance) maintains a checking account for several medical trusts for which Allegiance provides services. The account's interest is allocated to the various trusts based upon their average cash balance each month. Cash consisted of \$928,495 and \$966,515 as of December 31, 2024 and 2023, respectively.

The Plan maintains cash balances at a financial institution located in Missoula, Montana. Accounts at the institution are insured by the Federal Deposit Insurance Corporation up to \$250,000.

Note 4: Benefit Obligations

Claims payable represents participant claims for benefit coverage provided by the Plan but were unpaid as of December 31. The Plan had claims payable of \$35,603 and \$159,768 as of December 31, 2024 and 2023, respectively, and IBNR of \$338,284 and \$126,025 as of December 31, 2024 and 2023, respectively.

Note 5: Administrative Expenses

The Plan pays administrative fees to the third-party administrator for claims processing based on the number of employees participating in the Plan.

Note 6: Tax Status

The trust established under the Plan is an IRC Section 419(a) trust, and accordingly, the Plan's investment income is exempt from income taxes. No determination letter from the Internal Revenue Service has been requested for the Plan. The determination of tax exempt status is considered to be a tax position. The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions and other evidence. It is the opinion of the Plan Administrator that the Plan has no uncertain tax positions. The Plan is generally subject to examinations by federal tax authorities for the three previous years.

Note 7: Related-Party Transactions and Party-in-Interest Transactions

Fees paid by the Plan to parties-in-interest for the processing and administration of the claims activity for the years ended December 31, 2024 and 2023 totaled \$36,730 and \$87,125, respectively. Fees paid by the Plan to parties-in-interest for the stop loss premiums for the years ended December 31, 2024 and 2023 totaled \$920,433 and \$659,196, respectively.

Additionally, certain employees and some members of management and the Board of Trustees are also participants in the Plan who receive benefits in the same manner as all other participants.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations.
