Basis for Opinion on the 2024 Financial Statements

NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. Description of plan

The following description of the **Hoffman Supply Company, Inc. 401k Plan** (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution safe harbor non-elective profit-sharing plan covering all eligible employees of Hoffman Supply Company, Inc. (the Company) age 21 or older and who have completed 1 year of eligible service with 1,000 hours of eligible service required in each year to make elective deferral contributions within the Plan. Employees not eligible to participate in the Plan are those classified as union employees, non-resident aliens, or leased employees. Eligible participants can enter the Plan April 1st or October 1st following the satisfaction of the eligibility requirements. Effective January 1, 2024, the Plan was amended and restated in order to allow for eligible participants to enter the Plan January 1st, April 1st, July 1st, and October 1st following the satisfaction of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and originally began January 1, 1984.

Contributions

Participants may contribute a percentage or dollar amount of their eligible compensation as defined by the Plan. Participants who have reached age 50 before the end of the Plan year are eligible to make "catch-up" contributions. Employee contributions, including "catch-up" contributions, are subject to certain limitations as limited by IRS regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participating employees must complete one year of service and be employed on the last day of the Plan year in order to be eligible for employer contributions. To complete a year of service the participant must have worked 1,000 hours of service during an eligibility period. An eligibility period is the twelve-month period beginning on the date of hire. The Plan allows for safe harbor non-elective matching contributions which are made by the Company in the amount of three percent of a participant's eligible compensation. As of December 31, 2024 and 2023, the safe harbor non-elective matching contributions made to the Plan were \$310,360 and \$279,823, respectively. The Plan also allows for a discretionary profit-sharing contribution which is determined by management and allocated based upon a percentage of eligible compensation and the employee classification group. As of December 31, 2024 and 2023, the discretionary profit-sharing contribution made to the Plan was \$339,192 and \$294,595, respectively.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution (b) the Company's profit-sharing contribution, if any, (c) earnings or losses, and (d) charged allocation of administrative expenses. Allocations are based

on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their individual contributions, plus actual earnings thereon. Participants are also immediately vested in the employer safe harbor non-elective matching contribution. Vesting in the Company's employer discretionary profit-sharing contribution is based on years of continuous service. A participant is 100 percent vested in the Company match and discretionary contribution after six full years of credited service.

Payments of benefits

Distributions are generally made in the event of retirement, death, disability, resignation, or dismissal. Vested account balances can be distributed by transferring the balance to a different trustee (i.e., rollover) or lump-sum distribution. Vested account balances that do not exceed \$5,000 are subject to automatic distribution without participants' consent and are rolled over into an IRA account if the participant is under the age of 65, and if the participant does not elect another option available. If the participant's vested account is \$1,000 or less, then the account will automatically be paid out as a single lump sum.

The Plan allows participants to make financial hardship withdrawals for all or part of their vested account, including earnings on elective deferral contributions, for immediate and severe financial need. A participant may also take an in-service withdrawal of all or a portion of their vested account balance after reaching age 59 ½. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time.

Forfeited accounts

A non-vested amount remaining in a participant account of a terminated employee after the earlier of (a) distribution of his or her vested account balance or (b) five consecutive one-year breaks in service is defined as a forfeiture. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,652 and \$20,152, respectively. These accounts will be used to reduce or add to future employer contributions. In 2024 and 2023, employer contributions were reduced by \$8,440 and \$5,659, respectively, from forfeited non-vested accounts.

2. Summary of significant accounting policies

This summary of significant accounting policies is presented to assist in understanding the Plan Administrator's financial statements. The financial statements and notes are representations of the Plan Administrator's management, which is responsible for their integrity and objectivity. In preparing financial statements, the Plan Administrator makes estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Basis of accounting

The Plan's financial statements are presented on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefit payments to participants are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through November 19, 2025, the date the financial statements were available to be issued.

3. Fair value measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Observable inputs other than Level 1 process, such as quoted prices for similar assets or liabilities; quoted prices for identical or similar assets in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability’s fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage - consists of shares of money market funds and registered investment company funds that are valued at closing price reported on the active market on which the individual securities are traded.

4. Summary of certified information

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from Ascensus, LLC for the year ended December 31, 2024, and from Newport Trust Company, LLC for the year ended December 31, 2023, that all investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Plan's custodian.

5. Plan termination and transfer of assets

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

6. Tax status

The Plan was designed under a volume submitter prototype non-standardized profit-sharing plan accepted by the Internal Revenue Service by a letter dated June 30, 2020, in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, and the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

7. Related-party transactions and party-in-interest transactions

The Plan assets were held and managed by the custodians who invest cash received, interest, and dividend income as direct by participants of the Plan. Fees paid by the Plan for investment management services are included in the financial statements and showing within administrative expenses noted herein. Certain administrative functions are performed by officers and employees of the Company for which the officers or employees receive no compensation from the Plan nor is the Plan charged by the Company for these services. These transactions qualify as party-in-interest transactions under ERISA, which are exempt from the prohibited transaction rules.

8. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
