Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of Rodeo Dental and Orthodontics 401(k) Plan (the "Plan") provides only general information. Plan participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was organized effective October 1, 2020, as a defined contribution retirement savings plan covering all eligible employees of ROX Access Network, the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contributions and the Plan Sponsor's contributions, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses of the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Contributions

Each year, participants may contribute to the Plan on a pretax basis up to the maximum percentage allowable, subject to certain Internal Revenue Code ("IRC") limitations. The participating employer may contribute a discretionary percentage of the amount deferred by the employees. The employer may also contribute a discretionary amount determined each year by the participating employer. As of December 31, 2024, the Plan's contributions receivable totaled \$0. Contributions are accumulated and invested, as directed by the participants, and held in trust by the trustee.

Profit-sharing contributions may be made at the option of the Plan Sponsor's board of directors at the end of each Plan year and allocated to participants' accounts based on criteria established in the Plan document.

Participants direct the investment of their contributions, as well as those made by the Plan Sponsor, into various investment options offered by the Plan.

Vesting

Participants are vested immediately in their contributions and actual earnings thereon. Vesting in the Plan Sponsor's discretionary profit-sharing contribution portion of their account is based on years of service. A participant is 20% vested after two years of credited service, 40% vested after three years of service, 60% vested after four years of service, 80% vested after five years of service, and 100% vested after six years of service. Non-vested balances of employees who terminate are forfeited and may be used to reduce future employer matching contributions or Plan expenses at the end of the Plan year.

Forfeitures

Forfeitures from non-vested accounts may be used to reduce matching or non-elective employer contributions or Plan expenses. For the year ended December 31, 2024, no forfeited accounts were used to reduce employer contributions or pay plan expenses. As of December 31, 2024, forfeited non-vested accounts totaled \$0.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts in various mutual funds and one stable value fund from registered investment companies as investment options for plan participants.

Hardship Withdrawals

Participants may withdraw from the Plan part or all of the participant's contributions in the event of undue financial hardship. The maximum hardship withdrawal is the total of a participant's 100% vested balance. The Trustees shall determine what portion of such account balance is necessary to alleviate the hardship. A financial hardship must be one of the reasons specified below:

1. Medical expense incurred by the participant, the participant's spouse, or any dependents of the participant;
2. The purchase (excluding mortgage payments) of a principal residence of a participant;
3. Certain educational expenses for the participant, his or her spouse, or dependents of the participant;
4. The need to prevent the eviction of the participant from his or her principal residence or foreclosure on the mortgage of his or her principal residence; or

5. Other events as may be prescribed by the Internal Revenue Service Commissioner in revenue rulings, notices, and other documents of general applicability.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may, upon advance notice, direct the plan fiduciary to withdraw any contract account to pay plan benefits as allowed for or required under the Plan. Withdrawals are paid as directed by the participant, as applicable, in a single sum or mutually agreeable option within 30 days of receipt of Advance Notice.

Notes Receivable from Participants

Subject to limitations, a participant may borrow from the vested portion of his or her elective account. The minimum amount of any loan is \$1,000 and the maximum amount is the lesser of 50% of a participant's vested amount or \$50,000. A participant may only have one loan outstanding at any given time and a loan may be refinanced. The loan is secured by the participant's vested interest in his or her account. The interest rate on a loan is determined at the time of the loan as prime plus 1% and will be constant through the loan. Principal and interest are paid ratably through payroll deductions. All loans are required to be repaid within 5 years, except loans to acquire the participant's principal residence which may not exceed 360 months.

Accounting principles generally accepted in the United States require management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in process. The Plan is subject to income tax examinations for the prior three plan years.

Plan Expenses

Administrative expenses for maintaining the Plan may be paid by the Plan Sponsor or the Plan, at the Plan Sponsor's discretion. Loan administration fees are charged directly to the participant's account and are included in administrative expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the Plan's financial statement in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the date of the financial statements and the changes in net assets available for plan benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principle balance plus any accrued but unpaid interest. Notes receivable from participants are deemed to be in default if a scheduled installment payment has not been received within 90 days of the date it was due. Defaulted participant loans are reclassified as distributions based upon the terms of the plan document. On a periodic basis, the Plan sponsor evaluates notes receivable from participants and, if necessary, establishes an allowance for doubtful accounts. As of December 31, 2024, the Plan sponsor estimates the allowance for credit losses to be \$0.

Investment Valuation and Income Recognition

Participants have the right to direct employer and employee contributions to any of the investment options offered by the Plan. The investment options are with registered investment companies and include a stable value fund and various stock and bond funds. The fund values are computed daily by the custodians and reflect changes in the unit values of the investments. Participant loans are valued at their outstanding balances, which approximate fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on an accrual basis and dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefit payments to participants are recorded when paid.

NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024. Accordingly, Principal Life Insurance Company, the trustee of the Plan, has certified the completeness and accuracy of all investments reported in the accompanying Statement of Net Assets Available for Benefits as of December 31,

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan has categorized its assets and liabilities that are measured at fair value into a three-level fair value hierarchy. The hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation

techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

Mutual funds: Valued at market value of shares held by the Plan at year end.

Common collective trust: The Plan has a stable value fund that is a common collective investment trust. The fund is a fully benefit-responsive investment contract that allows participant-directed withdrawals and transfers at contract value. The contract value is based on the net asset value of the underlying investments held by the fund less its liabilities. In accordance with ASC 820-10-35, the common collective trust funds measured at contract value have not been classified in the fair value hierarchy. The fair value amounts presented in the table below are intended to permit reconciliation to the amounts presented in the statements of net assets available for benefits.

Pooled separate accounts: Presented at net asset value based on number of units held in the pooled accounts multiplied by unit values. The unit values of the pooled separate accounts are based on significant observable inputs that are based upon quoted market prices in an active market and are therefore considered Level 2 investments within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a summary, by major nature and risks class within each level of the fair value hierarchy, of the Plan's investment assets that are measured at fair value on a recurring basis as of December 31, 2024:

NOTE 5 - TAX STATUTE

The Plan has adopted a volume submitter plan document whose sponsor has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014, stating that the volume submitter plan document was designed in accordance with the applicable sections of the IRC. Although the Plan and the volume submitter plan document have been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or assets) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The prior three plan years are subject to income tax examinations.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, interest not previously vested will become immediately, completely vested and nonforfeitable.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024, there were transactions involving the investment of plan assets in investment funds maintained by Principal Life Insurance Company, a party-in-interest as defined in Section 3(14) of ERISA.

Onedigital Investment Advisors received fees for investment management services. Fees paid to Onedigital Investment Advisors are reflected in the accompanying statement of changes in net assets available for plan benefits totaled \$17,946 for the year ended December 31, 2024.

Notes receivable from participants are permitted party-in-interest transactions.

Jason F. Clausen, P.C. is the auditing firm for the plan. Fees paid for the audit were paid by the plan sponsor.

NOTE 8 - FIDELITY BOND

The plan sponsor has \$500,000 in fiduciary coverage for all ERISA sponsored plans as of December 31, 2024. The plan is not covered by a fidelity bond.

NOTE 9 - CONCENTRATION OF CREDIT RISK
