INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Alternative Services – Northeast Company Sponsored Pension Plan

Opinion

We have audited the accompanying financial statements of Alternative Services – Northeast Company Sponsored Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of ALTERNATIVE SERVICES - NORTHEAST Company Sponsored Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan document and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is an Internal Revenue Code ("Code") Section 403(b) defined contribution retirement plan covering all employees of Alternative Services - Northeast, Inc. (the "Organization"). All employees, except those that normally work less than 20 hours per week, are immediately eligible to participate in the Plan upon their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to certain Code limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds as investment options.

At the discretion of its Board of Directors, the Organization may also make discretionary nonelective contributions to the Plan. Discretionary nonelective contributions are made to eligible participants who are at least 18 years of age, have completed at least 1,000 hours of service in the 12-month period following their date of hire and are actively employed on the last day of the Plan year. Contributions are subject to certain limitations. There was no discretionary contribution for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, an allocation of the Organization's contributions, Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document.

Administrative charges related to the administration of participant accounts are deducted directly from the respective participant's account. Investment expenses charged by the mutual funds in which the Plan invests are paid directly from the underlying assets of the respective investments and are included in the net appreciation in fair value of mutual funds in the statement of changes in net assets available for benefits. All other charges related to the administration of the Plan are paid by the Organization.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their salary deferral contributions and rollover contributions plus actual earnings thereon. In the event of termination due to death, total and permanent disability, normal or early retirement, participants shall become 100% vested in the Organization contribution portion of their account. For all other participants, vesting in the Organization contribution portion of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

Forfeited Accounts

When a participant is terminated, non-vested employer contributions are forfeited by the participant. Any forfeited non-vested accounts generated during the year will be used to reduce the Organization's administrative expenses or its profit-sharing contribution. The Plan used the available forfeitures to reduce expenses during the year ended December 31, 2024. The forfeiture balance at December 31, 2024 was \$8, which was used to reduce plan expenses after December 31, 2024.

Payment of Benefits

On termination of service due to death, disability, normal or early retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments for a specified term or through the purchase of an annuity contract available under the terms of the Plan. For termination of service for other reasons, a participant may receive the value of his or her account as a lump-sum distribution. Participants with a vested account balance less than \$5,000 will receive a lump-sum distribution as soon as it is administratively practicable immediately following their separation from service with the Organization.

Withdrawals from a participant's salary deferral account balance may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Withdrawals from a participant's rollover account may be made at any time. Additionally, in-service withdrawals are allowed in accordance with the provisions specified in the Plan for participants who have attained age 59 ½.

Hardship Withdrawals

Withdrawals from a participant's vested account balance (exclusive of any earnings on salary deferral contributions) may be made in the event of financial hardship, in accordance with the provisions specified in the Plan. Additionally, in-service withdrawals are allowed in accordance with the provisions specified in the Plan for participants who have attained age 59 ½.

Notes Receivable from Participants

The Organization does not allow participants to borrow from their account balances in the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in the statement of changes in net assets available for benefits the net (depreciation) in fair value of mutual funds, which includes gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The Organization has evaluated events and transactions for potential recognition or disclosure through December 02, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include; quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant the fair value measurement.

The investments fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued using the net asset value of shares held by the Plan at year end (Level 1). Level 1 instrument valuations are obtained from real-time quotes for transactions in active exchange markets involving identical assets.

Money market fund: Valued using significant observable inputs, particularly dealer market prices for comparable investments as of the valuation date (Level 1).

The Plan had no Level 2 or 3 investments at December 31, 2024 or 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Organization contribution portion of their account.

NOTE 5 – TAX STATUS

The Internal Revenue Service (the "IRS") has previously not provided plans established under Section 403(b) with a determination or opinion letter indicating that the Plan is designed in accordance with applicable sections of the Code. The Plan was amended and restated effective January 1, 2018 to comply with current regulations. Although the Plan has never received a determination or opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore believes that the Plan is qualified and tax-exempt as of December 31, 2024.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan had no uncertain tax positions at December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments managed by American Funds, the custodian, are considered exempt party-in-interest transactions. Total fees charged for investment management and other administrative expenses totaled \$2,900 for the year ended December 31, 2024.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – NONEXEMPT TRANSACTIONS

As reported on the supplemental schedule of delinquent participant contributions (Schedule H, Line 4a), certain salary deferrals were not remitted to the Plan for the year ended December 31, 2023, (\$1,000) within the timeframe specified by the Department of Labor's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Organization. The Plan remitted to the Trust on October 21, 2024, approximately \$116 for lost earnings related to this delay.
