**NOTE 1: DESCRIPTION OF THE PLAN**

The following description of the Martin Bauer, Inc. 401(k) Profit Sharing Plan, (the Plan) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan's provisions.

General

The Plan was established on January 1, 2003 by BI Nutraceuticals, Inc. as a defined contribution plan under the provisions of Section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

In 2019 BI Nutraceuticals, Inc. was acquired by MB Capital Investments, LLC, a wholly owned subsidiary of MB Holdings GmbH & Co. KG, Germany ("MB Holdings"). As a result of this acquisition, in July 2020, all the assets and liabilities of BI Nutraceuticals, Inc. were merged with and into Martin Bauer, Inc. (a related-party entity under the common control of MB Capital Investments, LLC ("MCU")). BI Nutraceuticals, Inc. ceased to exist as a separate entity leaving Martin Bauer, Inc. (the "Company," "Employer," or "Plan Sponsor") as the surviving entity. On July 1, 2020, the Plan was amended and renamed the Martin Bauer, Inc. 401(k) Profit Sharing Plan.

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act, related to participant loans and distributions. The Organization has until December 31, 2024, to amend the Plan for changes allowed by the CARES Act. The Plan has not been formally amended to adopt these provisions as of December 31, 2024.

Effective January 1, 2021, the Plan was amended to allow the employees of Core Botanica Processors, LLC to participate in the Plan. Core Botanica Processors, LLC is a related-party entity under the common control of MCU.

Effective August 1, 2021, the Plan was amended to merge the Strong Brews, LLC 401(k) Plan net assets into the Plan. Strong Brews, LLC is a related-party entity under the common control of MCU.

Administration

The Plan is overseen by a committee (the “Investment Committee” or “Plan Administrator”) appointed by the Company. The Plan’s recordkeeper is ADP Retirement Services (“ADP RS” or the “Recordkeeper”). As of December 31, 2024 and 2023, the assets of the Plan were under the custody of Reliance Trust Company (the “Trustee”).

The Trustee and Recordkeeper have the power to administer the Plan and apply all of its provisions on behalf of the Plan Sponsor and the Investment Committee. The Plan Sponsor has the discretion to appoint or remove any trustee or agent of the Plan.

Eligibility

All employees of the Company are eligible to participate in the Plan upon their date of hire, excluding union employees, nonresident aliens, and temporary employees. Effective January 1, 2021 employees of Core Botanica Processors, LLC who meet the eligibility requirements may participate in the Plan. Effective August 1, 2021, employees of Strong Brews, LLC who meet the eligibility requirements may participate in the Plan.

Contributions

Participants may make pre-tax and or Roth 401(k) contributions up to 90% of the eligible compensation subject to IRC limit. However, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute Roll Over contribution, which represents amounts representing distribution from other qualified plans.

The Employer makes safe harbor matching contributions equal to 100% of the participant’s elective deferrals that do not exceed 4% of his/her compensation each pay period. Safe harbor matching contributions are made for all employees who were active participants at any time during the payroll period.

The Employer may also make a discretionary non-elective contribution to the Plan each year. To be eligible for these contributions, participants must be employed on the last day of the Plan year and have completed 1,000 hours of service during the Plan year. If made, such contributions are allocated to eligible participants’ accounts based on each participant’s compensation in proportion to total compensation for all eligible participants. The Employer did not make any discretionary non-elective contributions for the years ended December 31, 2024 or 2023.

All contributions are invested in the participants' accounts according to their specified investment allocations as of the date of the contribution.

Participant Accounts

Each participant's account is credited or charged with his or her contributions and an allocation of Plan earnings or losses. Each participant's account is charged with an allocation of management fees. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefits that can be provided from participant's vested account.

Vesting

Participants are always 100% vested in their elective salary deferrals, catch-up contributions, rollover contributions, safe harbor matching contributions, and any earnings thereon. Participants vest in Employer discretionary non-elective contributions, and any earnings thereon, as follows:

Less than 2 years	0%
2 but less than 3 years	50%
3 or more years	100%

Participants become 100% vested in all their accounts if they are employed with the Company and reach normal retirement age, become totally disabled, upon death or if the Plan terminates.

Forfeitures

Participants who terminate employment forfeit the non-vested portion of their employer discretionary non-elective contributions and earnings thereon. As of December 31, 2024 and 2023 there were no forfeitures. Forfeitures are available to pay Plan administrative expenses or reduce employer contributions. For the years ended December 31, 2024 and 2023, there were no material forfeitures, used to offset the safe harbor matching contributions.

Investment Options

The Plan currently offers diversified investment funds as investment options for participants. The participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their accounts the lesser of a) \$50,000, reduced by the highest outstanding note balance during the prior year, or b) 50% of their vested account balance, subject to a \$500 minimum. Notes are secured by the vested balance in the participant's account. Note payments are made through payroll deductions over periods up to five years, unless the note is used to acquire a principal residence, in which case the term may be extended at the discretion of the Plan Administrator. New notes bear interest at the prime rate plus 1% per annum. Interest rates are fixed at inception of the note. As of December 31, 2021, notes mature through 2031 and bear interest at rates ranging from 4.25% to 6.50% per annum, which is commensurate with local prevailing rates as determined by the Plan Administrator at the time of the note.

Payments of Benefits

Upon termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive an amount equal to the participant's vested account balance in a lump-sum payment, installment payments over the participant's or beneficiary's assumed life expectancy, roll the amount to an individual retirement account or other eligible transferee plan, or delay payment until the required beginning date of minimum distributions, depending on the value of the account. In addition, the Plan permits in-service distributions for participants who are age 59 ½ or older. Distributions paid prior to the participant attaining age 59 ½ and not rolled into another retirement account are subject to federal income tax of 20% and a federal excise tax of 10%.

Vested account balances less than \$5,000, but more than \$1,000 may be distributed as a lump-sum cash payment or in the form of a direct rollover to an individual retirement account or eligible retirement plan at the consent of the participant or beneficiary. Vested account balances of less than \$1,000 are distributed in a single lump-sum cash payment to the participant or beneficiary.

Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the

provisions of ERISA. In the event of Plan termination, participants will become fully vested in the employer contributions.

Administrative Expenses

All reasonable expenses of administration may be paid out of the Plan assets unless paid by the Company. Expenses, to the extent not paid by the Company, are paid by the Plan and allocated to participants based on their account balances. Expenses that relate solely to a specific participant, such as fees for notes receivable or benefit payments, are assessed to the participant. Certain expenses are included in the transaction prices of investments bought and sold and cannot be separately quantified.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain amounts and disclosures. Accordingly actual results could differ from those estimates.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") as set forth by the Financial Accounting Standards Board (the "FASB").

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized depreciation and appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note 3 for discussion on fair value measurements and trustee certification.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2020, no allowance for credit losses has been recorded. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Date of Management's Review

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

Payments of benefits and Corrective distributions

Benefits are recorded when paid.

**NOTE 3: SUMMARY OF UNAUDITED INFORMATION**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. The following information was certified by the Trustee and was not subjected to any auditing procedures performed by the independent public accountant:

- a. Fair value and net realizable value of investment as reflected in the Statements of Net Assets Available for Plan Benefits as of December 31, 2024, and 2023.
- b. Interest and dividends, net realized and unrealized depreciation in fair value of investments, and interest income on notes receivable from participants as reflected in the Statement of Changes in Net Assets Available for Plan Benefits for the Year Ended December 31, 2024.
- c. Investment information reflected in Schedule H, line 4i – Schedule of Assets (Held At End of Year) as of December 31, 2024.

The classification of the investments into the appropriate levels (1, 2, or 3) as disclosed in Note 5 is not certified by the Trustee and is the responsibility of Plan management.

**NOTE 4: INVESTMENTS**

All Plan investments are participant-directed and held by the Trustee as of December 31, 2023 and 2022. Participants can direct their accounts among various mutual funds and a money market fund.

**NOTE 5: FAIR VALUE MEASUREMENTS**

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). All of the Plan's investments were valued at Level One of fair value measurement hierarchy at December 31, 2024 and 2023. Under Level One, imputes to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 1 Fair Value Measurement:* The fair value of Registered Investment companies (mutual funds) is valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. The money market fund and mutual funds are valued at quoted market prices which are available on active markets and, therefore, are classified as Level 1 within the valuation hierarchy. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6: TAX STATUS**

The Plan utilizes an ADP RS Prototype Non-Standardized Profit-Sharing Plan Document which received an opinion letter dated July 16, 2014 in which the IRS stated that as of that date the Plan document was designed in compliance with the applicable IRC requirements. The Plan has been amended since ADP RS received the opinion letter. However, Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, Plan management believes that the Plan is qualified, and the related trust is tax exempt as of December 31, 2024 and 2023 and for the years then ended.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

**NOTE 7: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Some of the Plan's assets are invested in securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies are their markets may be less liquid and their prices more volatile than securities of comparable U.S. companies.

**NOTE 8: SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 14, 2025, the date on which the financial statements were available to be issued. Except as disclosed, there were no other subsequent events that would require adjustments to or disclosure in these financial statements. The effects of the global pandemic COVID-19 in the market have generally been mitigated in U.S. markets, however, the impact of the COVID-19 on foreign markets continues to evolve. The Company is not able at this time to estimate its impact on the Plan's assets in foreign companies.

**NOTE 9: PARTY-IN-INTERST TRANSACTIONS**

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or a relative of such persons mentioned. Additionally, the Plan Sponsor, Core Botanica Processors LLC and Strong Brews LLC are parties-in-interest to the Plan. However, there were no transactions with these entities other than the funding of contributions to the Plan.
