Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of DispatchIT, Inc. 401(k) P/S Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Notes to Financial Statements

1. Plan Description

The following description of DispatchIT, Inc. 401(k) P/S Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by DispatchIT, Inc. (the “Employer”, “Plan Sponsor”, or “Plan Administrator”). Substantially all full-time and part-time employees (aged 21 and older) of the Employer are eligible to participate in the Plan. The Employer controls and manages the operation and administration of the Plan. Ascensus serves as custodian of the Plan’s assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC).

Contributions

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined by the Plan, through elective deferrals up to the maximum allowed by tax law. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participant contributions can be in the form of pre-tax contributions or post-tax Roth contributions for up to 100% of eligible compensation. The Plan allows for participants to transfer contributions into the Plan from another qualified plan or from an individual retirement account.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund.

The Employer’s matching contribution is discretionary and is 50% of the employee contributions up to 6% of their eligible compensation for 2024. The Employer may also, at its sole discretion, make a non-elective contribution to the Plan for all eligible Participants. Non-elective contributions are allocated to the Non-Elective Contribution Account of each Participant eligible in the ratio that each Participant’s Plan Compensation bears to the Plan Compensation of all eligible Participants. There were no such contributions made for the years ended December 31, 2024 or 2023.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

A participant is 100% vested in employee contributions at all times. The participant is 50% vested in the employer match after one year of vesting service, which is a vesting computation period during which the participant completes 1,000 hours of service during the Plan Year. After two years of vesting service the participant is 100% vested.

Distributions

The benefit to which a participant is entitled is the vested balance in their accounts. The payment of benefits shall be made according to the election of the participant in the form of a rollover to another qualified plan or lump sum distribution as prescribed by the Plan.

Distributions of a participant's account can be made upon death, total disability, or retirement. Under certain circumstances, as defined by the Plan, participants may request a hardship or in-service withdrawal from their participant accounts. The Plan allows for automatic distribution of accounts upon termination, so that amounts between \$1,000 and \$5,000 may be automatically distributed into an individual retirement account designated by the Plan Administrator. Vested benefits for terminated participants with account balances that do not exceed \$1,000 are automatically distributed in a lump sum payment. Terminated participants with vested account balances that do not exceed \$5,000 will be distributed, however, the participant may elect to have their benefits paid in cash or rolled over to an individual retirement account or qualified plan.

Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, subject to certain restrictions. Note terms may not exceed 5 years except in the case of a residential loan where the term may be up to 30 years. The notes are secured by the vested balance in the participant's account and bear interest at reasonable rates. Principal and interest are paid ratably through deductions from the participant's payroll for active participants. Upon eligibility for a distribution or if the employee terminates employment, the note generally becomes immediately payable in full.

Forfeitures

If employment with the Company terminates and participants receive a distribution of the entire vested portion of their Account, they forfeit the non-vested portion of their Account. Forfeited funds are applied as a credit to future Plan expenses. A total of \$5,275 and \$5,240 of company match dollars were forfeited in 2024 and 2023, respectively. This total was applied to subsequent Plan expenses.

Plan Expenses

Certain administrative expenses of the Plan are paid directly by the Employer. Investment management fees, participant transaction costs, and certain administrative costs are paid by the participants.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net

assets available for benefits during the reporting period. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are valued at amortized cost which approximates fair value. Amortized cost represents unpaid loan principal plus accrued interest at year end. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

3. Investments, at Fair Value

Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's investments measured at fair value:

Mutual Funds: Valued daily based on quoted prices from national exchanges in an active market.

Money Market Accounts: Valued at the daily closing price as reported by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

5. Party in Interest Transactions

The Plan issues loans to participants which are secured by the vested balance of the participants' accounts. Certain other fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions which are exempt from prohibited transaction rules.

6. Risks and Uncertainties

The Plan offers various investment options to participants that are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant accounts.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

8. Tax Status

The Plan adopted a non-standardized pre-approved profit-sharing plan which received an opinion from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the plan is qualified and the Trust established under the Plan is tax-exempt under the appropriate sections of the Internal Revenue Service Code (the Code). Once qualified, the Plan is required to operate in conformity with the Code to maintain its tax qualification. The Plan has been amended since receiving the determination letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
