We have performed an audit of the financial statements of Cheng Shin Rubber USA, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of February 18, 2025, and the related statement of changes in net assets available for benefits for the period from January 1, 2025 to February 18, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2025 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2025 financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Auditors’ Report on the 2024 Financial Statements

Predecessor auditors performed an audit of the 2024 financial statements of the Plan. Their report dated April 21, 2025 indicated that (a) the amounts and disclosures in the 2024 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2024 supplemental schedule, other than the information in the 2024 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2024 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

1. Description of the Plan

The following brief description of the Cheng Shin Rubber USA, Inc. 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan was a defined contribution plan and was sponsored by Cheng Shin Rubber USA, Inc. (the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan, adopted by the Company effective June 1, 1992, was amended and restated effective February 17, 2022. No significant changes were made to the Plan as a result of this restatement.

Effective February 18, 2025, the Company became a participating employer in The (k)larity Plan, a pooled employer plan. Therefore, all assets, totaling \$21,661,792, were transferred out of the Plan on February 18, 2025.

Eligibility

The Plan allowed employees to participate in the Plan after completing 90 days of service. Enrollment was allowed on the first day of the month subsequent to the above condition being met.

Contributions

Each year, participants may have contributed up to the dollar limitation set forth in Section 402(g) of the Internal Revenue Code (IRC) in effect at the beginning of the Plan year. Participants who had attained age 50, before the close of the Plan year, were allowed to make catch-up contributions up to the maximum allowed by the IRC. Contributions were subject to certain limitations. Newly hired employees who became eligible to participate in the Plan were automatically enrolled at 6% of their compensation, which automatically increased 1% each year up to a maximum of 10%, unless another option was selected by them.

Participants may have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan.

The Company elected to operate the Plan under a safe harbor provision whereby participants in the Plan received a non-elective matching contribution of 100% of the first 6% of compensation contributed to the Plan. The Company could have also chosen to make a discretionary profit-sharing contribution to the Plan. For the period from January 1, 2025 through February 18, 2025, no additional contributions were made.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of the Company's contribution and Plan earnings (losses). Allocations were based on participant compensation, deferrals or account balances, as defined. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account balance.

1. Description of the Plan (cont.)

Notes Receivable from Participants

Participants may have borrowed, from their fund accounts, a minimum of \$1,000, up to a maximum equal to the lesser of \$30,000 or 50% of their vested account balance. Participants may have only borrowed from their elective deferral contributions and rollover contributions in the Plan for any notes receivable issued. Note receivable transactions were treated as a transfer between the investment fund(s) and the participant note receivable fund. The notes receivable from participants were secured by the balance in the participant's account and bore a reasonable rate of interest as defined by the Plan. Principal and interest payments occurred ratably through regular payroll deductions over a period not to exceed five years, unless the notes receivable were used to purchase a primary residence in which case the note receivable terms may have exceeded five years.

Vesting

Participants were immediately vested in their voluntary contributions, all employer contributions, plus actual earnings thereon.

Payment of Benefits

A participant's contributions and employer contributions may have been withdrawn upon retirement (on or after the attainment of normal retirement age or early retirement age with 6 years of vesting service), termination of employment, upon reaching age 59½, disability, or death. Participants may have elected to have distributions paid in annuities or installments. Under certain qualifying circumstances, hardship withdrawals were permitted under the Plan. If a terminated participant's balance was less than or equal to \$5,000, the amount may have been automatically distributed in the form of lump-sums as designated by the Company.

Forfeitures

There were no forfeited non-vested accounts as of February 18, 2025 and December 31, 2024. Forfeitures from non-vested participants' accounts could have been used to reduce future Company matching contributions or to pay for certain administrative expenses. During the period from January 1, 2025 to February 18, 2025, there were no forfeited funds that could have been used to offset contributions or to reduce Plan expenses.

Plan Expenses

Certain administrative expenses of the Plan were paid by the Plan. Certain other administrative expenses of the Plan were paid by the Company. Investment fees were paid by the Plan in the form of reductions of net investment income (loss) earned by Plan participants.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan followed accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

2. Summary of Significant Accounting Policies (cont.)

Use of Estimates

The preparation of financial statements in conformity with GAAP required the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could have differed from those estimates.

Investment Valuation and Income (Loss) Recognition

The investments of the Plan were reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Plan's committee determined the Plan's valuation policies utilizing information provided by the investment advisers and custodian.

Purchases and sales were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Investment income (loss) was recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company were recorded in the year in which the employee contributions were withheld from compensation.

Notes Receivable

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of February 18, 2025 and December 31, 2024. If a participant ceased to make loan repayments and the Plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

3. Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2025 and 2024. Accordingly, Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, (collectively Principal), the Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of February 18, 2025 and December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2025 to February 18, 2025. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

4. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements).

The three levels of the fair value hierarchy under GAAP are described below:

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 18, 2025 and December 31, 2024.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds that were held by the Plan were deemed to be actively traded.

Common Collective Trust Fund - The Principal Stable Value Fund was a common collective trust fund that was valued at NAV as the practical expedient based on the last reported sales price of the underlying investments held. The Plan's interest in the collective trust was based on information reported by the trustee using the audited financial statements of the collective trust at year-end. The investment income (loss) was allocated to participants based on their proportionate share of the net assets of the fund.

Pooled Separate Accounts - Pooled separate accounts were valued at NAV as the practical expedient based on the last reported sales price of the underlying investments held and the number of units held by the Plan at year-end, as of December 31, 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024. The Plan has no investments as of February 18, 2025.

The collective trust fund participated in a stable value fund that invested primarily in benefit-responsive investment contracts issued by insurance companies and other financial institutions (Contracts), fixed income securities, and money market funds. Under the terms of the Contracts, the assets of the fund were invested in fixed income securities (which may have included, but were not limited to, U.S. treasury and agency bonds, corporate bonds, mortgage-backed securities, commercial mortgage-backed securities, asset-backed securities, and collective investment vehicles and shares of investment companies that invested primarily in fixed income securities) and shares of money market funds. The fund may also have invested in futures contracts, option contracts, and swap agreements.

5. Tax Status

The Plan had adopted a Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan) sponsored by Principal Life Insurance Company (PLIC). The Internal Revenue Service (IRS) had opined and informed PLIC by letter dated June 30, 2020, stating that the form of the Pre-Approved Plan document was in compliance with the applicable requirements of the IRC. Although the Plan had been restated since adopting the Pre-Approved Plan document, the Plan administrator believed that the Plan was designed, and was being operated, in compliance with the applicable requirements of the IRC and therefore believed that the Plan was qualified, and the related trust was tax exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their Company contributions.

7. Party-In-Interest Transactions

Certain Plan investments were managed by Principal. These transactions, as defined by the Plan, qualified as party-in-interest transactions. Notes receivable from participants were also defined by ERISA as party-in-interest transactions.

8. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would have occurred in the near term and that such changes could have materially affected participants' account balances, and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

9. SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the period from January 1, 2025 to February 18, 2025. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.
