## INDEPENDENT AUDITOR’S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of San Antonio Masonry and Steel 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets in liquidation available for benefits as of December 31, 2024 and December 31, 2023 (in liquidation), and the related statement of changes in net assets in liquidation available for benefits for the year then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution, John Hancock Life Insurance Company, the Custodian, as of and for the period then ended November 20, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Basis of Accounting**

As further discussed in Note B to the financial statements, on August 13, 2024, the Plan Sponsor notified the Plan participants and the Plan Custodian that liquidation is imminent. As a result, the Plan used the liquidation basis of accounting in presenting the December 31, 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the liquidation basis of accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE A - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting:* The financial statements of the San Antonio Masonry and Steel 401(k) Plan (“Plan”) are prepared on the accrual method of accounting in accordance with U.S. generally accepted accounting principles. San Antonio Masonry and Steel is the Plan Sponsor and John Hancock Life Insurance Company serves as the Custodian. San Antonio Masonry and Steel, the Plan Sponsor, was acquired on August 13, 2024, and the Board of Directors adopted a resolution to terminate the Plan. As a result, the Plan’s financial statements as of December 31, 2024 and December 31, 2023 have been prepared on the liquidation basis. See Note B.

*Recognition of Income:* The basis of investments held by the Plan is adjusted daily to closing market value and unrealized gains and losses are recorded as part of this adjustment. Realized gains and losses on investments are computed using this adjusted basis (beginning of year market value). Security transaction expenses are considered in computing realized gains and losses on investments.

*Investment Valuation:* Investments in pooled separate accounts are carried at fair value (net asset value), as determined by quoted prices in an active market. Dividends are considered in the fair value determination. Gains and losses (realized and unrealized) are included the net appreciation (depreciation) in the fair value of assets in the statement of changes in net assets available for plan benefits.

Investments in unallocated general accounts are valued at contract value, which represents the amount contributed, plus interest at guaranteed rates, less any withdrawals or applicable fees.

*Participants’ Notes Receivable:* Participants’ notes receivable are stated at their unpaid principal balance plus any accrued interest. Interest is recognized as accrued. An allowance was not required at either year end. If a participant ceases to make a loan payment and the Plan Administrator deems the participant loan to be in default, the loan balance is reduced and a benefit payment to the participant is recorded.

*Benefit Payments:* Benefits are recorded when paid.

*Subsequent Events:* Subsequent events have been evaluated by management through the date of the independent auditor’s report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

*Use of Estimates:* The preparation of financial statements in conformity with the liquidation basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

*Reclassification:* Certain reclassifications of amounts previously reported have been made to the accompanying financial statements to maintain consistency between periods presented. The reclassifications had no effect on the previously reported change in net assets available for benefits

**NOTE B – PLAN TERMINATION AND LIQUIDATION BASIS OF ACCOUNTING**

The Plan Sponsor notified John Hancock Life Insurance Company, the Custodian, their intent to terminate the Plan effective August 13, 2024. Compensation earned was cut off as of August 13, 2024 and benefit accruals ceased for all participants as of this date. Plan assets continued to be held on behalf of participants and their beneficiaries until distributed in accordance with the Plan terms. Contributions under the Plan were permanently discontinued. Participants were 100% vested in their accounts. Management determined the liquidation basis of accounting was appropriate as of and for the years ended December 31, 2024 and December 31, 2023.

Accordingly, the Plan's financial statements as of December 31, 2024, have been prepared on the liquidation basis of accounting. The liquidation basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable, and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement accounts. The estimated net realizable value for investments as of December 31, 2024 is fair value.

**NOTE C - DESCRIPTION OF THE PLAN**

The following description of the San Antonio Masonry and Steel 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution plan, established January 1, 2013, covering virtually all employees of San Antonio Masonry and Steel, who complete 6 months of eligible service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated effective January 1, 2022.

*Contributions:* Eligible participants can enter the plan on the first day of the first month and the seventh month of the plan year, participants may elect to contribute pretax compensation, as well as post-tax (Roth) compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor may elect to contribute matching contributions, the amount of which is determined by the Plan Sponsor and allocated based on each participants contribution. Additional profit sharing amounts may be contributed at the option of the Plan Sponsor.

*Participant Accounts:* Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting:* Participants are always 100% vested in their voluntary contributions and any earnings thereon. Vesting in Sponsor matching contributions is based on years of service as follows:

1 year	0%	4 years	60%
2 years	20%	5 years	80%
3 years	40%	6 years or more	100%

Participants become fully vested upon death or permanent disability. Due to the Plan termination, discussed in Note B above, all participants become fully vested in their Sponsor matching contributions.

**NOTE C - DESCRIPTION OF THE PLAN – continued**

*Forfeitures:* Forfeitures may be used to reduce future employer contributions and pay the expenses of the Plan. No forfeitures were used during 2024 and 2023 to offset employer contributions to the Plan.

*Expenses of the Plan:* The Plan’s administrative expenses are paid either by the Plan or the Plan Sponsor as provided in the Plan document.

*Payment of Benefits:* On termination of service, a participant may elect to receive a lump-sum distribution equal to the value of the participant’s vested interest in his or her account. Distributions are allowed at age 65, normal retirement age and in-service distributions are available to participants who are age 59 ½. Any balance under \$1,000 is automatically paid out as soon as administratively possible. Hardship withdrawals are also available subject to certain limitations.

*Participants’ Notes Receivable:* Participants’ notes receivable are available to all eligible actively employed participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Interest rates are established by the Plan Sponsor. Principal and interest are repaid through salary deductions each pay period according to an amortization schedule based on the life of the note.

*SECURE 2.0 Act:* The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2024 and later. As of the date of the financial statements, no amendments had been made.

**NOTE D - INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)**

As permitted by Department of Labor CFR 2520.103-8, investments and participants’ notes receivable at November 20, 2024 and December 31, 2023, and the related net appreciation in fair value of investments and interest on participants’ notes were certified and held by John Hancock Life Insurance Company, the Custodian, and were not audited by the independent auditor.

**NOTE E - TRANSACTIONS WITH PARTIES IN INTEREST**

Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the years ended December 31, 2024 and December 31, 2023, the Plan made direct payments to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan sponsor pays directly any other fees related to the operation of the Plan. Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

**NOTE F - INCOME TAX STATUS**

The Plan has received a favorable determination letter that it qualifies under applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Management is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax returns for the last four years remain subject to examination.

**NOTE G - FAIR VALUE MEASUREMENTS**

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2: Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets
  - quoted prices for identical or similar assets or liabilities in inactive markets
  - inputs other than quoted prices that are observable for the asset or liability
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means
  - if the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used, nor transfers between levels. Following is a description of the valuation methodologies used for various types of assets measured at fair value:

*Pooled separate accounts:* Valued at fair value and include various investment types, including mutual funds, money market funds, and other pooled investment vehicles. Mutual funds and money market funds are valued based on quoted market prices in active markets. Other investments, such as collective investment trusts or similar vehicles, are typically valued using the Net Asset Value (NAV) as a practical expedient or based on observable inputs where applicable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE I - RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE J - PROHIBITED TRANSACTIONS**

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable. The Plan had contributions of \$4,058 in 2024 and \$25,712 in 2022 that were not remitted timely. These contributions are considered prohibited transactions.

**NOTE K – MISSED REMITTANCE CORRECTION**

The Plan Sponsor withheld \$1,549 of contributions that were not remitted to the Plan in 2024. The Plan Sponsor remitted a corrective contribution including lost earnings to these participants through their new plan at Principal Financial Services on September 11, 2025.
