Responsibilities of Management for the Financial Statements

Note 1: Description of Plan

The following description of the Miller 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan covering substantially all employees of the sponsor, Tolm Group, Inc. and affiliated employers Cowell Steele Structures, LLC; Hattieville Leasing, LLC; Phoenix Innovations, Inc.; TOLM Industrial, LLC; Weston Petroleum, LLC; Wren Industries; and Point Remove Brewing, LLC (collectively, the “Employer”), who have reached 18 years of age and have completed three months of service, excluding collectively bargained employees. Employees will become eligible to participate on the first day of the Plan Year quarter after completion of all eligibility requirements.

Effective January 1, 2024, The Setting Every Community Up for Retirement Enhancement (SECURE) Act extended eligibility for participation in 401(k) plans to certain long-term part-time (LTPT) employees. LTPT employees must have three consecutive years of eligible service beginning in 2021 in order to make deferral contributions into the Plan. Eligible service is defined as at least 500 hours of service for each 12-month eligibility period. The eligibility service window applies for plan years beginning after December 31, 2020, and excludes service before that. The Plan Sponsor may still require the employee to satisfy any minimum age requirements, and can also decide whether LTPT employees will receive any portion of employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendments

The Plan was amended effective January 1, 2023 to reflect the new participation of the affiliated employer Point Remove Brewing, LLC. Additionally, the Plan was amended to exclude collectively bargained employees from eligibility for participation in the plan.

The plan was amended effective August 15, 2024 to reflect the cessation of participation in the plan by formerly affiliated participating employer, Rosewood Classic Coach, Inc.

Contributions

Participants may contribute up to 100% of their annual compensation not to exceed the limit set by the Internal Revenue Code, which was \$23,000 in 2024 and \$22,500 in 2023. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to an additional \$7,500 in 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified retirement plans. Compensation is defined as total compensation subject to income tax, excluding reimbursements and other expense allowances, fringe benefits (cash and non-cash), moving expenses, deferred compensation, and welfare benefits, and including any salary reduction contributions.

The Plan allows the Employer to make “safe harbor” matching contributions equal to 100% of the first 3% of compensation and 50% of the next 2% of compensation.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Employer’s “safe harbor” contributions, and Plan earnings and losses. Participant accounts are charged with an allocation of the Plan’s administrative expenses that are paid by the plan. Allocations are based on participant earnings, account balances or specific participant transactions as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions, employer “safe harbor” contributions, and any earnings thereon.

Administrative Expenses

Plan fees and expenses, including fees and expenses connected with the providing of administrative services by external service providers, are paid either by the Plan or the Employer, as provided by the Plan document. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net change in fair value of investments.

Investment Options

Participants may instruct the trustee, through an employee election form, on how to invest their account among funds established by the Plan administrator. Participants may change their investment selections at anytime. The Plan currently offers 30 pooled separate accounts as investment options for participants.

Payment of Benefits

Upon death, disability, retirement, or termination of service for other reasons, a participant may elect to receive payments of his or her vested account balance in a lump-sum distribution, as partial withdrawals, or as a direct rollover to an eligible retirement plan. The Plan allows in-service withdrawals from participant deferral account balances for financial hardship, and from all vested accounts after age 59 ½ or upon reaching normal retirement age.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting. Under the accrual basis of accounting, revenues and expenses, other than benefit payments, together with the related assets and liabilities are recorded in the accounting period to which they apply, regardless of when the cash transaction occurred.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan administrators to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. The Plan’s most significant estimate relates to the valuation of investments. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the valuation policies utilizing information provided by the investment advisors and custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated all subsequent events for potential recognition and disclosure through November 21, 2025, the date these financial statements were available to be issued.

Note 3: Plan Termination

Although it has not expressed the intent to do so, the Employer has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. Employee contributions, employer "safe harbor" contributions and their related earnings are always 100 percent vested.

Note 4: Parties-in-Interest Transaction

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employee association or relatives of such person.

Plan Administration & Consulting, LLC is the third-party administrator. John Hancock Life Insurance Company processes and maintains the records of the participant data and holds the Plan assets. Arvest Wealth Management serves as an investment advisor to the Plan. They are by definition parties-in-interest and, as a result, these transactions qualify as party-in-interest transactions. The Plan paid \$82,957 and \$46,475 for investment management, administrative, and other fees during the years ended December 31, 2024 and 2023, respectively. These transactions are exempt from being prohibited transactions under ERISA.

Note 5: Fair Value

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Following are the valuation methodologies the Plan uses to measure financial instruments at fair value:

Pooled Separate Accounts (PSAs): Valued at the net asset value (NAV) as reported by the fund managers as of the financial statement date based on recent transaction prices. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance requirement. The Plan is permitted to redeem investment units at NAV on the measurement date.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments in the statements of changes in net assets available for benefits. The Plan's investments (including realized gains and losses on investments bought, sold, and held during the year as well as unrealized appreciation of the investments held at the end of the year) appreciated(depreciated) in value by \$657,510 in 2024 and \$647,104 in 2023.

Note 6: Income Tax Status

The IRS has determined and informed the Employer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7: Information Prepared and Certified by Custodian

The Plan's investments are held by John Hancock Life Insurance Company, the custodian. The amounts set forth in the accompanying financial statements for investments and investment income and the information shown in the supplemental schedules were summarized from information furnished by the custodian. The Plan administrator received from the custodian certification that information furnished is complete and accurate. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the information certified by the custodian were not subjected to any audit procedures except for comparing the information with the related information included in the financial statements and supplemental schedules.

Note 8: Reconciliation of Financial Statements to Form 5500

Certain amounts reported in the Plan's annual Form 5500 for changes in net assets available for benefits are different from the amounts reported in the accompanying financial statements. These differences are due to different presentation of investment income and expenses but have no effect on the net assets of the Plan.

Note 9: Subsequent Events

Subsequent to year end, the Plan changed its custodian from John Hancock Life Insurance Company to Ascensus Trust Company. The third party administrator was changed from Plan Administration & Consulting, LLC to Ascensus, LLC. The Plan assets were transferred to the new provider effective January 3, 2025. The Employer has adopted Ascensus LLC's Plan Document, effective January 1, 2025, with no significant changes to Plan provisions.
