Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Atrio Health Plans, Inc. Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Atrio Health Plans, Inc. Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. 1. Plan Description

The following description of Atrio Health Plans, Inc. Employee Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective January 1, 2022.

General

The Plan, which was established January 1, 2006, is a defined contribution plan covering substantially all employees of Atrio Health Plans, Inc. (the Company), who have 90 days of service. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Eligible participants enter the Plan on the first of the month after meeting the eligibility requirements. John Hancock Life Insurance Company is the Plan's custodian. The 401(k) Plan Committee oversees governance of the Plan.

Contributions

Each year, participants may contribute up to 100 percent of annual compensation on a pre-tax or Roth (after-tax) basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

The Company makes a Safe Harbor nonelective employer contribution of 3 percent of eligible compensation. Participants are eligible for the Safe Harbor employer contribution after completing 90 days of service. The Safe Harbor employer contribution for the years ended December 31, 2024 and 2023 were \$393,820 and \$443,064, respectively.

The Company may also make a discretionary matching employer contribution each year, which is allocated based on the discretion of the executive committee of the Plan sponsor and in accordance with regulatory limits. Participants are eligible for the discretionary matching employer contribution upon completing 1,000 hours of service and must be employed on the last day of the Plan year. The Company did not make a discretionary matching employer contribution for the years ended December 31, 2024 and 2023.

The Company may also make a discretionary nonelective employer contribution each year, which is allocated based on the discretion of the executive committee of the Plan sponsor and in accordance with regulatory limits. Participants are eligible for the discretionary employer contributions upon completing 1,000 hours of service and must be employed on the last day of the Plan year in order to receive the discretionary nonelective employer contribution. For the years ended December 31, 2024 and 2023, the Company did not make a nonelective employer contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and earnings on the participant's account balances. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

1. Plan Description, continued

Vesting

Participants are vested immediately in their contributions, Safe Harbor nonelective contributions, plus actual earnings thereon. Vesting in discretionary match and discretionary non-elective contributions for participants is based on years of service and is 30 percent vested after one year, 60 percent after two years, and 100 percent after three years.

Forfeited Accounts

Amounts that are not fully vested when participants terminate from the Plan are forfeited. These amounts are used to pay Plan administrative expenses or offset future Employer contributions. For the years ended December 31, 2024 and 2023, \$2,869 and \$1,407, respectively was forfeited by participants and \$868 and \$3,053, respectively was used to pay plan expenses or reinstate participant balances. There were \$3,117 and \$1,171 of unused forfeitures at December 31, 2024 and 2023, respectively.

Payment of Benefits

Upon retirement, disability, death, or termination, participants (or their beneficiaries) may elect to receive part or all of the vested interest in their accounts by lump-sum, in accordance with the appropriate provisions of the Internal Revenue Code (IRC) and applicable state laws. In-service withdrawals are allowed at age 59½ from all accounts that are fully vested. Hardship distributions are permitted in the event of an immediate and heavy financial need in an amount not to exceed the lesser of the participant's vested account or the amount of the financial need, in accordance with Plan provisions.

Notes Receivable from Participants

The Plan does not allow participants to borrow from their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 3 for additional information on fair value measurements.

Purchases or sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Participant and employer contributions are recorded in the year in which the participant contributions are withheld and underlying compensation paid.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administration Expenses and Fees

Administrative expenses of the Plan are paid from Plan assets or from the balance of available forfeitures. Administrative expenses may also be paid by the Employer; such expenses are excluded from these financial statements. Certain participant transaction fees are charged directly to the participant's account. Investment related expenses are included in net change in fair value of investments or as a reduction from investment income.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable. There was no impact to the financial statements as a result of adopting this standard.

3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: A portion of the Plan's investments are units of mutual funds held within a group annuity contract through John Hancock and valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered to have a readily determinable fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Employer discretionary match contributions and their Employer discretionary non-elective contributions.

During the plan year ended December 31, 2024, the Company implemented headcount reduction measures that resulted in a significant number of involuntary terminations. These terminations constitute a partial plan termination, and as such, the affected participants became 100 percent vested in the portion of their account balances from employer discretionary match and discretionary profit-sharing contributions.

5. Tax Status

The Plan is a Non-Standardized Pre-Approved Profit-Sharing Plan with CODA (the prototype plan upon which the Plan is based). The Sponsor of the prototype plan has obtained an opinion letter dated November 30, 2020, in which the IRS informed the Employer that the Plan as then designed was in accordance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. Information Certified by the Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Party-in-Interest Transactions

Certain Plan mutual fund investments are managed by John Hancock Life Insurance Company, the custodian of the Plan, and therefore these transactions qualified as party-in-interest transactions. Administrative fees paid to John Hancock Life Insurance Company for the years ended December 31, 2024 and 2023 totaled \$21,934 and \$22,236, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Non-Exempt Transactions

During the year ended December 31, 2023 and 2022, participant contributions totaling \$33,935 and \$1,325 respectively, were not remitted to the Plan within the appropriate time period by the Company. These transactions constitute prohibited transactions as defined by ERISA. The Company took the appropriate steps to correct the situation 2024 by reimbursing employees for lost earnings and interest. During the year ended December 31, 2024 no remittances were deemed late.

10. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
