## INDEPENDENT AUDITOR'S REPORT

**To the Administrative Committee  
Co-op 401(k) Plan sponsored by Dairy One Cooperative, Inc.  
Ithaca, New York**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements Co-op 401(k) Plan sponsored by Dairy One Cooperative, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Co-op 401(k) Plan sponsored by Dairy One Cooperative, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Co-op 401(k) Plan sponsored by Dairy One Cooperative, Inc. and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

#### NOTE 1 - DESCRIPTION OF PLAN

---

The following description of the Co-op 401(k) Plan sponsored by Dairy One Cooperative, Inc. (the “Plan”) provides only general information. Participants should refer to the plan document and adoption agreement for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a defined contribution plan sponsored by Dairy One Cooperative, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All employees who are age 18 or older are eligible after completing one year of service or at least 30 consecutive days of eligibility service. Entry dates are the first day of the month following completion of eligibility requirements. The Administrative Committee is responsible for oversight of the Plan. The plan administrator determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Administrative Committee.

The Plan is part of the Co-op 401(k) Trust (the “Trust”), which was established for the investment of assets of the Plan along with several other Co-op sponsored retirement plans in the United States. The investments of the Plan are held in a separate subaccount of the Trust by Charles Schwab Trust Bank, the trustee.

##### **Contributions**

Each year, participants may make salary savings contributions in an amount up to 50% of their compensation on a pre-tax or after-tax basis, in accordance with the Roth provision, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The auto enrollment provision includes an automatic deferral escalation of 1% each year with a cap of 6%. Under the Plan, the Company makes safe harbor contributions in an amount equal to the sum of 3% of each participant’s compensation for the plan year. The Company also makes a matching contribution equal to 50% up to 6% of a participant’s compensation. The Plan also permits the Company to make a discretionary profit-sharing contribution, which is allocated by the ratio each eligible participant’s compensation bears to the total compensation of all eligible participants. No discretionary profit-sharing contributions were made for the years ended December 31, 2024 and 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions and the Company’s contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions and the Company's safe harbor and discretionary profit sharing contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their account is based on years of continuous service. A participant is 100% vested after five years of credited service. Participants will become 100% vested if they reach their normal retirement date (age 65) or they leave employment due to permanent disability, or death, even if 5 years of service is not completed.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the local prevailing rates. Principal and interest is paid ratably through regular payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In-service withdrawals are permitted for participants that have attained age 59 ½ or for financial hardship.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$177 and \$960, respectively. These accounts are used to reduce future employer contributions or to pay administrative expenses. Also, in 2024, employer contributions were reduced by \$20,883 from forfeited nonvested accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of fully benefit-responsive investment contracts.

The Plan held investments in Co-op 401(k) Stable Asset Fund ("the Fund"), a separately managed account, which is managed for the Plan by an investment manager. The Fund is comprised of one collective trust fund, three synthetic guaranteed investment contracts, and one guaranteed investment contract. At December 31, 2024 and 2023, the Fund totaled \$3,586,205 and \$3,160,699, respectively. The Plan separately accounts for each of the underlying investments of the Fund for financial statement reporting purposes.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants are recorded in the year in which participant deferrals are withheld from compensation. Safe harbor contributions, matching contributions, and discretionary profit-sharing contributions from the Company are recorded in the year service is rendered by the participant.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments. Accrued expenses relate to investment management and wrapper contract fees outstanding at plan year end.

**Subsequent Events**

The Plan has evaluated subsequent events through December 1, 2025, the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* Composed primarily of fully benefit-responsive investment contracts that are valued at net asset value (NAV) of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

**NOTE 4 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The Co-op 401(k) Stable Asset Fund holds investments in a guaranteed investment contract (“GIC”) and three synthetic guaranteed investment contracts (“synthetic GICs”). These investment contracts meet the fully benefit-responsive investment contract criteria, and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Traditional GICs are backed by the general account of the contract issuer. The Fund deposits a lump sum with the issuer and receives a guaranteed interest rate for a specified period. Interest is accrued on either a simple or fully compounded basis, and is paid either periodically or at the end of the contract term. Synthetic GICs include wrapper contracts that provide a guarantee that the credit rate will not fall below 0%. Cash flow volatility (for example, timing of benefit payments) as well as asset underperformance can be passed through to the Plan through adjustment to future contract crediting rates. Formulas are provided in each contract that adjust renewal crediting rates to recognize the difference between fair value and the book value of the underlying assets. Crediting rates are reviewed monthly for resetting. The issuers guarantee that all qualified participant withdrawals will be at contract value (principal plus accrued interest).

A security-backed contract is an investment contract issued by an insurance company or other financial institution, backed by a portfolio of bonds that are owned by the Fund. The portfolio underlying the contract is maintained separately from the contract issuer's general assets, usually by a third-party custodian. The interest crediting rate of a security-backed contract is based on the contract value, and the fair value, duration, and yield to maturity of the underlying portfolio. These contracts typically allow for realized and unrealized gains and losses on the underlying assets to be amortized, usually over the duration of the underlying investments, through adjustments to the future interest crediting rate, rather than reflected immediately in the net assets of the Fund. The issuer guarantees that all qualified participant withdrawals will be at contract value.

The Plan's ability to receive amounts due is dependent on the issuers' ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Risks arise when entering into any investment contract due to the potential inability of the issuer to meet the terms of the contract. In addition, security-backed contracts have the risk of default or the lack of liquidity of the underlying portfolio assets.

Certain events may limit the ability of the plan sponsor and/or plan participants to transact at contract value with the issuers: (1) material amendments to the Fund's structure or administration; (2) changes to the participating plan's competing investment options including the elimination of equity wash provisions; (3) complete or partial termination of the Fund, including a merger with another fund, (4) the failure of the Fund to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; (5) the redemption of all or a portion of the interests in the Fund held by a participating plan at the direction of the participating plan sponsor, including withdrawals due to the removal of a specifically identifiable group of employees from coverage under the participating plan (such as a group layoff or early retirement incentive program), the closing or sale of a subsidiary, employing unit, or affiliate, the bankruptcy or insolvency of a plan sponsor, the merger of the Plan with another plan, or the plan sponsor's establishment of another tax qualified defined contribution plan; (6) any change in law, regulation, ruling, administrative or judicial position, or accounting requirement, applicable to the Fund or participating plans; (7) the delivery of any communication to plan participants designed to influence a participant not to invest in the Fund. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

GICs and synthetic GICs generally do not permit issuers to terminate the agreement prior to the scheduled maturity date. Security-backed contracts generally are evergreen contracts that contain termination provisions, allowing the Fund or the contract issuer to terminate with notice, at any time at fair value, and providing for automatic termination of the contract if the contract value or the fair value of the underlying portfolio equals zero. The issuer is obligated to pay the excess contract value when the fair value of the underlying portfolio equals zero.

In addition, if the Fund defaults in its obligations under the security-backed contract (including the issuer's determination that the agreement constitutes a non-exempt prohibited transaction as defined under ERISA), and such default is not corrected within the time permitted by the contract, then the contract may be terminated by the issuer and the Fund will receive the fair value as of the date of termination.

**NOTE 5 - PLAN TERMINATION**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer matching contributions.

**NOTE 6 - TAX STATUS**

---

The Plan has adopted a non-standardized pre-approved profit-sharing plan with CODA sponsored by Fox Rothschild LLP. The IRS has determined and informed the Plan by a letter dated June 30, 2020, that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - CERTIFIED INVESTMENTS**

---

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the trustee of the Plan).

**NOTE 8 - RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants which are secured by the participant's account balance. These transactions qualify as party-in-interest transactions. Other transactions, which may be considered related-party or party-in-interest transactions, relate to normal plan management and administrative services, and the related payment of fees.

**NOTE 11 - DELINQUENT PARTICIPANT CONTRIBUTIONS**

---

The Company did not remit certain participant contributions and loan repayments to the Plan totaling \$43,181 for the year ended December 31, 2022, on a timely basis as defined by the Department of Labor. The delinquent participant contributions resulted in prohibited transactions which are separately reported on Schedule H, Line 4a - Schedule of Delinquent Participant Contributions. Additionally, the Company did not remit certain employer match contributions to the Plan totaling \$27,700 for the year ended December 31, 2022, on a timely basis as defined by the Department of Labor. The third-party administrator calculated lost earnings resulting from the delay in participant and employer discretionary contributions and subsequently has made a contribution for lost earnings to the Plan in August 2025.

During 2023, the Company erroneously failed to timely remit certain employee deferrals to the Plan totaling \$172. The Company computed the lost earnings on these 2023 deferrals and subsequently has made a contribution for lost earnings to the Plan in August 2025.

The Company did not remit certain participant contributions and related employer matching contributions to the Plan totaling \$396 for the year ended December 31, 2024, on a timely basis as defined by the Department of Labor. The delinquent participant contributions resulted in prohibited transactions which are separately reported on Schedule H, Line 4a - Schedule of Delinquent Participant Contributions. The third-party administrator will calculate lost earnings resulting from the delay in participant and employer matching contributions and remit the correction subsequent to the date of the financial statements.

The amount of lost earnings for delinquent participant and employer contributions related to the plan years ended December 31, 2024 and 2023 are not considered to be material to the Plan, and are therefore not included in these financial statements.
