Subject: Request for Penalty and Interest Abatement

I am writing to respectfully request abatement of penalties and interest assessed in connection with the late filing of Form 5500-SF for the tax period ending December 31, 2023.

The delay in filing was due to reasonable cause and not willful neglect. LEW, Inc. was sold on August 12, 2022, and a Form 5500-SF was filed for that year. Unfortunately, I was unaware that an additional filing was required for the 2023 plan year to complete the process.

Further complicating matters, IRS correspondence continued to be sent to the former business address at 309 13th Avenue South, South St. Paul, MN 55075, despite my submission of a forwarding request to the local post office. The forwarding period expired after six months, and I did not receive IRS notices until they were redirected to my home address in 2025.

Upon receiving the notice, I acted promptly to resolve the issue. Although I was no longer a client of my previous payroll provider, Paychex, they assisted me in preparing the required filing. After learning that Form 5500-SF must be filed electronically through EFAST2, I completed the electronic filing on September 23, 2025, and confirmed receipt with the IRS on October 1, 2025.

Given these circumstances, I respectfully request that the penalties and interest be abated. The delay was unintentional, and I took immediate steps to comply once I became aware of the requirement.
