To Whom It May Concern:

This statement is submitted in connection with the late filing of Form 5500 for the Duncan Mechanical Services Inc 401 (K) Retirement Plan, EIN: 38-3975475, Plan Number 001, for the plan year ending December 31, 2024.

The late filing was due to reasonable cause and not willful neglect. During the applicable filing period, the Plan Administrator relied on information and reporting from third-party service providers to prepare the annual return. Due to an inadvertent administrative oversight and delays in receiving necessary financial and participant data, the Plan Administrator did not become aware that the Form 5500 had not been timely filed. Once the issue was identified, the Plan Administrator acted promptly to gather the required information and complete and submit the filing as quickly as possible.

To prevent this issue from occurring in the future, the Plan Administrator has implemented improved internal controls, including enhanced calendar tracking, updated procedures for coordinating with service providers, and additional review steps to ensure timely and accurate filing of all required annual returns.

The late filing was inadvertent, unintentional, and corrected promptly upon discovery. We respectfully request that the Department consider these circumstances as constituting reasonable cause for the late submission.
