Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of PA Consulting Group, Inc. Salary Savings Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following description of the PA Consulting Group, Inc. Salary Savings Plan (the “Plan”) is provided for general purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan, established January 6, 1983, is a defined-contribution plan available to qualifying employees of PA Consulting Group, Inc. (the “Company” or the “Plan Sponsor”) except for temporary employees including student interns, occasional part-time employees who are scheduled to work less than 1,000 service hours on an annual basis, employees of oversea subsidiaries, project employees, and transferees from another company outside of the United States of America, which is part of the PA International Group, which group presently has its principal offices in London, England. The Plan was most recently restated effective May 13, 2020. There is no age or service requirement to be eligible to participate in the Plan. The Plan is intended to qualify under Section 401(k) of the Internal Revenue Code (“IRC”) and subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan administrator and Plan fiduciary are responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

The Plan Sponsor acquired the Cambridge Group, and effective August 1, 2023, the Cambridge Group plan assets were transferred into the Plan.

Administration – The Plan is administered by the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses are either paid directly by the Plan Sponsor or by the account of the participant.

Participant Contributions – Each year, participants may contribute a percentage of their eligible compensation, as defined in the Plan, on a pre-tax basis, subject to statutory limitations of the IRC. The Plan was amended on May 13, 2020, to add Roth 401(k) contributions to the Plan. In addition, participants 50 years of age or older may elect to make a catch-up deferral contribution of up to \$7,500 for the year ended December 31, 2024. Distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution.

Automatic Enrollment – Newly-hired eligible employees are automatically enrolled to contribute salary deferrals equal to 3% of compensation. Each year, the contribution percentage is increased by 1%, up to a maximum of 10%. A participant may specifically request to opt out of the automatic enrollment or may elect to contribute a different amount.

Employer Contributions – The Company makes an employer matching contribution of 6% of eligible compensation to eligible employees, as defined in the Plan. Matching contributions are made to only those participants who are employed on the last day of the Plan year. For the year ended December 31, 2024, the Company allocated employer matching contributions of \$3,085,337. Forfeitures of \$291,663 were used to reduce the 2024 employer matching contributions. The Company may also make qualified matching contributions, as determined necessary. No such qualified matching contributions were made during the year ended December 31, 2024. All contributions are subject to certain IRC limitations.

Investment Options – Participants may direct Vanguard Fiduciary Trust Company (“Vanguard”), the qualified institution, as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at the beginning of each quarter. Transfers of account balances between elected investment options may be made at the beginning of each quarter.

Note 1—Description of the Plan (continued)

Vesting – Participants are immediately vested in their salary deferral contributions, and rollover contributions, plus actual earnings (losses) thereon. Participants may direct the investment of contributions on a daily basis into various investment options offered by the Plan. A participant also becomes 100% vested upon death, becoming disabled, or reaching retirement age, as defined by the Plan. The employer and matching contributions are vested as follows:

Less than 1 year	0%
1 year	33%
2 years	66%
3 years	100%

Participant Accounts – Individual accounts are maintained for each participant and include participants' salary deferral contributions, rollover contributions, plus an allocation of the Plan Sponsor's qualified matching contributions, if any, matching contribution, if any, and Plan earnings (losses), including realized and unrealized gains and losses on investments, and charged with the participant's distributions and the allocation of Plan expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits – A participant may make a withdrawal, at termination of the Plan, becoming disabled, for certain in-service withdrawals upon attainment of 59½, or attaining normal retirement age. Upon termination of service due to retirement, death, or disability, a participant or beneficiary may elect to receive the value of the vested interest in his or her account either by a lump-sum distribution or in monthly, quarterly, or annual installments over a period not to exceed the participant's or beneficiary's life expectancy at the time of distribution.

The Plan also allows, in certain hardship situations as defined in the Plan, participants to withdraw from their account balances while actively employed. These hardship withdrawals are subject to IRC restrictions and penalties.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum amount that is equal to the lesser of \$50,000 or 50% of their vested account balance. Note transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Notes must be repaid within five years (or up to 20 years for the purchase of a primary residence). The notes are secured by the balance in the participant's account and accrue interest (as of the loan start date) equal to the then existing prime rate of interest plus 1%. At December 31, 2024, interest rates ranged from 4.25% to 9.50% with maturities through June 2041.

Forfeitures – Terminating participants forfeit nonvested Plan Sponsor profit sharing contributions. Remaining forfeitures shall be applied against Plan Sponsor contributions in accordance with specific Plan provisions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$430,289 and \$251,218, respectively. For the year ended December 31, 2024, forfeitures of \$291,663 were used to reduce the 2024 employer matching contributions.

Note 2—Summary of significant accounting policies

Basis of Accounting – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

Benefits Paid to Participants – Benefits paid to participants are recorded when paid.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Risk and Uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the statements of net assets available for benefits.

Fair Value Measurements – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability, including assumptions regarding risk.

Note 2—Summary of significant accounting policies (continued)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Mutual Funds – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Money Market Fund – This investment is valued at the closing price reported on the active market on which the individual security is traded and is classified within Level 1 of the valuation hierarchy.

Self-Directed Brokerage Fund – This investment is a public investment vehicle valued at the closing price reported on the active market on which the individual securities are traded. This investment is classified within Level 1 of the valuation hierarchy.

Common Collective Trust – This investment is a public investment vehicle valued using NAV as a practical expedient to estimate fair value provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. In accordance with Accounting Standards Codification (“ASC”) Subtopic 820-10, this investment has not been classified under the fair value hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 3—Information certified by the qualified institution (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard, the qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024:

- Investments, at fair value, and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Note 5—Parties-in-interest

Certain Plan investments are managed by Vanguard and, therefore, these transactions qualify as parties-in-interest transactions for which a statutory exemption exists. Fees paid to the Trustee totaled \$152,249 for the year ended December 31, 2024.

Notes receivable also qualifies as party-in-interest transactions.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances.

Note 7—Tax status

The Plan utilized a prototype plan document sponsored by The Vanguard Group. The prototype plan sponsor has obtained a favorable opinion letter dated February 21, 2019, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
