1. Description of the Plan

The following description of The Deron School Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a complete description of Plan’s provisions.

General

The Deron School Retirement Plan (the “Plan”) is a defined contribution plan qualifying under Section 401(a) of the Internal Revenue Code, covering substantially all eligible employees of The Deron School of New Jersey, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established on July 1, 1984, as a tax deferred profit-sharing plan for the purpose of providing eligible employees of the Company and their beneficiaries funds for retirement.

Administration of the Plan

The general administration of the Plan and the responsibility for carrying out its provisions shall be placed on the Company. The Company is the Plan sponsor and serves as the Plan Administrator and Trustee. The Company has engaged the services of an independent company to assist it with the performance of its duties. Alerus Financial, N.A (“Alerus”) serves as the plan custodian.

Eligibility

An employee is considered eligible if they have completed 1 year of service (1,000 hours) and are at least 21 years of age, provided they are not otherwise excluded from the Plan. Employees enter the Plan on the entry date. The entry date is the first day of the Plan year or the first day of the seventh month of the plan year coinciding with or next following the date eligibility requirements are satisfied.

Contributions

The Company may make discretionary profit-sharing contributions to participants upon meeting eligibility requirements. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution Plans. Participants direct the investment of the contributions into various investment options offered by the Plan. For the years ended June 30, 2025 and 2024, the Company made a profit-sharing contribution of \$1,283,153 and \$972,547 respectively, net of forfeitures applied.

The Plan does not allow for participant contributions.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's proportional allocation of the Plan's earnings, including realized and unrealized gains and losses, and expenses. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the Company's contribution portion of accounts is based on years of continuous service and follows the chart below. Moreover, participants are fully and automatically vested in their accounts after becoming eligible for retirement, incurring a disability prior to termination, or upon death.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested account balances or \$50,000. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1 percent above the prime rate, as defined. Interest rates range from 4.25% to 9.5%. Principal and interest is paid ratably through payroll deductions.

The maximum number of loans available to a participant at any given time is two loans. Terms depend on the type of loan; a general loan must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period is allowed.

Payment of Benefits

On termination due to death, disability or retirement, a participant or his or her beneficiary will receive payment equal to the value of the participant's vested interest in his or her account through a lump-sum payment or ad-hoc distribution only of the participant is subject to lifetime required minimum distributions. If the participant has not begun taking distributions before the required beginning day for the distributions, the Plan generally must commence distributions as of such date. The required beginning date is April 1 following the end of the calendar year in which the participant attains age 72 or terminates employment, whichever is later.

In-Service Withdrawals

An active participant may withdraw all or a portion of their vested account balance on January 1st of the calendar year in which they attain the age of 59 ½. The participant is also entitled to withdraw all or a portion of their rollover account balance, if any, at any time. In the event a participant suffers financial hardship, as defined in the Plan, the participant may generally withdraw all or part of the vested portion of his/her account.

Forfeited Accounts

Forfeitures are the non-vested amounts in the accounts of participants who terminate service. In accordance with the Plan, forfeitures are used to reduce the Company's employer contributions or to pay administrative plan expenses. Forfeited balances may also be used to reinstate previously forfeited account balances of participants. During the 2025 plan year, \$110,375 in forfeitures were used to reduce the Company contributions. At June 30, 2025 and 2024, forfeited non-vested amounts totaled \$104,660 and \$110,375, respectively.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the amounts of assets and liabilities, revenues and expenses and changes therein, and disclosures of contingent assets and contingent liabilities and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies using information provided by investment advisors and custodians. See Note 4 for fair value disclosure. Participant loans are valued at outstanding balances, which approximate fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on an accrual basis. Related fees are charged directly to the participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of June 30, 2025 and 2024. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan's administrator has reviewed subsequent events and transactions that occurred after June 30, 2025, through the date of the independent auditors' report and the date the financial statements were available to be issued, December 1, 2025. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with generally accepted accounting principles. Management has determined that there are no nonrecognized subsequent events that require additional disclosure.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

*Self-directed brokerage account:* Consists of common stock, interest-bearing cash, and exchanged traded funds.

*Common stock and exchange traded funds:* Valued at the closing price reported on the active market on which the individual securities are traded.

Redemptions of the common collective trust held by the Plan are allowed daily for participants; however, the Plan is subject to a twelve-month redemption notice period. There are no unfunded commitments.

5. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of the Plan termination or if employer contributions are permanently discontinued, the rights of the participants under the Plan will become fully vested and non-forfeitable. Should the Plan terminate at some future time, the assets of the Plan are to be distributed to the participants, their beneficiaries, or estates, in accordance with the value of the accounts as of the date of the termination of the Plan.

6. Tax Status

The Plan has been designed to qualify under section 401(a) of the Internal Revenue Code ("IRC"). Effective July 1, 2021, the Company adopted a restated pre-approved plan document of Alerus Financial NA, and the Internal Revenue Service ("IRS") has determined and informed the sponsor of the pre-approved plan document by a letter dated June 30, 2020, that the pre-approved document is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2017-41.

Accounting principles generally accepted in the United States of America, require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not, would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest Transactions

Certain Plan investments are managed by the Custodian. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Additionally, the Company is the Plan sponsor and administrator, therefore is a party-in-interest to the Plan. Loans to the participants and their management are also considered party-in-interest.

8. Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
