Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Notes to Financial Statements December 31, 2024 and 2023

Note 1: Description of Plan

The following description of the WMF, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering all employees of WMF, Inc. d/b/a Washington Metal Fabricators, LLC (the Company or the Plan Sponsor) who have reached 18 years of age and have completed two months of eligible service, as defined by the Plan Document. Employees may enter the Plan on the first day of each month of the year following completion of the age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make pre-tax and Roth 401(k) contributions to the Plan through payroll deductions up to 75% of their Plan compensation, as defined by the Plan Document, subject to the statutory limit set by the Internal Revenue Code (IRC). The limit for 2024 was \$23,000. Participants who have attained at least age 50 are eligible to defer additional amounts (catch-up contributions). The maximum catch-up contribution was \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Plan Sponsor may match, subject to limitations under the IRC, a portion of each participant's contributions. The amount of the matching contribution, if any, is determined by the Plan Sponsor each pay period. During 2024, the Plan Sponsor elected to not match participant contributions.

In addition to any matching contributions, the Plan Sponsor may deposit discretionary non-elective contributions to the Plan. Such contributions are subject to the limitations under the IRC. Participants must complete over 500 hours of service during the plan year to receive an allocation of discretionary non-elective contributions. There were no discretionary non-elective contributions made by the Plan Sponsor during the year ended December 31, 2024.

Administration

The Company serves as the Plan Administrator. The Plan Administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan and making determinations regarding questions which may affect eligibility for benefits.

Effective November 1, 2024, Fidelity Management Trust Company (Fidelity or the Trustee) serves as trustee and third-party administrator of the Plan. Prior to November 1, 2024, Capital Bank and Trust Company (Capital Bank) served as the trustee and third-party administrator of the Plan.

Capital Bank and Fidelity receive all contributions made under the Plan, holds Plan assets, pays benefits to participants as directed by the Plan Administrator, and is responsible for the administration of investments for the benefit of the participants and their beneficiaries (see Notes 3 and 6).

Participant Accounts

Each participant's account is credited with pre-tax, Roth and rollover contributions made by the participant and the participant's portion of Company matching contributions, discretionary non-elective contributions, and actual Plan earnings thereon. The participant's account is also charged with withdrawals, applicable allocations of investment gains/losses, and administrative expenses. Allocations are based on the participant's Plan compensation, account balances or specific participant transactions, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

Vesting

Participants are immediately 100% vested in their contributions, rollover balances, matching and non-elective contributions, and investment performance thereon.

Investment Options

Upon enrollment into the Plan, participants are required to make participant-directed allocations of their accounts in increments totaling 100% among various investment options offered by the Trustee and selected by the Plan Administrator. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their account balance, less defaulted loans, if any. Participants are limited to one outstanding loan at a time, secured by the participant's vested account balance and payable over a period not to exceed 5 years, unless for the purchase of the participant's primary residence. The interest rates on notes receivable from participants are established by the Plan Administrator, which are commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Benefits are paid according to the vested interest in the participant's account upon normal retirement age of 65, termination, disability, or death. Benefits are distributed to the participant or beneficiary as partial distributions, as defined in the Plan Document.

In general, a participant may withdraw from \$500 up to 100% of the participant's contributions in the event of a heavy and immediate financial hardship, as defined in the Plan Document. Hardship distributions may not exceed the amount of the participant's financial hardship and may not be repaid by the participant. Participants may also receive an in-service distribution of their vested account balance after attaining age 59 1/2.

Participants withdrawing from the Plan due to termination of employment with the Plan Sponsor, other than due to retirement, disability, or death, may receive the value of their vested account by transfer to another qualified plan or individual retirement account or through a lump sum distribution. In general if the participant's account balance, as defined in the Plan Document, is greater than the involuntary cash-out amount of \$5,000, the account may not be distributed without the participant's consent.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4).

Purchases and sales of investments, including gains and losses, are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments represents the change in fair value during the year, including realized and unrealized gains and losses.

Risks and Uncertainties

The Plan's invested assets are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits and statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payments of Benefits

Benefit payments are recorded when paid by the Plan.

Administrative Expenses

Administrative expenses of the Plan are liabilities of the Plan but may be paid by the Plan Sponsor. These expenses include, but are not limited to, legal, accounting and recordkeeping fees, and investment expenses. For administrative expenses not paid by the Plan Sponsor, a proportionate share of fees and expenses paid by the Plan is charged to each participant's account.

Note 3: Certified Investments

Certain information summarized below related to the accompanying financial statements and ERISA-required supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

Note 4: Fair Value Measurements

The accounting standard for fair value measurements provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in non-active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds – Mutual funds are valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Income Tax Status

The Plan Sponsor entered into a standard adoption agreement with Fidelity (the Prototype Plan). The Prototype Plan received a favorable opinion letter from the IRS dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC.

The Plan Administrator believes the Plan is designed and currently operating in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax exempt as of December 31, 2024.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: Party-in-Interest Transactions

The Plan’s Trustees and their affiliates perform services for, sell products to, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. Transactions with these providers qualify as party-in-interest transactions. Fees paid by the Plan for these services totaled \$28,015 for the year December 31, 2024, which are reported as administrative expenses in the accompanying statement of changes in net assets available for benefits. In addition, notes receivable from participants also qualify as party-in-interest transactions.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 7: Prohibited Transactions

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions and loan repayments to the Plan from its general assets as soon as practicable. The Plan has contributions totaling \$27,207, all of which represented employee salary deferrals and loan repayments, that were not remitted timely in 2024. These contributions are considered prohibited transactions. The Company will calculate lost investment earnings and file Form 5330, as applicable, and expects to compensate the plan for the lost earnings in 2025.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subjected to the provisions of ERISA. In event of partial or full termination of the Plan, affected participants will become 100% vested in their accounts.

Note 9: Subsequent Events

The Plan Sponsor has evaluated subsequent events between the date of the statement of net assets available for benefits as of December 31, 2024 and the report date, which is the date these financial statements were available for issuance, and has concluded that all subsequent events requiring recognition or disclosure have been incorporated into these financial statements.
