Independent Auditor's Report

To the Plan Sponsor
Legal & General America, Inc. Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Legal & General America, Inc. Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a significant likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Legal & General America, Inc. Savings Plan (the "Plan") provisions is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General

The Plan is a defined contribution plan. Effective January 1, 2008, the Plan covered all employees of Legal & General America, Inc. ("LGA"), Legal & General Investment Management America, Inc., Banner Life Insurance Company, William Penn Life Insurance Company of New York, and Global Index Advisors, Inc. (collectively, "the Employers"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is administered by LGA ("Plan Administrator"). The authority to manage, control, construct, and interpret the Plan is vested in the Administrative Committee of LGA.

Effective January 1, 2015, the Plan was amended to use a "safe harbor" plan designed under Section 401(k) of the Internal Revenue Code ("IRC"). A plan with a safe harbor design automatically satisfies certain nondiscrimination testing otherwise applicable under the IRC, by providing a specified level of matching contributions and meeting other requirements.

Contributions and Vesting

Plan participants may elect to contribute, through salary deductions, an amount not to exceed 20% of his or her annual base salary up to the maximum amount allowed by the law. The Employers match employee contributions dollar for dollar up to 6% of each participating employee's base salary. Participants direct the investment of their contributions and the employer contributions into any of 15 mutual funds, a money market account, and a self-directed brokerage investment option offered by the Plan.

Under the Plan Agreement, participants are immediately vested in their contributions plus actual earnings thereon. Participants are immediately vested in all employer-matching contributions as of January 1, 2015, under the safe harbor contribution plan.

Each participant's account is credited with his or her contribution and their employer's matching contribution. Earnings of the funds in which the participant elects to participate are allocated to the participant's account based upon his or her interest in the fund in relation to the fund's total value. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Benefits

Upon disability, retirement or termination of employment from the Employers, distributions, if requested, are paid in either the form of a lump sum, annual installments or direct rollover to the participant or the designated beneficiary upon death.

Forfeitures

Under the Plan Agreement, forfeitures become available to reduce employer contributions and pay reasonable Plan expense in the Plan year in which such forfeitures arise. As of December 31, 2024 and 2023, \$11,967 and \$28,819, included in the Schwab Bank Savings Account, represents forfeitures available to reduce employer contributions. For the years ended December 31, 2024 and 2023, Plan management reduced employer contributions of forfeiture activity by \$3,920 and \$0, respectively. For the years ended December 31, 2024 and 2023, Plan management paid Plan expenses of \$22,717 and \$53,268.

Notes Receivable from Participants

Participating employees may borrow between \$1,000 and \$50,000 from their account balance, with an interest rate based on the prevailing prime interest rate, ranging from 3.25% - 8.50% at December 31, 2024. Note receivable amounts are limited to 50% of a participant's vested account balance. Participants may repay the note receivable over a period of up to five years unless the note receivable is utilized to purchase or improve a primary residence. In such an instance, the repayment period can be extended to a maximum of 25 years.

Withdrawals

Participants are permitted to withdraw from their account balance, subject to restrictions outlined in the Plan Agreement. Hardship withdrawals from the participant's pre-tax contributions, rollover contributions, and vested matching contributions are permitted in the event of a participant's illness, unusual need, or emergency. Hardship withdrawals are also permitted for the purpose of acquiring or preserving a home or for providing for the education of the participant or the participant's dependents. Hardship withdrawals are subject to the approval of the Plan Administrator.

Administrative Expenses

Expenses related to the administration of the Plan are generally borne by LGA. These expenses may include trustee and audit fees.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared on an accrual basis.

Distributions

Distributions from participant account balances are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The Plan presents in the Statements of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in the fair value of its investment, which consists of the realized gains or losses and unrealized appreciation (depreciation) on those investments. Investment income is recorded on the accrual basis.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Agreement. Interest income on loans is recorded when earned.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 3 – FAIR VALUE MEASUREMENTS

In compliance with Accounting Standards Codification Topic 820, *Fair Value Measurements and Disclosures*, the Plan has categorized its financial instruments based on a three-tiered fair value hierarchy approach, which prioritizes the inputs to valuation techniques used to measure fair value:

Level 1: Unadjusted quoted prices for identical assets within active markets.

Level 2: Quoted prices for similar assets in active markets or inputs that are significant that are observable either directly or indirectly; fair value can be determined through the use of model or other valuation methodologies whose inputs are observable or whose significant value drivers are observable. Valuations are generally obtained from third-party pricing services and tested for reasonableness by the Plan's management through comparisons to alternate pricing sources.

Level 3: Prices or valuations that require inputs that are both unobservable and significant to the overall fair value measurement. Inputs reflect assumptions and best estimates made by management regarding the assumptions a potential market participant would use when pricing the asset.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account: Account primarily consists of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

The following tables summarize the Plan's investments measured at fair value as of December 31, 2024 and 2023. See also Note 4 regarding certification of the Plan's investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income (loss) and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan.

NOTE 5 – PLAN TERMINATION

Although LGA has not expressed any intent to terminate the Plan Agreement or discontinue its contributions, it may do so at any time, subject to the provisions of ERISA. If the Plan is terminated, the rights of the Plan participants to the amounts credited to their accounts shall become non-forfeitable. Each affected participant will receive a single distribution equal to his or her account value as of the valuation date.

NOTE 6 – INCOME TAX STATUS

The Plan obtained its latest determination letter dated September 30, 2016, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and money market funds managed by the trustee and recordkeeper of the Plan; therefore, these transactions qualify as party-in-interest transactions. During 2024 and 2023, the Plan paid \$134,806 and \$134,806, respectively, to Schwab Retirement Plan Services, Inc. for record keeping services.

NOTE 8 – SUBSEQUENT EVENTS

LGA performed an evaluation of subsequent events through October 13, 2025, which is the date that these financial statements were available to be issued. There were no subsequent events requiring accounting or disclosure that were identified as a result of the LGA's evaluation.
