# Roofers Local Union #149 Vacation and Holiday Plan

## Notes to Financial Statements

### 1. Description of Plan

The following brief description of the Roofers Local Union #149 Vacation and Holiday Plan provides only general information about the Plan's provisions. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a multiemployer vacation and holiday benefit plan that was established on June 6, 1956 pursuant to a collective bargaining agreement (CBA) between the Southeast Michigan Roofing Contractors Association which represents the participating employers, and United Union of Roofers, Waterproofers and Allied Workers Local 149. The Plan is governed and managed by the Board of Trustees and covers all members of the union employed under the terms of collective bargaining agreements and subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

#### Contributions

The Plan is funded by employer contributions. The employer rates are specified in their collective bargaining agreements. These agreements provide for employers to contribute to the Plan on the basis of participants' hours worked.

#### Benefits

The vacation and holiday benefit payable to an eligible participant shall be equal to the balance accumulated in the participant's account on the applicable valuation date. If, as of any May 31st (the last day of the Plan's fiscal year), the Plan's assets exceed the aggregate amount of vacation and holiday pay standing to the credit of participants, accrued expenses and the estimated expenses for the next year, such excess may be distributed among the participants as a bonus or dividend distribution on a basis determined by management.

### 2. Summary of Accounting Policies

#### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### 2. Summary of Accounting Policies -continued

#### Benefits

Benefit payments are based on the amount accumulated in a participant's account and shall be available at an office designated by management. The participants elect to receive their vacation and holiday benefits on a quarterly, semi-annual or annual basis. Such payments shall be made between October 25th and July 25th of the following fixed year.

If any amount still stands to the credit of an employee twenty four (24) months after the date such amount was due to be distributed because of the failure to cash the distribution check, because the check is returned to the fund office undelivered, or because of insufficient information, no such check could be issued, and the participant fails to claim same within such twenty four (24) month period, then such amount standing to the participant's credit shall revert to and become part of the Fund free and discharged from any claim.

In the case of the death of a participant, all amounts credited to the participant's account shall be paid to the participant's designated beneficiary.

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

#### Contributions Receivable

Contributions receivables are reported at their outstanding balances net of estimated reserve for doubtful accounts and are primarily composed of balances due from employers. As of date of report, all amounts were deemed collectible.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Since all investments consisted of savings or money market funds, fair value approximates cost.

Interest income is recorded on the accrual basis.

#### Subsequent Events

The Plan has evaluated subsequent events through the date of the independent auditors report, the date the financial statements were available to be issued.

### 3. Authorized Withholdings

Authorized dues assessments totaling \$225,723 in 2025 and \$260,655 in 2024 were withheld from participants' vacation benefit payments and remitted to the Roofers Local #149 Union.

### 5. Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees to the third-party administrator, legal and audit. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

### 6. Tax Status

The Plan received an exemption letter from the Internal Revenue Service stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the IRC.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service, state or local taxing authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Termination of the Plan

Although it has not expressed any intention to do so, the Trustees have the right under the Plan to modify the benefits provided to and contributions required of employers, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and non-discretionary manner towards the provision of benefits for or on account of the participants. No assets of the Plan may revert to the employers or be used for purposes other than for the exclusive benefit of the Plan participants.

### 8. Related Party Transactions

As described in note 5, the Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.
