INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator
of the Awardco, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits for the Financial Statements

We have performed audits of the accompanying financial statements of Awardco, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Awardco, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Awardco, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan documents.

General – The Plan is a defined contribution plan covering substantially all employees of Awardco, Inc. (the "Company", "Plan Sponsor", or "Employer") established August 1, 2020, and is designed to provide eligible participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination, or financial hardship. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act (ERISA) and subsequent laws. The Plan Sponsor is responsible for oversight of the Plan, which includes the appropriateness of the Plan's investment offerings and monitoring of investment performance.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 2.0) was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date these financials were available to be issued.

Plan Administration - The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Employer has delegated certain responsibilities for the operation and administration of the Plan. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the "Custodian" or "Principal") is responsible for the custody and management of the Plan's assets. Principal maintains participant accounts and transactions related to participant-initiated activity.

Eligibility – All employees of the Company are eligible to participate in the Plan upon reaching age 18. Part-time, temporary, or seasonal employees who are regularly scheduled to work less than 1,000 hours of service are not eligible to participate in the Plan. Participants may enter the Plan on the first day of the month coinciding with or following the date the eligibility requirements have been met.

Contributions – Participants may elect to contribute up to 100% of their eligible compensation to the Plan, subject to calendar year contribution limits set forth by the Internal Revenue Code (IRC). Participant contributions may be made on a pre-tax basis or after-tax as Roth contributions. Participants who have attained the age 50 before the end of the plan year are eligible to make catch-up contributions which are also subject to the IRC limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company may elect to make discretionary matching contributions, nonelective contributions, and qualified nonelective contributions at its sole discretion. For the year ended December 31, 2024, the Company made discretionary matching contributions equal to 50% of the first 3% of compensation deferred by each participant to the Plan. No discretionary nonelective or qualified nonelective contributions were approved or made for the year ended December 31, 2024.

Participants' Accounts – Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings or losses.

Plan earnings or losses are allocated based upon each participant's account balance. Participant accounts are charged with an allocation of administrative expenses. Certain fees are charged to the fund investment and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their contributions and Employer contributions into various investment options offered by the Plan.

Vesting – Participants are immediately and fully vested in their contributions, including rollover contributions, and the Company's qualified discretionary nonelective contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and nonelective contributions is based on years of continuous service and a participant is 100% vested after one year of credited service. A participant is 100% vested upon death, disability or attainment of retirement age.

Payment of Benefits – Distributions and withdrawals are payable upon retirement, termination, financial hardship, disability or death. If a participant's account balance is less than or equal to \$7,000 upon termination, their balance will be rolled over to an individual retirement account designated by the administrator if the participant has not requested a lump-sum cash payment or a direct rollover into another qualified benefit plan. If the account balance is over \$7,000, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan or postpone payment to a later date and remain in the Plan as described in the plan documents.

In addition to the foregoing, participants are permitted to request in-service distributions from their vested Plan accounts at any time after having attained age of 59 ½. Participants incurring an immediate and heavy financial need may request a hardship distribution of their Plan accounts subject to certain restrictions as described in the plan documents.

Notes Receivable from Participants – Notes receivable from participants ("participant loans" or "loans") are issued directly from the participant's account balance. Under the terms of the Plan, a participant may borrow from their account a minimum of \$1,000 up to a maximum equal to 50% of their account balance or \$50,000, whichever is less. Notes receivable terms are generally five years or less but may exceed five years if the purpose of the loan is to purchase a principal residence. The notes receivable are secured by the remaining balance in the participant's account and accrue interest at rates established by the Plan Administrator at the time the loan is issued. At December 31, 2024, outstanding notes receivable from participants accrue interest at rates ranging from 9.50% to 10.50% with varying maturity dates through 2029.

Forfeitures – Non-vested balances of participants' accounts may be subject to forfeiture upon termination of their employment with the Company. A forfeiture occurs in the Plan year in which the participant either receives a distribution of their vested account or has five consecutive one-year breaks in service, as defined by the Plan. Forfeitures are retained in the Plan and used either to pay Plan administrative expenses or to reduce future Employer contributions. The forfeited unvested account balance and activity was not significant at December 31, 2024 and 2023 nor for the year ended December 31, 2024.

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right, under terms of the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the individual accounts of all participants shall become fully vested. After deducting all charges and expenses, the balances of all individual accounts will be adjusted and the remaining assets distributed.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 5). The Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and Contribution Receivable - Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Employer, which is the pay date. Employer contributions are recorded in the year earned to coincide with the year in which the Employer records the contributions to its general ledger. The Plan records receivables based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Rollover contributions from participants are recorded based on the date the rollover contributions were received by the Custodian.

Plan Administration Costs – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. Administrative expenses are recorded when incurred.

Payment of Benefits - Benefits are recorded when paid.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Subsequent Events – Management has evaluated, for potential recognition or disclosure in the financial statements, subsequent events that have occurred through December 5, 2025, which is the date that the financial statements were available to be issued. See subsequent events at Note 9.

NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Custodian, determined to be a qualified institution by the plan administrator, has certified to the completeness and accuracy of:

- Investments, at fair value, and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net increase in fair value of investments, dividends and other interest income, and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

Accordingly, as requested by the plan administrator, the Plan's independent auditor performed no procedures on the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

NOTE 4 – TAX STATUS

The Plan has adopted a non-standardized pre-approved profit sharing plan with CODA plan document, sponsored by Principal, that received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the document satisfies the applicable provisions of the IRC, and is appropriate for use by employers for the benefit of their employees. The Plan has been amended since the opinion letter; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

For the Plan year ended December 31, 2022, the Plan administrator determined that certain operational errors existed with respect to the Plan. During the year ending December 31, 2025, the Plan Sponsor quantified and corrected these operational errors in accordance with applicable IRS guidelines in order to maintain the Plan's continued qualified status. Amounts related to this correction are included in Employer contributions receivable in the accompanying statements of net assets as of December 31, 2024 and 2023.

NOTE 5 – FAIR VALUE MEASUREMENTS

Accounting standards establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plans have the ability to access.

See Independent Auditor's Report and Notes to Financial Statements

Level 2 Inputs to the valuation methodology other than quoted prices included in Level 1 are observable for the asset or liability, each directly or indirectly, and include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered investment company funds

Valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment company funds held by the Plan are deemed to be actively traded.

Pooled separate accounts

Pooled separate accounts are not classified in the fair value hierarchy as they are valued using the NAV, as a practical expedient to fair value, based on the value of the underlying assets owned by the fund less its liabilities, and this difference is then divided by the number of units outstanding. The unit price of the investments is quoted on a private market that is not active; however, the unit price is based on underlying investments which are based on observable inputs. There were no unfunded commitments for the periods presented and no redemption restrictions on these investments.

Collective trust:

The Morley Stable Value Fund (the "Fund") is a collective trust administered by the Custodian. The Fund is valued at the NAV of units of a collective investment trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the Fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The objective of the Fund is to preserve principal and maintain a stable crediting rate that is responsive to changes in interest rate. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The NAV is not a publicly quoted price in an active market.

NOTE 6 –RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines party-in-interest similarly to the definition of a related party in financial accounting standards, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be party-in-interest. The Plan did not enter into any material related party transactions during the Plan year related to compensation arrangements, expense allowances, or similar items.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer or relatives of such persons, and an employee organization whose members are covered by the Plan.

Transactions conducted by the Custodian and its affiliates and the Company, on behalf of the Plan, qualify as party-in-interest transactions. Also, the Plan Sponsor pays certain fees on behalf of the Plan.

Certain fund level fees incurred by the funds in which the Plan invests for such services as investment management and shareholder services are paid through fund level revenue sharing arrangements. These fees reduce fund earnings, thereby impacting Plan revenue applied to participants' accounts.

The Custodian retains as compensation, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.

NOTE 8 – DELINQUENT PARTICIPANT CONTRIBUTIONS

The Company has failed to remit certain employee contributions to the Plan within the period prescribed by Department of Labor regulations. Delays in remitting contributions were due to administrative errors. The delayed contributions are considered prohibited, or nonexempt, transactions. During 2025, the Plan administrator took corrective action on late remittances from the year ended December 31, 2022, including payment of lost interest and related taxes and penalties, and is in the process of correcting remaining late remittances in order to maintain its qualified tax status.

NOTE 9 – SUBSEQUENT EVENTS

Effective January 1, 2025, the plan was amended and restated to modify Plan entry provisions for new employees to require 30 days of service and to allow for immediate entry into the Plan on the date the eligibility requirements have been met. Additionally, a Qualified Automatic Contribution Arrangement (QACA) provision was added whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of annual eligible Plan compensation, as defined, with automatic increases of 1% each year, up to a maximum deferral rate of 10%. As amended, the Company will make safe harbor matching contributions equal to 100% of the first 1% of compensation deferred by each participant to the Plan and 50% of the next 5% of compensation deferred. Additionally, discretionary matching and nonelective contributions are no longer permitted.
