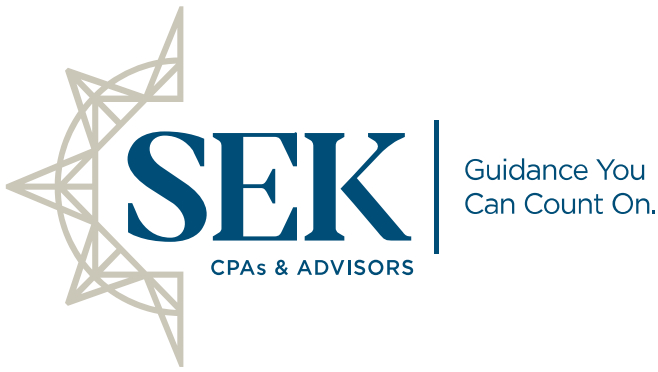

INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the accompanying financial statements of D. L. Martin Co. Group Medical Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of D. L. Martin Co. Group Medical Plan as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of D. L. Martin Co. Group Medical Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about D. L. Martin Co. Group Medical Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to Financial Statements

NOTE 1 PLAN DESCRIPTION

The following description of the D. L. Martin Co. Group Medical Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan provides health benefits covering eligible employees and covered dependents of D. L. Martin Co. (the "Company" or "Employer"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company established a trust on January 1, 2024, to fund the Plan and continue benefits previously provided directly by the Company. The Plan provides self-insured (subject to stop-loss) health benefits.

Effective January 1, 2025, the Plan switched their funding option to "Pay-As-You-Go", where claim payments for health benefits are paid directly by the Company to the third-party administrator rather than through the trust. The final surplus distribution out of the trust was initiated on July 15, 2025, and the trust account was closed thereafter.

Plan Administration

The Plan operates as part of the Veris Benefits Consortium, LLC (Consortium), which is a group of companies that have partnered together in efforts of obtaining more preferential treatment and insurance rates than the companies could have acquired individually. The Company entered into an agreement with the Consortium whereby the manager of the Consortium will perform administrative services on behalf of the Plan including development of the program with respect to eligibility and underwriting standards, placing stop-loss insurance, coordination of regulatory compliance and document preparation.

The Company also entered into an agreement with an insurance provider to administer the health benefits under the Plan in accordance with its policies and procedures. The insurance provider invoices the Plan for claims paid on a weekly basis.

The third-party administrators charge an administrative fee related to the services performed, of which certain administrative expense is paid from the Plan's trust account. The Plan's other administrative expenses are paid either directly by the Company or by the Plan. These third-party administrators are considered parties-in-interest under ERISA.

Benefits

The Plan provides health (medical and prescription) benefits to covered persons who are employees of the Company.

The eligibility period for all full-time employees (defined as working at least 30 hours per week) is 60 days. The waiting period is waived for employees transferring from a part-time or temporary position to a full-time position. Spouses and dependents of the full-time employees are also eligible for coverage.

Coverage will begin on the first day of the month coinciding with or following the first day that all eligibility requirements are met.

Notes to Financial Statements

NOTE 1 PLAN DESCRIPTION (CONTINUED)

Self-Insured Benefits

The health benefits are self-insured by the Company. The claims for this self-insured benefit are processed by a third-party administrator. The third-party administrator pays claims directly to, or on behalf of, the participants. The payments for these claims are paid from the Plan's trust, which is funded by both Company and employee contributions. Despite the Plan's utilization of third-party administrators for claims processing, the ultimate responsibility for payments to providers and participants is retained by the Plan.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for health benefits (individual participant claims over a specific dollar amount), as well as its aggregate exposure for all claims. The Plan's stop-loss coverage amount was \$ 100,000 per individual and provided coverage up to a maximum of \$ 1,000,000 for the year ended December 31, 2024.

Stop-loss reimbursements of \$ 521,469 are netted against claims paid for the year ended December 31, 2024.

Contributions

Participants are required to contribute to the Plan to fund a portion of the cost of their health benefits. Amounts required to be contributed by participants are determined annually in accordance with the Plan document. The remainder of the funding required to pay benefits, stop-loss insurance, and cover expenses under the Plan is paid by the Company.

The Company funds the health benefits through the use of a trust established by the Consortium for the Plan. Monthly contributions are made to the trust in an amount sufficient to cover expected claims, stop-loss insurance, and administrative expenses of the Plan.

COBRA

The Plan offers continuation of benefits under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) for a specified period of time to qualified employees and their dependents who would not otherwise be eligible for continued coverage because of a particular qualifying event. Each qualifying individual pays their premium directly to a third-party COBRA administrator. The premium collected is then paid to the Company. Separate third-party administrators process claims and other expenses. The Company and the Plan retain the risk for self-insured health claims.

Plan Termination and Modification

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, the Company must pay the claims incurred and expenses of the Plan due up to the date of termination, plus extended benefits, if any, provided under the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting and in accordance with the accounting principles generally accepted in the United States of America (U.S. GAAP).

Interest-Bearing Cash

The Plan's interest-bearing cash was held in a commercial performance checking account as of December 31, 2024.

Claims Payable

Claims payable represent the amount of benefit claims incurred, paid by the claims processor, and reported to the Plan by the end of the year.

Claims Incurred but Not Reported

Claims incurred but not reported are the estimated claims, which have service dates prior to year-end, but are reported to the Plan subsequent to year-end. Those amounts are estimated based on actual claims experience. See Note 3 for benefit obligations.

The Plan had no accumulated eligibility credits or postretirement benefit obligations.

Payment of Benefits

Claim payments for health benefits are recorded when paid by the third-party administrator.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those amounts. Significant estimates used in the preparation of these financial statements relate to claims payable and currently due and claims incurred but not reported to the Plan.

Plan obligations at December 31, 2024 for claims incurred by participants but not reported at that date are measured by the Plan's actuary at the estimated ultimate cost to the Plan of settling the claims. Estimated ultimate cost reflects the Plan's obligation to pay claims to or for participants, regardless of status of employment beyond December 31, 2024, pursuant to the provisions of the Plan. The method used to derive the estimated unpaid claims liability applies the reserve factor to a monthly average of the past several months of health claims, which is then adjusted as needed based on actual subsequent period claims paid.

The Plan does not offer postemployment benefits, and thus, they are not included in the above calculations.

NOTE 5 RISKS AND UNCERTAINTIES

Plan assets include interest-bearing cash, which is held at a bank insured by the Federal Deposit Insurance Corporation (FDIC) up to \$ 250,000. The Plan may have deposits from time to time which exceed the maximum amount insured by the FDIC.

The actuarial value of benefit obligations is computed as described in Note 3. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term could be material to the financial statements.

NOTE 6 TAX STATUS

The Plan is intended to qualify as an employee welfare benefit plan as defined in ERISA. The Plan benefits are funded by both Company and participant contributions.

The trust established under the Plan to hold the Plan's assets is a taxable trust, under Internal Revenue Code (IRC) 419. The trust files Form 1041 U.S. Income Tax Return for Estates and Trusts. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, generally for a period of three years after the returns are filed; however, there are currently no audits for any tax periods in progress.

NOTE 7 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan engages third parties to perform administrative functions and process claims. Fees paid by the Plan for these services are included in administrative expenses on the statement of changes in net assets available for benefits.

During 2024, the Plan made a direct payment for administrative services to Capital Blue Cross of \$ 47,124. The Plan also made direct payments to Brown & Brown totaling \$ 41,580 for broker services, to The Benecon Group totaling \$ 22,467 for broker and management services, and to ConnectCare3 totaling \$ 7,789 for patient advocacy services. The Plan Sponsor pays directly any other fees related to the Plan's operations.

NOTE 8 SUBSEQUENT EVENTS

The Plan has evaluated events and transactions subsequent to December 31, 2024 through December 5, 2025, the date these financial statements were available to be issued. Based on the definitions and requirements of U.S. GAAP, we have not identified any events that have occurred subsequent to December 31, 2024 and through December 5, 2025, which require recognition or additional disclosure in the financial statements, except as noted in Note 1.
