I am writing to request penalty abatement for the late filing of Form 5500 for the tax year 2022 and 2024. Here is a succinct summary of the issue. Grand Tours, Inc. had a misunderstanding with ADP regarding who was filing the 5500 since the program was new to us in 2022.

We have remedied that for all future filings. The first written notification of a penalty came on November 24, 2025 so we are working to resolve it quickly. We relied on our pension benefits provider to take care of the filing. Unfortunately, we did not realize we did not complete the process with the return they provided. I have a history of compliance and have always filed in a timely manner.
