**1. Description of Plan**

The following description of the Mastek, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan covering substantially all employees of Mastek, Inc. (formerly known as Digility, Inc.) (the "Company/ Plan Sponsor/ Employer"). The Plan is a qualified salary deferral plan under the provisions of the Internal Revenue Code ("IRC") sections 401(a) and 401(k). The Plan is subject to the applicable regulations of the Employee Retirement Income Security Act of 1974 ("ERISA") and the IRC.

During the year ended December 31, 2022, Evolutionary Systems Corp became a participating employer in the Plan. During the year ended December 31, 2024, BizAnalytica LLC became participating employer in the Plan.

Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively referred as Empower) are responsible for the oversight and fiduciary management of the Plan, serving as its designated trustees.

*Contributions*

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the IRC. Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company will make a safe harbor matching contribution equal to 100% on the first 3% of eligible earnings that are deferred as an elective deferral and an additional 50% on the next 3% of eligible earnings but do not exceed 5% of eligible earnings. Participants must make elective deferrals in order to receive the safe harbor matching contributions. Safe harbor matching contributions will be made each pay period.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

*Participant accounts*

Each participant's account is credited with the participant's contributions, safe harbor match, and an allocation of the Plan's earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are vested immediately in their contributions and the Company's contributions plus actual earnings thereon.

*Notes receivable from participants*

Participants may borrow from their fund accounts a minimum of \$1000 up to a maximum equal to the lesser of \$50,000 or 50% percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to Five years or greater for the purchase of a primary residence.

*Payment of benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum distributions. In addition, the Plan allows for hardship distributions if certain criteria are met. As of December 31, 2024 and December 31, 2023, there were no amounts allocated to participants but unpaid.

*Forfeited accounts*

Participants who terminate employment before they are fully vested forfeit all rights to any non-vested portion of their account. Forfeitures of terminated employees' non-vested accounts are used to pay Plan expenses or to reduce employer contributions, as defined in the Plan agreement. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$14,722 and \$10,680, respectively which includes adjustments for earnings and losses, amounting to \$177 and \$72 for the years ended December 31, 2024, and December 31, 2023, respectively. Forfeitures of terminated employees' nonvested accounts totaled \$3,865 during the year 2024 and \$6,855 during the year 2023. During 2024, no amounts were applied to plan activities from forfeited nonvested accounts. During the 2023, \$468 was utilized for fees.

**2. Summary of Accounting Policies**

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

The Plan's investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

*Payment of Benefits*

Benefits are recorded when paid.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

*Subsequent Events*

The Plan evaluated all events and transactions that occurred after December 31, 2024, through the date the financial statements were available to be issued. Based on the evaluation, the Plan is not aware of any events or transactions that would require recognition or disclosure in the financial statements.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and December 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Fully benefit responsive investment contracts:* Fully benefit responsive investment contracts which are valued at Contract value . Contract value represents the aggregation of contributions, plus interest, less withdrawals, if any.

**5. Fully Benefit-Responsive Investment Contracts**

The Plan holds a traditional fully benefit-responsive guaranteed investment contract, for which contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the sponsoring trustee, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.45 percent for year ended December 31, 2024, and 1.30 percent for year ended December 31, 2023. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. The actual average yield earned by the plan for the benefit responsive fund for 2024 is 1.41 percent and for 2023 is 1.23 percent.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory

developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include:

1. amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
2. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or,
5. premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

1. an uncured violation of the Plan's investment guidelines;
2. a breach of material obligation under the contract;
3. a material misrepresentation; or,
4. a material amendment to the agreement without the consent of the issuer.

## **6. Information Certified by Trustees**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Trustees of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and December 31, 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 and December 31, 2023.

**7. Transfer of assets into the Plan**

During the year ended December 31, 2024, BizAnalytica LLC became a participating employer in the Plan as a result of its acquisition by the Company during the year ended December 31, 2023. During the year ended December 2024, assets amounting to \$794,170 (December 31, 2023: \$NIL), representing the account balances of 26 participants, were transferred to the Plan from the BizAnalytica LLC 401(k) Profit Sharing Plan & Trust.

**8. Related-Party and Party In Interest Transactions**

Certain Plan investments are managed by the Trustees, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**10. Tax Status**

The Plan adopted a pre-approved plan offered by CCH Incorporated DBA FTWilliam.Com ("CCH"). The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**11. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**12. Delinquent Participant Contributions**

For the years ended December 31, 2024 and December 31, 2023, the Company did not remit certain participant contributions including loan repayments to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Company corrected Plan years 2024 and 2023 delinquent contributions by calculating and remitting lost earnings to the affected participant accounts to compensate those participants.

**14. Correction of Deferral Election Error**

During the Plan year 2024, the Company identified an operational error in which certain participants' elective deferral contributions were not withheld in accordance with their elected deferral rates. This resulted in a failure to implement participant deferral elections in accordance with Plan provisions.

To correct this error, the Company is following the Employee Plans Compliance Resolution System (EPCRS), a program established by the IRS that allows Plan sponsors to correct Plan failures and maintain the Plan's tax-qualified status. As a part of the correction process, the Company remitted Qualified Non-elective Contributions (QNEC) and Qualified Matching Contributions (QMAC) of \$481 and \$517, respectively.

All corrective contributions will be fully vested and subject to the same distribution restrictions as elective deferrals. These amounts are currently recorded as employer contributions receivable in the financial statements and were contributed to the Plan during Plan year 2025.

The Plan Sponsor remains committed to maintaining compliance with IRS regulations and ensuring participants are restored to the financial position they would have been in had the error not occurred.
