As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Center for Reproductive Rights Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan, which became effective February 1, 1994, is a contributory defined contribution plan covering all eligible employees of The Center for Reproductive Rights, Inc. (the "Organization" or the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligibility

The Plan covers substantially all the employees of the Employer as defined in the plan document. For purposes of salary deferral, employees are eligible upon hire. For purposes of Employer contributions, an employee becomes eligible upon completion of 1 year of service.

Contributions

Each year, eligible employees may elect to contribute to the Plan a portion of their pre-tax annual compensation subject to a maximum annual dollar limit as defined by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make Roth contributions. Participants may also include, as rollover contributions, those distributions they may receive from other qualified defined benefit or defined-contribution plans from prior employers.

The Employer will make a fully vested safe-harbor contribution to eligible employee's account in the amount of 3.5% of eligible compensation. This contribution is intended to satisfy a safe harbor contribution formula permitted by the Internal Revenue Code ("IRC"). The Organization may, at its discretion, make a fully vested qualified nonelective employer contribution on behalf of eligible participants. For the year 2024, qualified nonelective employer contribution was made in the amount of 4% of eligible compensation. All employees are eligible to receive the safe-harbor matching contribution and qualified nonelective Employer contribution on the first day of the month following one year of employment with the Organization.

Vesting

A participant is 100% vested in their employee and Employer contributions including allocated earnings thereon at all times.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan *(continued)*

Payment of Benefits

Upon termination of service, a participant's balance will be paid in a lump sum payment. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. In-service distributions are available for participants that have reached age 59 ½. Participants have the ability to take their distributions in the form of a lump sum distribution, installment payments or an annuity distribution. No minimum distribution amount is required as per the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested balance. The interest rate will be based on the rates available for similar loans from commercial lending institutions. Participants may only have one outstanding loan at a time. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence, or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All the Plan's investments are stated at fair value except the investment in the group annuity contract, which is valued at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

2. Summary of Significant Accounting Policies *(continued)*

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded, when a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses are paid for by the Organization, except for loan issuance fees and distribution fees, which are paid by the Plan. Fees paid by the Organization are excluded from these financial statements. Fees paid to Principal for investment management services on the mutual funds were recorded as a reduction of the investment income on the statements of changes in net assets available for benefits.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is December 2, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividend income and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

4. Group Annuity Contract

The Principal Fixed Income Guaranteed Option (the “PFIGO”) is a guaranteed general account backed group annuity contract issued by Principal Life Insurance Company. The PFIGO guarantees principal and provides a stated crediting rate backed by Principal Life Insurance Company. Because the PFIGO is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the PFIGO. Contract value represents contributions, plus earnings, less participant withdrawals, and administrative expenses.

A rate of interest is contractually guaranteed by Principal Life Insurance Company and is credited to participant’s account balances. The rate is reset on a semiannual basis.

Benefit payments are made at contract value (i.e., no market value adjustments or surrender charge adjustments) for plan benefit events including: retirement, death, disability, termination of employment, loans, withdrawals, or Plan termination. An employer level liquidation or employer initiated transfer of the Plan’s interest in the PFIGO will be subject to either a 12-month advance notice or a 5% surrender charge, whichever the Employer chooses. Notification of a Plan’s intent to terminate its interest may be revoked within 90 days of the receipt of such notice, after which time, the notice becomes irrevocable. A 5% surrender charge will also apply if the cumulative percentage of participant transfers from the PFIGO exceeds 20% of the Plan’s interest in the contract during the 12-month period immediately preceding the employer-level surrender of the Plan’s interest in the contract. If this scenario occurs, the surrender charge will be billed to the Employer. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The credit risk of the issuer, Principal Life Insurance Company, was evaluated by nationally recognized statistical rating agencies as follows: Moody’s Investors Service (A1 as of June 2025), S&P Global (A+ as of April 2025), A.M. Best Company (A+ as of April 2025), and Fitch Ratings (AA- as of May 2025).

5. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. Tax Status

The Plan was formed using a prototype plan which the Internal Revenue Service (“IRS”) has determined and informed the applicant by letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Plan management believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest Transactions

Certain Plan investments are managed by Principal. Any purchases and sales of these funds are performed in the open market at fair value and qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Notes receivable from participants also qualify as party-in-interest transactions.

8. Non-Exempt Party-in-Interest Transactions

During the 2024 plan year, the Employer failed to transmit to the Plan contributions for participants totaling \$77,827 within the period prescribed by Department of Labor regulations. The Employer is in the process of making the necessary corrections.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Auditors' Communication of Internal Control

The Plan Administrator Center for Reproductive Rights Retirement Plan

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Center for Reproductive Rights Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Principal Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.

Our consideration of internal control was for the limited purpose described in the two paragraphs above and was not designed to identify all deficiencies in internal control that might be material weaknesses. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified. As indicated in the attached addendum, we identified a matter for consideration that is an opportunity for strengthening internal controls and operating efficiency.

Addendum to Report on Internal Control Related Matters Matter for Consideration that is an Opportunity for Strengthening Internal Controls and Operating Efficiency

A. Employer Contribution Rate

During our audit, we noted as per the Plan document employer contribution is made at an amount equal to safe harbor QNEC at 3% whereas, the company made discretionary employer contribution during the year in an amount equal to a 4% and safe harbor QNEC of 3.5% of participant's contribution. Based on further discussion with client, we noted the employer always intended to make the discretionary employer contribution at 7.5%. We further noted that the eligibility criteria and forfeiture conditions are the same for safe harbor QNEC and discretionary employer contribution per the Plan document. The contribution is paid uniformly to all the eligible participants.

Recommendation

We recommend that the plan documents are revised to align with how the employer contribution is being made to the participants.

B. Employer Contribution Eligibility

During our audit, on review of employer contribution eligibility, we noted that the Plan's operational practice is not fully aligned with the provisions outlined in the adoption agreement. The adoption agreement specifies that participants become eligible to receive employer contributions upon completion of 12 months of service from their entry date, with the entry date being immediate upon meeting the eligibility criteria. However, in practice, the Plan applies the entry date as the first day of the month following the date the eligibility requirements are met, resulting in a delay in the commencement of employer contributions.

Recommendation

We recommend that the plan documents are revised to align to ensure timely employer contributions.

Auditors' Communication with Those Charged with Governance

We have audited the financial statements of Center for Reproductive Rights Retirement (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) as of and for the year ended December 31, 2024, and we issued our report thereon dated December 2, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Principal Trust Company which is bank or similar institution or insurance carriers that are regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America ("U.S. GAAP"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated July 18, 2024. Professional standards also require that we communicate to you the following information related to our audit.

Qualitative aspects of significant accounting practices

Significant accounting policies

Plan management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Significant accounting estimates

Accounting estimates made by the Plan's management are an integral part of the financial statements and are based on Plan management's knowledge and experience about past and current events and assumptions about future events.

Certain accounting estimates are particularly sensitive because of their significance to financial statements and their susceptibility to change. The Plan's management believes that the estimates used and assumptions made are adequate based on the information currently available. We evaluated the key factors and assumptions used to develop the estimates in relation to the value of the Plan's investments in determining that they are reasonable in relation to the financial statements as a whole.

Financial statement disclosures

The financial statement disclosures are neutral, consistent and clear.

Going concern

We concur with management's assessment that the Plan will continue as a going concern for one year from the auditors' report date.

Significant risks

We have identified the following significant risks in connection with our audit:

- Revenue recognition; and
- Plan management override of controls.

Form 5500 procedures

We are required to obtain and read a substantially completed draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties encountered during the audit

We encountered no significant difficulties in performing and completing our audit.

Corrected and uncorrected misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. No misstatements were identified during our audit.

Disagreements with management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

Representations requested from Plan management

We have requested certain written representations from the Plan's management in a separate letter dated December 2, 2025.

Management consultations with other independent accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other matters discussed with Plan management

We generally discuss with the Plan's management a variety of matters, including the application of accounting principles and auditing standards, business conditions affecting the Plan, and future plans and strategies that may affect the risks of material misstatement. None of the matters discussed and our responses thereto were a condition to our retention as auditors.

Other matters supplemental schedules

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, are presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).
