1. Description of Plan

The following brief description of the Dorsey & Whitney 401(k) Retirement & Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

General

The Plan is a contributory defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and the Internal Revenue Code ("IRC"). The plan sponsor, administrator, and employer is Dorsey & Whitney LLP (the "Employer," "Plan Sponsor" or "Plan Administrator"). Dorsey & Whitney Trust Company and Vanguard Fiduciary Trust Company are referred to collectively as the Trustees.

Eligibility

Substantially all employees and partners of the Employer who have reached 21 years of age and are scheduled to work at least 1,000 hours during the calendar year are eligible to participate in the Plan. Eligible employees and partners may enter the Plan on their date of hire if eligibility requirements are met, or on the date when the eligibility requirements are met as defined by the Plan. Employees who become eligible to participate in the Plan and fail to enroll themselves in the Plan within 45 days of their hire date shall be automatically enrolled to defer 6% of their eligible compensation into the Vanguard Target Retirement date fund that most closely approximates the participant's anticipated retirement date. Participants may also elect not to participate in the Plan and will not be automatically enrolled. The deferral percentage of each participant who is automatically enrolled will be automatically increased by one percent on the anniversary of the date the participant was automatically enrolled in the Plan, up to a maximum of 15%. Participants automatically enrolled may specify a different contribution percentage at their option.

For the integrated Employer contribution portion of the Plan, substantially all employees and partners of the Employer who have reached 21 years of age, completed one year of service, and been credited with at least 1,000 hours of service, and have not been employed as associates by the Employer during the calendar year are eligible. Eligible employees and partners are eligible to participate in this portion of the Plan on the date that is the earlier of the January 1 after the date upon which the eligibility requirements are met or the first day of the last calendar month that is not more than six months after the date upon which the eligibility requirements are met.

Contributions

Participants may contribute up to 75 percent of their annual earnings to the Plan, subject to IRC limitations. Participants may roll over amounts representing distributions from other qualified plans into the Plan.

For the integrated employer contribution portion of the Plan, the Employer, at its discretion, may annually contribute a percentage of each participant's pre-tax annual base compensation. For 2024 and 2023, the Employer contributed 7.5 percent of each participant's annual pre-tax compensation. Partners over the age of 40 receive an additional 5.83 and 5.68 percent of their compensation for 2024 and 2023, respectively. Contributions are subject to a compensation ceiling and annual limitations prescribed by the IRC.

1. Description of Plan (Continued)

Participant Accounts

Participants may direct and redirect their account balance and their contributions into various mutual fund and collective fund options offered by the Plan. In addition, the Plan offers self-directed accounts that allow participants to invest in any investment desired, within certain limitations. Investments in the self-directed accounts primarily consist of stocks, bonds, mutual funds, insurance policies, and partnership interests.

The allocation of account balances and contributions to these investment funds is determined at the participant's discretion and may be changed by the participant on a daily basis. Each participant's account is credited with the participant's contributions, rollover contributions, integrated Employer contributions, and allocations of additional Employer discretionary contributions, if any, and investment earnings or losses. Additional Employer discretionary contributions are allocated to the participant accounts based on the participant's total compensation.

All investment earnings and losses, except for those on the self-directed accounts, are allocated to the participant accounts in the proportion that each participant's account balance bears to the total of all participant accounts by fund. Earnings and losses on the self-directed accounts are allocated directly to the participant's account balance.

Vesting

Participants are 100 percent vested in their voluntary contributions plus actual earnings thereon. Participants vest in Employer contributions upon completion of their third year of service, at which point the participant is 100 percent vested in all allocated Employer contributions and related investment earnings thereon.

Forfeited Accounts

If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance is used to reduce future Employer contributions to the Plan. Forfeited amounts that were used to reduce Employer contributions to the Plan totaled approximately \$293,000 for 2024. Unallocated forfeited amounts in the Plan totaled approximately \$1,000 and \$29,000 at December 31, 2024 and 2023, respectively.

Notes Receivable From Participants

Participants are permitted to borrow up to 50 percent of their vested account balance with a maximum loan amount of \$50,000. Loans must be repaid in monthly installments of principal and interest, at one percent over the prime rate, not to exceed five years unless the loan is used to acquire a principal residence; then it is not to exceed ten years. Interest rates at December 31, 2024 and 2023 range from 4.25 percent to 9.50 percent. Notes receivable from participants are valued at their unpaid principal balance plus accrued interest.

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Certain mandatory distribution provisions may apply for smaller account balances of terminated employees.

2. Summary of Significant Accounting Policies

The following significant accounting policies were used to prepare the financial statements in conformity with accounting principles generally accepted in the United States of America.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, with the exception of select common collective trusts and life insurance policies. Shares of mutual funds and money market funds are valued at the net asset value of shares held by the Plan at year end using quoted market prices. The investments in common collective trust funds are stated at contract or fair value based on information provided on the investments. Corporate and government bonds are valued at quoted market prices. Corporate stock and public partnerships are stated at quoted market prices. Insurance policies are recorded at the cash surrender value of the policy determined annually by the insurer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year as well as unrealized gains and losses on investments held during the year are presented in the net appreciation or depreciation in fair value of investments.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Benefit Payments

Benefit payments are recorded when paid.

Use of Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates, and those results could be material.

Fair Value of Financial Instruments

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Subsequent Events

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through November 21, 2025, the date which the financial statements were available to be issued.

3. Investments and Limitation on Scope

At December 31, 2024 and 2023, the Plan's investments were held by Dorsey & Whitney Trust Company and Vanguard Fiduciary Trust Company (the Trustees). Participants in the Plan direct the Trustees as to the investment of their individual account balance.

The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(c), pursuant to 29 CFR Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed its independent auditors not to perform, and they did not perform, any auditing procedures with respect to the following information certified by the Trustees as complete and accurate, except for comparing the information with the related information included in the financial statements and supplemental schedule. At December 31, 2024 and 2023, the Trustees certified all investments, life insurance policies, and participant loan balances. For the year ended December 31, 2024, the Trustees certified all investment income and participant loan interest.

5. Fully Benefit Responsive Contract

The Plan provides a stable value investment option issued by Vanguard Fiduciary Trust Company that simulates the performance of a guaranteed investment contract. Vanguard Fiduciary Trust Company maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Vanguard Fiduciary Trust Company represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

6. Plan Termination

Although the Plan Administrator has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their Employer contributions, and the Plan assets will be distributed according to the provisions of the Plan documents.

7. Tax Status

The Plan obtained its latest determination letter on November 1, 2013, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has since been amended; however, the Plan Administrator believes the Plan, as amended, is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

8. Party-In-Interest Transactions

During the year, certain Plan investments are shares of mutual funds and collective trust funds managed by the Trustees; therefore, these are party-in-interest transactions. All investment transactions of the Plan are executed based upon the participant's direction. Total administrative fees paid to the Trustees were approximately \$74,000 for the year ended December 31, 2024.

9. Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will continue to occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.
