## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of  
Centered Health, LLC Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Centered Health, LLC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note C to the Financial Statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the Financial Statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.



### NOTES TO FINANCIAL STATEMENTS

December 31, 2022 and 2021

#### NOTE A--DESCRIPTION OF PLAN

The following description of the Centered Health, LLC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan which was created in 2021, effective January 1, 2021, covering substantially all employees of Centered Health, LLC; Bailard House, LLC; Marks House, LLC; Hills Rehab, LLC; The Meadowglade, LLC; and Los Angeles Outpatient Center, LLC, (collectively the "Companies", "Employers" or "Plan Sponsors"). Employees of these Companies who are eligible to participate must complete 83.3 hours of service during the first month or one year of service and not be excluded under the terms of the Plan Document. A year of service is a service period in which an eligible employee has at least 1,000 hours of service. There is no minimum age restriction to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Companies have elected a 401(k) Safe Harbor Plan on qualifying matching contributions.

Although the Plan was effective January 1, 2021, the contributions to the Plan began in September 2021.

Elective Deferrals and Contributions: Each year, participants may elect to have the Companies contribute a portion of their total eligible annual compensation to the Plan ("elective deferrals"). For any calendar year, a participant's elective deferrals may not exceed a specific dollar amount [\$20,500 in 2022 and \$19,500 in 2021 and if over 50 years of age, the participant may contribute an additional \$6,500 in 2022 and 2021 as determined by the Internal Revenue Service ("IRS")]. Under provisions of the Plan Document, the Companies may make discretionary matching contributions which the participants will be eligible for if they are an employee as of the last day of the calendar year. The Companies may also make qualified non-elective contributions ("QNECs"). The Plan is a safe harbor 401(k) plan which matching contributions are made, per pay period, and are equal to 100% of participant salary deferrals that do not exceed 3% of their compensation, as defined by the Plan, plus 50% of participant salary deferrals between 3% and 5% of their compensation. For the years ended December 31, 2022, and 2021, no discretionary contributions were made by the Plan Sponsors. For the year ended December 31, 2021, the Plan Sponsors had QNEC contributions of approximately \$1,900. No QNEC contributions were made by the Plan Sponsors for the year ended December 31, 2022.

NOTE A--DESCRIPTION OF PLAN--Continued

Participant Accounts: Each participant's account is credited with the participant's elective deferrals and allocations of safe harbor matching contributions and Plan earnings and losses and charged with an allocation of administrative expenses if the expenses are not paid by the Companies. Allocations are based on participant earnings or account balances, as defined by the Plan document. Safe harbor matching contributions and discretionary employer contributions are allocated based on participant contributions and participant compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All Plan investments are participant directed.

Investment Options: Upon enrollment in the Plan, a participant may direct elective deferrals and safe harbor matching contributions in any of the investment options offered by the Plan. Participants may change their investment options at their discretion. As of December 31, 2022 and 2021, the Plan offers investments in collective investment trusts and pooled separate accounts. As of December 31, 2021, the Plan offered investments at contract value.

Vesting: Participants' contributions, matching contributions and rollover contributions plus actual earnings are 100% vested immediately. Discretionary employer contributions are subject to the following vesting schedule:

Participants are considered fully vested upon normal retirement (65 years of age), death, total and permanent disability, or termination of the Plan.

Notes Receivable from Participants: Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 0-5 years. If the purpose of the loan is to acquire or construct the primary residence of the Participant, the period of repayment may exceed five years, but may not be greater than 15 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the loan is approved.

#### NOTE A--DESCRIPTION OF PLAN--Continued

Notes Receivable from Participants--Continued: Interest rates on notes receivable from participants outstanding at December 31, 2022 range from 3.50% to 7.00%. There were no outstanding notes receivable from participants at December 31, 2021. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits On termination of service due to death, disability or retirement, a participant or their beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment payments over a specified period of time, not to exceed the participant's life expectancy or the joint life expectancy of the participant and the participant's beneficiary. The normal retirement age is 65 years. Once a participant reaches the age of 72 years, annual required minimum distributions must be taken. A participant may also receive a distribution if they experience undue financial hardship as further defined in the Plan agreement and in accordance with the Internal Revenue Code ("IRC").

Forfeited Accounts: Forfeitures are created when participants terminate employment prior to becoming entitled to full benefits. Forfeitures of non-vested employer discretionary contributions can be used by the Companies to reduce future employer matching contributions and pay Plan expenses. There were no forfeitures for the years ended December 31, 2022 and 2021.

Expenses Paid by the Companies: Administrative Plan related expenses, such as professional fees, amounting to approximately \$33,000 and \$25,000 were incurred by the Plan in 2022 and 2021, respectively, and paid by the Companies on behalf of the Plan.

Plan Termination: Although they had not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates: The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions. Significant estimates include the determination of fair value of certain investments of the Plan. Actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee of the Plan. See Note D for discussion of fair value measurements. Investments reported at contract value were not significant to these financial statements.

Purchases and sales of securities are recorded on a trade-date basis. Investment earnings or losses and interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation in fair value of investments includes the Plan's net gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees for the administration of loans are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Companies as disclosed in Note A and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to participant's accounts and are included in administrative expenses. Investment related expenses are included in net (depreciation) appreciation in fair value of investments. Certain investment advisory and management fees are included in administrative expenses on the accompanying statements of changes in net assets available for benefits.

Risks and Uncertainties: The Plan provides for investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits.

Subsequent Events: The Plan's management has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through March 28, 2025, the date the financial statements were available to be issued.

#### NOTE C--INFORMATION CERTIFIED BY THE TRUSTEE

Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments from participants held at December 31, 2022 and 2021, and net (depreciation) appreciation in fair value of investments for the years ended December 31, 2022 and 2021, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Life Insurance Company, Principal Life Insurance Company on behalf of Principal Global Investors Trust Company, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (collectively, the "Custodian" of the Plan or "Principal").

#### NOTE D--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy in accordance with GAAP are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2022 and 2021. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Pooled Separate Accounts: These are investment units held through sub-accounts of an insurance company. Fair value has been estimated using the net asset value ("NAV") per share. The NAV of these accounts is based on the market value of its underlying investments. The NAV of these accounts is not a publicly quoted price in an active market.

Collective Investment Trusts: Collective Investment Trusts ("CITs") invest in a collective trust fund as well as a variety of separate accounts and mutual funds. The fair value of the CITs and the separate accounts are not publicly quoted pricing inputs. The fair value of mutual funds are publicly quoted using Level 1 inputs. The fair value of all these investments are used in determining the NAV of the CITs, which are not publicly quoted. The carrying amount of financial assets not measured at fair value on a recurring basis, including employer and employee contributions receivable, approximates their fair value.

These investment options often carry more risk than U.S. equity investment options but may have the potential for higher returns.
- (d) This category is generally comprised of a combination of fixed income and equity investment options. These investment options may include balanced, asset allocation, target-date, and target-risk investment options.
- (e) This category seeks to provide a high level of current income consistent with preservation of capital. It invests primarily in a diversified pool of investment-grade fixed-income securities, including corporate securities, U.S. government securities, asset-backed securities and mortgage-backed securities. The investment allows one transfer per 30-day period.

#### NOTE F--PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of pooled separate accounts and collective investment trusts managed by Principal. Principal is the custodian as defined by the Plan document and, therefore, these transactions qualify as party-in-interest transactions. Plan Design Consultants, Inc. provides third-party administrator services to the Plan; therefore, transactions with Plan Design Consultants, Inc. qualify as party-in-interest transactions. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of related party transactions under ERISA and applicable exemptions promulgated thereunder. Fees incurred by the Plan for investment management services are included in net (depreciation) appreciation in the fair value of investments. As described in Note B, the Plan makes direct payments to Principal for certain administrative expenses.

#### NOTE G--TAX STATUS

The Plan is a pre-approved profit-sharing plan that received an IRS determination letter dated June 30, 2020, for such prototype plan and related trust, as then designed, was in compliance with applicable sections of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore, the Plan is qualified and is tax-exempt.

GAAP requires Plan Management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the Plan's financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's tax returns for the year ended December 31, 2022 and 2021 remain subject to examination.

NOTE H--CONCENTRATIONS

At December 31, 2022, approximately 48% of the Plan's investments were invested in three investment options. At December 31, 2021, approximately 54% of the Plan's investments were invested in three investment options.

NOTE I--SUBSEQUENT EVENTS

Effective February 1, 2024, the Plan's custodian and third-party administrator was changed from Principal and Plan Design Consultants, Inc., respectively, to ADP Retirement Services. The Plan amended and restated the Plan document and changed certain provisions of the Plan including eligibility requirements and automatic deferral arrangements. Starting February 1, 2024, employees of the Companies who are eligible to participate must complete 166 hours of service during the first two months or one year of service and not be excluded under the terms of the Plan Document. Additionally, the Plan implemented auto enrollment prospectively. Upon meeting eligibility requirements, unless otherwise elected by the employee, the employee's compensation will automatically be reduced by 2% each pay period and remitted to the Plan as a salary deferral contribution.

Effective October 1, 2024, the Plan was amended to change eligibility requirements. Starting October 1, 2024, employees of the Companies must complete two months of service to be eligible to participate.
