**Opinion**

We have audited the financial statements of A.L. Gilbert Company Profit Sharing and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of February 28, 2025 and February 29, 2024, the related statement of changes in net assets available for benefits for the year ended February 28, 2025, and the related notes to the financial statements.

**Note 1 Description of the Plan**

The following description of the A. L. Gilbert Company Profit Sharing and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** The Plan is a participant-directed defined contribution plan covering all employees of A. L. Gilbert Company and Companies under its control (the Company) who have at least one year of service and are not covered by a collective bargaining agreement, unless the agreement provides for inclusion in the Plan. Employees can enter the Plan on March 1 or September 1 after they become eligible. Effective March 1, 2024, the Plan was restated due to the change in third party administrator as Digital Retirement Solutions, Inc. was acquired by July Business Services, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The financial statements are prepared in accordance with accounting principles generally accepted in the United States of America. The Board of Directors of the Company are responsible for the oversight of the Plan.

**Contributions** The Company contributes to the Plan an amount determined by the Board of Directors. Participants are neither required nor permitted to make contributions.

**Participant Accounts** Each participant's account is credited with an allocation of (a) the Company's contribution, (b) plan earnings, and (c) forfeitures of terminated employees' non-vested account balances remaining after any Plan expenses have been paid. Allocations are based on participant compensation or account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Notes Receivable from Participants** The Plan does not allow participant notes receivable.

**Payment of Benefits** Upon death, disability, attaining 59 ½ years of age, normal retirement age, or termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. Payments made may be in a single lump-sum or partial withdrawals.

**Investment Options** Upon enrollment in the Plan, a participant may direct contributions into numerous investment choices as made available from time to time. Participants may change their investment options through written request through the Company or via the internet.

**Administrative Expenses** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**Forfeitures** The portion of each participant account that is non-vested is forfeited when (a) a distribution of the vested portion of the account occurs, or (b) at the end of the Plan year during which the former participant incurs the fifth consecutive one-year service break after termination. The forfeited amounts held at February 28, 2025 and February 29, 2024 were \$1,641 and \$8,245, respectively. The Plan has elected to allocate these forfeitures to reduce administrative expenses.

**Vesting** A participant's vesting in their account is based on years of credited service. A participant becomes 100 percent vested after six years of credited service. A participant is 100 percent vested after reaching normal retirement age, or upon death or disability.

**Note 1 Description of the Plan (Continued)**

**Secure 2.0 Act** On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as Secure 2.0. These provisions continue the themes and reforms that began with the 2019 Secure Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

**Note 2 Summary of Accounting Policies**

**Basis of Accounting** The financial statements are prepared on the accrual basis of accounting.

**Investment Valuations and Income Recognition** Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, or trustees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Payment of Benefits** The Plan records benefits when paid. Total vested benefits due to terminated and retired participants but not paid was \$8,859,842 as of February 28, 2025.

**Accounting for Uncertainty in Income Taxes** Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Plan management has determined that as of February 28, 2025, there are no uncertain tax positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Use of Estimates** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

**Subsequent Events** In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through December 5, 2025, the date the financial statements were available to be issued.

**Note 3 Transactions with Parties-in-Interest**

Matrix Trust Company, the Plan's trustee, July Business Services, Inc., the Plan's third party administrator, Cetera Advisor Networks, LLC, the Plan's registered investment advisor, and Atherton & Associates, LLP, the Plan's auditor, are parties-in-interest according to Section 3(14) of ERISA.

**Note 4 Income Tax Status**

The Plan has adopted a non-standardized pre-approved profit sharing plan which has obtained a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

**Note 5 Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

**Note 6 Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts and balances and the amounts reported in the statements of net assets available for benefits.

**Note 7 Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at February 28, 2025 and February 29, 2024. Following is a description of the valuation methodologies used for assets measured at fair value.

**Money market fund:** Determined using a market approach and is based upon unadjusted quoted prices for identical assets in active markets.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
