## INDEPENDENT AUDITOR'S REPORT

**NOTE A – DESCRIPTION OF THE PLAN**

The following description of the Aspire Health Group LLC 401 (K) Plan (The Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**1. General**

The Plan is a defined contribution plan covering substantially all non-union employees of Aspire Health Group LLC 401 (K) Plan (the Sponsor) who are age 21 or older and have completed 3 month's service. The Plan was effective January 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee of the Plan determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the plan administrator.

**2. Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefits of defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Sponsor may make matching contributions for a discretionary percentage determined by the Sponsor on an annual basis. For the year ended December 31, 2024, the Sponsor did elect to make matching discretionary contributions. The Sponsor's contributions are invested in the same investment options and allocation percentages as the participant-directed contributions. Contributions are subject to certain IRS limitations. Participants must complete 1000 hours of service during the Plan year to be eligible.

**3. Participant Accounts**

Each participant's account is credited with the participant's contributions and Sponsor matching contributions, as well as allocations of Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**4. Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Sponsor's matching contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after the 2<sup>nd</sup> year of service and vesting increases by 20% each year after that until the participant is 100% vested after six years of credited service. Participants service time worked at Aspire Health Group LLC 401 (K) Plan will be included in total years of services for vesting purposes of the Plan. Participants also fully vest in the Sponsor's contributions upon death.

**5. Payment of Benefits**

Upon termination of service due to death, disability, retirement, or termination of service due to other reasons, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in their account. Participants may also elect to withdraw funds while still employed once they reach the age of 59 1/2 . Hardship withdrawals are also permitted, subject to certain limitations and restrictions.

**6. Notes Receivable from Participants**

No Participant Loans are permitted as per the Plan Document.

**7. Administrative Expenses**

The Plan's administrative expenses primarily include investment management and professional fees for services provided by parties-in-interest. Certain administrative expenses are paid by the Plan, while others are paid directly by the Sponsor and excluded from these financial statements.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**1. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**2. Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements and the

reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED**

**3. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The management of the Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisor and the custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**4. Payment of Benefits**

Benefits are recorded when paid.

**5. Administrative Expenses**

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of benefits paid to the participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**6. Subsequent Events**

The Plan has evaluated events through December 1, 2025, the date the financial statements were available to be issued.

**NOTE C – INFORMATION CERTIFIED BY THE PLANS' CUSTODIAN - JOHN HANCOCK**

As permitted by Section 2520.103-8 of the Department of Labor's Rules and regulations for Reporting and Disclosures under the Erisa, the plan has elected the alternative method of compliance with respect to the required audit of the financial statements. As a result of adopting this method, the trustee, who also maintains the primary records of the plan, certified to the plan administrator that the statements of the trustee were complete and accurate and the reported assets were under their control.

**NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted.

quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024.

*Pooled separate accounts:* Valued at the net asset value, which is based on the values of the underlying mutual funds as determined by quoted market prices, less any liabilities.

The Plan's assets at fair value as of December 31, 2024, was \$1,253,723, and is considered Level 2 investments within the fair value hierarchy.

**NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments managed by John Hancock, who is the custodian of the Plan and, therefore, transactions between John Hancock and the Plan qualify as party-in-interest transactions. Certain fees incurred by the Plan for the investment management services are

netted with administrative expenses, as they are paid through a revenue sharing, rather than direct payment. Administrative fees paid to John Hancock \$23,178 for the year ended December 31, 2024. Economic Group Pension Services (EGPS) provides investment advisor services and record-keeping, therefore transactions with EGPS and the Plan qualify as party-in-interest transactions for the year ended December 31, 2024.

**NOTE F – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their allocation of Sponsor contributions.

**NOTE G – TAX STATUS**

The Internal Revenue Service (IRS) issued a non-standardized pre-approved profit sharing plan with CODA (cash-or-deferred arrangements) opinion letter dated June 30, 2020 to CCH Incorporated DBA FTWilliam Com, stating that its plan is acceptable for use by employers for the benefit of their employees under the Internal Revenue Code. Although the Sponsor has not applied for a determination letter for the Plan, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the plan administrator believes that the Plan was qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 1 – DELINQUENT PARTICIPANT CONTRIBUTIONS**

During 2024, the Sponsor failed to remit in a timely manner certain employee deferrals to the Plan aggregating \$3,532. Lost earnings on these deposits will be calculated and submitted to the Plan subsequently.
