1. Description of Plan

The HDNet LLC 401(k) Profit Sharing Plan (the "Plan") was established by HDNet LLC (the "Company") as a defined contribution plan for the benefit of its employees. The Plan's original effective date was January 1, 2001, and the amended and restated provisions of the Plan became effective on April 1, 2013. The Plan allows for employee contributions under Section 401(k) of the Internal Revenue Code. The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company, excluding union employees, nonresident aliens, part time, temporary, and seasonal employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Employees become eligible after completing 1 month of service and have attained the age of 21.

Contributions

Each year, participants may contribute up to 90% of annual compensation, as defined in the Plan as W-2 wages excluding reimbursements or other allowances and fringe benefits, up to a maximum of \$23,000 for 2024 and \$22,500 for 2023. Participants may designate all or a portion of their elective deferrals as either pre-tax or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes matching contributions and may elect to make non-elective contributions at its own discretion. The Employer matching contributions are equal to 50% of participants elective deferral, not to exceed 6% of the employee's compensation. Any matching Company contributions are invested as directed by plan participants. Contributions are subject to certain limitations. For the year ended December 31, 2024 the matching Company contributions totaled \$107,653. There were no employer non-elective contributions made during 2024.

The Company makes annual true-up contributions when necessary.

Participants are automatically enrolled in the Plan at 6% of eligible compensation and can elect out of participation at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, and attributable Plan earnings, and charged with an allocation of administrative expenses. Employer matching contributions started on January 1, 2016. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Vesting

Participants are vested immediately in their contributions. Participant's elective deferrals are not subject to forfeiture for any reason. Participant's vesting in the employers matching and non-elective contributions, plus actual earnings thereon is based on years of continuous service as shown in the following schedule:

Years of service	Percent Vested
Less than 1	0%
At least 2, but less than 3	25%
At least 3, but less than 4	50%
At least 4, but less than 5	75%
5 or more	100%

Regardless of the vesting schedule, a participant will become fully vested upon death or total and permanent disability.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect withdrawals from their vested account balance. Distributions can be made in lump sums, substantially equal installments, or partial withdrawals. Such distributions are subject to certain taxes, fees, and other restrictions.

Upon termination of service, participants with account balances \$5,000 or less will automatically receive a lump sum distribution amount equal to the value of the participant's vested interest in his or her account. Participants with account balances in excess of \$5,000 will require participant's consent before any distribution will be made.

The Plan allows for certain in-service distributions including hardship and disability distributions provided certain conditions are satisfied and distributions do not exceed certain limits and the participant's vested account balance. Participants are not allowed to receive hardship distributions from qualified matching contributions. Disability distributions can be made from all contribution accounts.

Participant Loans

Each participant is allowed a maximum of two outstanding loans at the same time. Participants may borrow up to the lesser of 50 percent of their vested account balance or \$50,000. However, the \$50,000 maximum must be reduced by the highest outstanding loan balance the participant had under the Plan during the previous one-year period. The loans are secured by the balance in the participant's account and bear interest at a rate of Prime + 1%. The loan plus interest, which is credited to the participant's account, must be repaid within a five-year period (unless for purchase of primary residence) and is repaid directly through payroll deductions.

Investment Options

Upon enrollment in the Plan, a participant directs both participant and employer contributions in any of the available investment options. Participants may change their investment options at any time.

Termination

While the Company has not expressed any intent to terminate the Plan, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their employer contributions.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the HDNet LLC 401(k) Profit Sharing Plan have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end. Common/collective trusts are valued based on the respective net asset values of the underlying trusts, exclusive of the adjustment to contract value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All reasonable administrative expenses of maintaining the plan are paid by the Company.

Forfeited Accounts

Forfeitures are first applied to pay plan administrative expenses, then to reduce employer contributions. Forfeitures generated for the year ended December 31, 2024 were \$63,319, with \$35,837 used to reduce employer contributions.

Notes Receivable from Participants

Participant loans are reported at their unpaid principal balances plus any accrued but unpaid interest. If a participant misses a loan payment for any reason other than certain types of leaves of absence, the outstanding loan, including interest accrued to date, will be considered in default and treated as taxable on the participant's deemed distribution date.

Concentrations of Credit Risk

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist primarily of marketable securities. Marketable securities are subject to daily changes in market valuations. The Plan has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk on cash and cash funds.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 14, 2025.

3. Information Certified by Custodian

4. Income Tax Status

The Company adopted a Prototype Non-Standardized 401(k) Plan dated December 31, 2018, which received a favorable opinion letter from the Internal Revenue Service in which the Internal Revenue Service stated that the Plan, as then designed, was tax exempt and in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Tax years subject to review are years 2020 and forward.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. Parties in Interest Transactions

Certain plan investments are managed by Reliance Trust. Reliance Trust generally acts as the Plan custodian and recordkeeper. Therefore, these transactions qualify as party in interest transactions.

Reliance Trust and its affiliates and the plan's investment advisor can receive 12(b)(1) fees or similar fees from Plan investments for plan advisory fees.

7. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy under FASB ASC 820, Fair Value Measurement, are describe as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in active markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data, by correlation, or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following describes the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the year.

Registered Investment Companies

Value based on unadjusted quota market prices in actively traded markets. These mutual funds are required to publish or provide the daily valuation information.

Common/Collective Trusts
