Enclosed please find IRS Form 5500 for the plan noted above in connection with the plan year ended 12/31/2024. Please consider the following explanation as to the reason that this form is being submitted past the normal due date of 7/31/2025.

Due to lack of Payroll which prevented the ability to complete the Census, IRS Form 5500 was not submitted prior to 7/31/2025 for the 2024 submission. It was our understanding that without Census, Form 5500 could not be submitted. Therefore, the due date for the 2024 filing was filed late. This was an honest mistake on our part.

I would, therefore, request that you waive the penalty for late filing in this instance.

Our Plan was created back in 2005 and the Company never missed a single filing.

In addition, the Company was dissolved in January 2025, therefore there is no bank account to pay the penalty from.
