We are the Accountants for the Chapter 7 Bankruptcy Trustee of PositivePsyche Biz Corp. (“Positive” or the “Debtor”), the Sponsor of the PositivePsyche Biz Corp 401K Plan. Positive filed for protection under Chapter 7 of the United States Bankruptcy Code on January 10, 2025, at which time Zvi Guttman Esq. was appointed as the Chapter 7 Trustee (the “Trustee”). All operations and payroll ceased as of the Chapter 7 filing.

As a result of the Chapter 7 bankruptcy proceeding, and pursuant to 11 U.S.C. Sect. 704(a)(11), the Trustee is responsible for the liquidation of the Plan Assets of the Health IQ 401(k) Profit Sharing Plan and Trust (“the Plan”).

The 2025 annual informational return was prepared from the best information available; that is, data provided by the Debtor to the Plan’s Record Keeper and Plan Asset Custodian, BPAS Plan Administration & Recordkeeping Services (“BPAS”). Due to the cessation of business and the filing of bankruptcy, certain key financial records, subsidiary ledgers and documentation supporting various policies, transactions, and other matters that would normally be expected to be present in an operating enterprise, were missing or unavailable.

For several years prior to the Trustee’s appointment, contributions totaling \$91,748 were not timely remitted by the Debtor to the Plan, which included \$35,663 that was not remitted to Participants’ accounts at all during 2024. Since Bankruptcy Regulations do not allow the use of Bankruptcy Estate funds for Plan expenses or missed contributions, there are no funds available in the Bankruptcy Estate to reimburse the Plan’s Participants. Accordingly, there are no funds to make Participants whole or to pay the lost earnings that would be required under the DOL’s Voluntary Fiduciary Correction Program. The Trustee has filed claims with the Bankruptcy Court on behalf of the participants whose accounts experienced the 2024 shortfalls totaling \$35,663.

During 2025, as part of the termination and liquidation process, all of the Plan’s remaining funds were distributed to Participants. We are not aware of any complaints from Participants regarding the distribution or disposition of their account balances.

The period on this return through January 10, 2025 predates the appointment of the Trustee and his professionals. Neither the Trustee, nor the Trustee’s Accountants have any direct knowledge of the transactions recorded by the Debtor and BPAS prior to his appointment. In addition, the Trustee and his professionals have no knowledge of the processes used or policies put in place by the Debtor or BPAS.

The Trustee, by his signature on the face of this informational return, has relied on BPAS’s expertise in preparing the return from the available records, which were limited due to the entity's cessation of business. However, it is our qualified opinion that this is a complete return based on the financial information available.
