**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the H & M Construction Company, Inc. Employees' Profit Sharing and Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established January 1, 1986, for the purpose of providing employees of H & M Construction Company, Inc. (the "Company") the opportunity to defer a portion of their annual base compensation for Federal income tax purposes in accordance with Section 401(k) of the Internal Revenue Code (the "Code"). The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. The Plan was restated with an effective date of May 1, 2015 to include all companies owned by H & M Construction Company, Inc. Effective May 1, 2023, the Plan was restated. Under the restated plan, among other changes, the Plan became a safe harbor plan.

Eligibility: Under the restatement effective May 1, 2023, employees who have completed one consecutive year, or 1,000 hours of service, and have attained the age of twenty-one are eligible to participate in the Plan. Employees may elect to change or discontinue deferrals at any time.

Contributions: Participants may elect to contribute to the Plan an unlimited amount of their eligible wages up to a maximum contribution as allowed by the Internal Revenue Service. Roth elective deferrals are permitted. Participants who are age 50 or older by the end of the Plan year may make catch-up contributions, subject to certain Internal Revenue Code limitations. Eligible wages include regular wages, and overtime. Participant contributions to the Plan are made by means of payroll deductions during each regular payroll period. A participant may make rollover contributions directly from certain other qualified plans or from certain qualified special individual retirement accounts. Each pay period, the Company makes safe harbor matching contributions to the account of each eligible employee equal to 100% of the first 3% and 50% of the next 2% of eligible compensation that a participant contributes to the Plan. True-up matching contributions shall be made each plan year to ensure that participants receive the full safe harbor matching contribution for the Plan Year quarter, as further described in the Plan document.

The Company may contribute to the Plan an additional discretionary amount determined by the Board of Directors. Such contributions, if any, shall be allocated to each participant in proportion to his or her compensation for the Plan year. Participants must be employed at the end of the Plan year and complete one year of service to be eligible for the additional discretionary contribution. The Company did not make a discretionary matching contribution during the Plan years ending April 30, 2025 and 2024. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings, and (c) forfeitures of employer discretionary contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Active employees may make withdrawals of all or a portion of their account balances subject to certain withdrawal and contribution suspension rules as defined by the Plan. Withdrawals from the accounts are not allowed for participants who are less than 59½ years of age, except under hardship withdrawal and rollover contribution provisions.

Notes Receivable from Participants: Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Notes are generally repaid over a period of 60 months through payroll deductions. Interest rates are determined at the time of origination by the retirement plan committee and are based on market rates used by the trustee.

Vesting: Participants are immediately fully vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Employer nonelective profit sharing contributions are based on years of continuous service as follows:

<u>Year of Service</u>	<u>Vesting Percentage</u>
1	20%
2	40%
3	60%
4	80%
5	100%

Payment of Benefits: Participants are eligible for payment of benefits upon retirement, death, permanent disability, or termination of employment. Payments are in the form of a lump sum distribution or also can be provided in substantially equal installments.

Forfeitures: The non-vested portion of terminated participants accounts plus earnings thereon are forfeited and can be used by the Plan to reduce the amount of future employer contributions to the Plan or to pay administrative expenses. Any remaining forfeitures are then allocated back to participant accounts.

Hardship Withdrawals: Participants may withdraw their vested contributions in the event of hardship as defined in the plan agreement.

Investment Options: Participants may direct their contributions (including the Company's matching contributions) and make changes monthly into any of the available investment options.

Administrative Expenses: Trustee fees and management fees are paid by the Company, to the extent they are not paid by the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements are prepared under the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Risks and Uncertainties: The Plan invests in various investments. The investments are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further discussed in Note 4. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Rights Upon Plan Termination: Although it has not expressed any intention to do so, the Company has the right to terminate the Plan subject to the related provisions of ERISA. In the event of a plan termination or permanent discontinuance of contributions, participants would become 100% vested in their accounts.

**NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at April 30, 2025 and 2024, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended April 30 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Money Market and Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Stable Value Collective Trust:* The fair values of participation units in a stable value collective trust are based on the net asset values per unit as reported by the fund managers. The stable value collective trust provides for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

**NOTE 5 – TAX STATUS OF PLAN**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. A tax position is recognized as a benefit only if it is “more likely than not” that the tax position would be sustained in a tax examination, with a tax examination presumed to occur. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 30, 2025 and 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan holds investments in mutual funds and a stable value collective trust issued by T. Rowe Price Trust Company, who manages the investments and provides recordkeeping services, and, therefore, these transactions and the Plan’s payment of recordkeeping fees and investment management fees to T. Rowe Price Trust Company qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.
