- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the HBCS 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Copies of the Plan document are available from the Plan administrator.

General

The Plan, established on October 1, 2009, is a defined contribution plan covering all eligible employees of Hospital Billing & Collection Service, Ltd. ("HBCS", "Employer", or "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Eligible employees are all employees of HBCS except for (i) leased employees and (ii) employees of any member of a controlled and/or affiliated service group whose employer does not affirmatively adopt the Plan.

During 2024, HBCS was acquired by Med-Metrix. Effective August 5, 2024, eligible HBCS employees became eligible to participate in the Med-Metrix 401(k) Plan ("Med-Metrix Plan") and contributions to the Plan ceased. Through November 1, 2024, eligible participants could take distributions and loans from the Plan. The sponsor successfully merged the Plan assets into the Med-Metrix Plan on November 4, 2024 (Note G).

Contributions

Participant Salary Deferrals

Participants may contribute pretax annual compensation, as defined in the Plan document, up to Internal Revenue Service ("IRS") limitations. Participants may also elect Roth contributions or elect in-plan Roth rollover conversions. Eligible employees are automatically enrolled in the Plan at an amount equal to 3% of their eligible compensation unless the eligible employee affirmatively elects to opt-out of such deferral contributions or elects a deferral percentage other than 3%. The individual deferral rate for those participants who either have not opted out of automatic enrollment or have not elected a deferral percentage other than 3%, will increase by 1% each subsequent Plan year until the participant's individual deferral rate reaches 6%. Participants may also roll over amounts from other qualified defined benefit or defined contribution plans. Participants who have attained the age of 50 before the end of the Plan year are also eligible to make catch-up contributions subject to annual IRS limits.

Employer Contributions

The Plan includes safe harbor matching contributions equivalent to (a) 100% of the first 1% of compensation contributed by a participant to the Plan, and (b) 50% of participant salary deferrals between 1% and 6% of compensation. The Plan also allows the Employer to make discretionary matching contributions, which would be determined on or before the due date of the Employer's tax return for the year of allocation, but not to exceed 4% of compensation. Discretionary matching contributions are equivalent to 25% of participant salary deferrals between 7% and 17%. In addition, participants are not required to be employed at the end of the year in order to receive Employer matching contributions.

The Employer may also, at its discretion, make qualified non-elective contributions to eligible participants who are non-highly compensated employees. No discretionary non-elective contributions were made in 2024.

In 2024, Employer safe harbor matching contributions totaled \$753,962 and discretionary matching contributions totaled \$1,066. Employer contributions were reduced by \$46,351, the amount funded from forfeited non-vested accounts.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, Company's matching contributions, and an allocation of Plan investment earnings, and is charged with withdrawals and an allocation of Plan investment losses and administrative expenses, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their account balances in 1% increments into various mutual funds and a stable value account offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles. Plan investment earnings and/or losses are allocated to participants' accounts on a daily basis according to the type of funding vehicle in which balances are invested.

Vesting

Participants are considered fully vested at all times in their deferral contributions and their rollover amounts plus actual earnings thereon. An employee is credited with one year of service for each Plan year worked. Employer matching and discretionary contributions, plus actual earnings thereon, are 100% vested after two years of service.

Forfeited Accounts

Forfeited, non-vested accounts may be used to reduce future employer contributions or pay Plan expenses. On November 1, 2024 unallocated forfeitures were merged into the Med-Matrix Plan. At December 31, 2023, the balance of forfeited non-vested accounts totaled \$75,431. In 2024, \$46,351 in forfeitures were used to reduce employer contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 reduced by the excess of the highest outstanding loan balance in the last 12 months or 50% of their vested balance reduced by the outstanding balance of all loans. Each participant is limited to no more than one loan at a time. Loan terms are standard for all participants, and the loan term shall not exceed five years, unless the loan is for the purchase of a participant's principal residence, in which case the loan term shall not exceed ten years.

The loans are secured by the balance in the participant's vested accounts and bear interest at a rate of prime +1% at the date the loans are issued. Principal and interest are paid directly by participants to the trustee.

Payment of Benefits

Upon termination of service, death, disability, retirement or separation, a participant may receive the value of the vested interest in their account as a lump-sum distribution. In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59½. Participants are also permitted to make hardship withdrawals in certain cases of immediate and heavy financial need. Rollover account balances may be withdrawn at any time.

Per IRS regulations, participants are required to take a minimum required distribution by April 1 of the year following the year they reach age 73.

Defaulted loans considered deemed distributions of \$43,619 are recorded as benefits paid to participants in the accompanying statement of changes in net assets available for benefits for the period from January 1, 2024 through November 1, 2024.

Plan Administration

Lincoln Financial Group Trust Company, Inc. serves as the Plan's recordkeeper.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Lincoln Financial Group Stable Value Account ("Stable Value Account"), which is reported at contract value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the trustee. See Note D for discussion of fair value measurements and investment valuation.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments and Distributions

Benefit payments and distributions are recorded when paid.

Administrative Expenses

Administrative costs for active participants of the Plan are paid by HBCS. Administrative costs for non-active participants are deducted from their accounts and are included in administrative expenses in the statement of changes in net assets available for benefits.

NOTE C - INVESTMENTS AND INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103 8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial Group Trust Company, Inc. ("Lincoln"), the trustee, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of November 1, 2024 and December 31, 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the period from January 1, 2024 through November 1, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at November 1, 2024 and December 31, 2023.

Mutual Funds: Shares of mutual funds are valued based on quoted prices of the fund in active markets and classified within Level 1 of the fair value hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present information about the Plan's investments measured at fair value on a recurring basis as of December 31, 2023, and indicate the fair value hierarchy of the valuation techniques utilized by the Plan to determine such value:

Gains and losses (realized and unrealized) included in changes in net assets for the period above are reported in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the period from January 1, 2024 through November 1, 2024 and December 31, 2023, no investments were transferred from Level 1 to Level 2 in the fair value hierarchy.

NOTE E - LINCOLN FINANCIAL GROUP STABLE VALUE ACCOUNT

The Stable Value Account is a fixed annuity contract issued by Lincoln National Life Insurance Company and is managed to earn a competitive interest rate without risking a loss of principal. The fixed annuity contract is considered fully benefit-responsive and is backed by the assets of Lincoln National Life Insurance Company. Participants' ownership of the Stable Value Account is represented as units. Units are issued and redeemed daily at the Stable Value Account's constant NAV of \$1 per unit.

Investments in the accompanying statements of net assets available for benefits include a fully benefit-responsive investment contract recognized at contract value. Contract value represents net contributions plus crediting interest, less funds used to pay terminated participants. Crediting interest rates are based on an external index and are adjusted to market quarterly. The contract does not specify any events which would limit the ability of the Plan to transact at contract value with the issuer, or any events which would allow the issuer to terminate the contract and settle for an amount different from contract value. The crediting interest rate is based on a formula agreed upon with the issuer and is guaranteed for five contract

years. The Plan entered into a fixed annuity contract with Lincoln National Life Insurance Company with a guaranteed interest rate of 1.0%.

NOTE F - PARTIES-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds and the Stable Value Account, which are managed by an affiliate of Lincoln. Lincoln acts as record-keeper for investments in the Plan. Transactions in such investments qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

Participant loans are considered party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE G - PLAN MERGER

Effective November 1, 2024, the Plan was merged into the Med-Matrix Plan. Assets totaling \$28,925,184, including \$785,648 in notes receivable from participants, were transferred on November 4, 2024. Participants' accounts were mapped from existing fund options to the investment lineup of the Mex-Matrix Plan in accordance with participant notices and instructions.

NOTE H - INCOME TAX STATUS

The underlying volume submitter plan has received an opinion letter from the IRS dated June 30, 2020, 2014, stating that the form of the plan is qualified under Section 401(a) of the Internal Revenue Code ("Code") and, therefore, the related trust is tax exempt. The Plan Sponsor has determined that it is eligible to and has chosen to rely on the current IRS opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes the Plan, as amended and restated, is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 1, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through November 26, 2025, the date the financial statements were available to be issued. There are no events that require recognition or disclosure in the financial statements.
