To Whom It May Concern:

We respectfully request abatement of any assessed penalties for the late filing of Form 5500 for plan year 2023. The failure to file was due to reasonable cause and not willful neglect, as defined in Treasury Regulation §301.6651-1(c).

The plan administrator reasonably relied on its third-party benefits/plan sponsor to prepare and timely file all required Form 5500 filings. The sponsor had previously handled the annual reporting process for the company's benefit plan. Based on their assurances that all required filings would be submitted, they reasonably believed that their Form 5500 filings were being completed as required.

The IRS Internal Revenue Manual acknowledges that reasonable reliance on a qualified professional may constitute reasonable cause when the taxpayer exercises ordinary business care and prudence (IRM 20.1.1.3.2.4). The plan administrator maintained standard compliance procedures and relied on experienced benefits professionals for annual reporting obligations.

At all times, the plan administrator provided accurate and complete information to the service provider and acted in good faith. The plan was closed in 2023, and switched providers, this seems to be where the issues arose and the sponsor did not file a final to close out the plan. We were unaware that the filings had not been submitted.

There was no intentional disregard, and no attempt to avoid filing requirements.

Once they became aware of the delinquency, they immediately began reaching out to their former plan sponsor. Unable to reach anyone or get information on that end, they reached out to our office to file the required Final Form 5500 through the appropriate channels. We gained power of attorney and had multiple correspondence with the IRS.

Given these facts, we respectfully request that the IRS:

Abate all penalties in full for the plan year ended 2023, under the reasonable-cause provisions of IRC §6652(d), Treas. Reg. §301.6651-1(c), and IRM 20.1.1.3.2 – 20.1.1.3.2.4.

The plan administrator acted in good faith, with ordinary business care and prudence, and the failure was the result of reasonable reliance on their plan sponsor.
