### 1. Description of Plan

The following description of the Hilltop Trailer Sales, Inc., 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan is a defined contribution plan sponsored by Hilltop Trailer Sales, Inc. (the "Employer", "Plan Sponsor", or "Plan Administrator") for the benefit of its employees. The Plan became effective January 1, 1992 and was most recently amended effective January 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Principal Trust Company (the "Trustee") is responsible for oversight of the Plan as well as determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

#### **Eligibility**

Employees who have worked at least two months and attained the age of 18 are eligible to participate in the Plan for the purposes of salary deferrals and the employer matching contributions. Ineligible employees are (1) employees whose employment is governed by the terms of a collective bargaining agreement, (2) non-resident aliens who do not receive any compensation from U.S. sources, or (3) leased employees. Eligible employees may enter the Plan on the date when the eligibility requirements are met as defined by the Plan.

Employees who become eligible to participate in the Plan and fail to enroll themselves in the Plan shall be automatically enrolled to defer 3% of their eligible compensation into the Principal Target Retirement Date fund that most closely approximates the participant's anticipated retirement date. Participants may also elect to not participate in the Plan and will not be automatically enrolled. Once enrolled, the participants can change their contribution deferral amounts at any time. The Plan does not have an auto escalation feature at this time.

#### **Contributions**

Participants may elect to contribute on a pre-tax or Roth basis up to 100% of eligible pre-tax compensation to the Plan each year, up to the maximum amount allowed by law. The Plan also allows participants to make contributions to a Roth 401(k). Additionally, participants may rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have obtained age 50 before the end of the Plan year are eligible to make catch-up contributions.

For 2024, the Plan or the Plan Sponsor contributed \$0.25 for every dollar of the participant's contribution up to a maximum of 2% of total compensation. For 2023, the Plan made matching contributions of approximately \$114,000. The Plan also has a discretionary employer match. There were no discretionary profit sharing contributions for the year ended December 31, 2024. Contributions are subject to a compensation ceiling and annual limitations prescribed by certain IRS limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and the Plan's discretionary matching contributions, an allocation of any Plan contribution, and each participant's portion of earnings and losses, if any. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct and redirect their account balances and their contributions into various mutual fund options offered by the Plan. The allocation of account balances and contributions to these investment funds is determined at the participant's discretion and may be changed by the participant on a daily basis.

#### **Vesting**

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Participants are 100% immediately vested in employer contributions.

### 1. Description of Plan (Continued)

#### **Forfeited Accounts**

If a participant terminates employment before becoming fully vested in any of the Plan benefits, those non-vested amounts may be forfeited. Approximately \$1,000 of forfeited amounts were used to reduce Employer contributions to the Plan during 2024. At December 31, 2024 and 2023, there were \$0 and \$574 (compiled), respectively, of forfeited nonvested account totals in the Plan. This account is used to reduce future employer contributions.

#### **Notes Receivable From Participants**

Participants are permitted to borrow up to 50 percent of their vested account balance with a minimum of \$1,000 up to a maximum loan amount of \$50,000. Only one note may be outstanding at any given time. Loans must be repaid in monthly installments of principle and interest, at one percent over the prime rate, not to exceed five years unless the loan is used to acquire a principle residence; then it is not to exceed ten years. Interest rates at December 31, 2024 range from 4.25 percent to 9.50 percent. Notes receivable from participants are valued at their unpaid principal balance plus accrued interest.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A terminated employee with a vested balance of \$5,000 or less will have the option to elect to have the distribution paid out or rolled over into a qualified Individual Retirement Account. A terminated employee with a vested balance of more than \$5,000 may elect to take their distribution by lump sum, partial lump sums, qualified joint and survivor annuity (QJSA), installment payments, or annuity payments.

Distributions may be made at the participant's election prior to termination, upon attainment of age 59 1/2, or due to hardship as defined in the Plan Document.

### 2. Summary of Significant Accounting Policies

#### **Basis of Accounting**

The financial statements of the Plan are prepared under accounting principles generally accepted in the United States of America (US GAAP).

#### **Accounting Estimates**

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates and those results could be material.

## 2. Summary of Significant Accounting Policies (Continued)

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Shares of mutual funds and taxable bond funds are valued at the net asset value of shares held by the Plan at year end using quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year are presented in the net appreciation in fair value of investments.

### **Payment of Benefits**

Benefit payments are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account.

### **Fair Value of Financial Instruments**

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

### **Subsequent Events**

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through November 14, 2025, the date which the financial statements were available to be issued.

### 6. Plan Termination

Although the Plan Sponsor has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their Employer contributions, and the Plan assets will be distributed according to the provisions of the Plan documents.

### 7. Tax Status

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

### 8. Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will continue to occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.
