## INDEPENDENT AUDITOR'S REPORT

To the Trustees  
**Code42 401(k) Retirement Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Code42 401(k) Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of March 23, 2025, and December 31, 2024, and the related statement of changes in net assets available for benefits for the period January 1, 2025, through March 23, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **Code42 401(k) Retirement Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 23, 2025, and December 31, 2024, and for the period January 1 through March 23, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **Code42 401(k) Retirement Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ### **Emphasis of Matter - Plan Merger**

As described in Note 1 to the financial statements, all of the assets of the Plan were merged into the Mimecast North America, Inc. 401(k) Plan on March 23, 2025. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about **Code42 401(k) Retirement Plan's** ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE 1: DESCRIPTION OF PLAN**

The following description of Code42 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan was a defined contribution plan, under section 401(k) of the Internal Revenue Code ("IRC"), covering employees of Code42 Software, Inc. (the "Company") who were at least 21 years of age. Plan entrance dates were the first of the month following completion of the eligibility requirements. The Investment Committee was responsible for the oversight of the Plan, determined the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Plan Merger:** The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. On February 28, 2025, the Plan was merged into the Mimecast North America, Inc. 401(k) Plan. Total assets of \$39,408,639 were transferred out of the Plan. On March 23, 2025, the remaining \$154,854 of assets remaining in the Plan related to existing notes receivable from participants, were transferred to the Mimecast plan. The certified statements provided by the Plan's recordkeeper were through February 28, 2025 (see Note 5) and include the notes receivable from participants in the amount of \$154,854, however an adjustment to record the transfer out of these assets was recorded to show zero remaining net assets effective March 23, 2025. The employer receivable related to a true-up contribution will be funded into Mimecast North America, Inc. 401(k) and as such a corresponding liability in the amount of \$75,192 was recorded against Plan transfer out in the statement of changes in net assets available for benefits.

**Contributions and Allocations:** There were no contributions made to the Plan in 2025.

**Participant Accounts:** Each participant's account was credited with Plan earnings or losses and charged with an allocation of administrative expenses, if any. Allocations of participant earnings (losses) were based on account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

**Investment Options:** Participants directed the investment of contributions into various investment options offered by the Plan. Participants could change their investment options as determined by the rules applicable to each investment.

**Vesting:** Participants were immediately vested in their voluntary contributions and any actual earnings thereon. Employer matching contributions and discretionary non-elective profit-sharing contributions were subject to a vesting scheduled based on the number of years of continuous service as follows:

#### NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

**Notes Receivable from Participants:** Participants could borrow from their account balance a minimum of \$1,000 up to a maximum equal to the present value of their vested account balances. Loans were secured by the balances in the participants' accounts and were supported by a promissory note. Loans bore interest at a reasonable rate (4.25% - 9.50% during 2025). Principal and interest were paid ratably through payroll deductions. If participants terminated or retired, they had the choice of repaying the loan or having the loan offset from their account. The offset loan amount would be considered a taxable distribution.

**Payment of Benefits:** Upon termination of service, retirement (age 65), death, or disability, a participant could elect to receive a lump sum amount or partial payments equal to the value of his or her account. Upon termination of service, if the account balance was \$1,000 or less, the account balance would be distributed to the participant, who may elect to treat the distribution as a taxable withdrawal or directly roll over the balance into another qualified plan or individual retirement account. If the balance was greater than \$1,000, but less than \$5,000, the benefit payment would be rolled over into a qualified individual retirement account. Balances greater than \$5,000 could remain in the Plan. In service distributions were allowed for participants after obtaining age 59.5 or for amounts attributable to rollover contributions at any time, without restriction. Hardship distributions of elective deferrals were also permitted.

**Forfeitures:** Forfeited amounts related to Plan Sponsor's contributions were used to pay Plan expenses. During the period ending March 23, 2025, the Plan Sponsor utilized \$0 of forfeitures to pay Plan expenses. As of period ending March 23, 2025, and year ended December 31, 2024, the Plan had forfeitures available to pay Plan expenses in the amount of \$0 and \$75,402, respectively.

#### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan were prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates:** The preparation of financial statements in conformity with GAAP required Plan management to make estimates and assumptions that affected the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determined the Plan's valuation policies utilizing information provided by the investment advisers, trustees and other parties involved with the Plan. See Note 6 for discussion of fair value measurements.

#### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses:** Certain expenses of maintaining the Plan were paid by participants based on a percentage set forth in the service agreement, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participants' accounts and were included in administrative expenses. Investment related expenses were included in net appreciation of fair value of investments.

**Risks and Uncertainties:** The Plan utilized various investment instruments. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities would occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

**Payment of Benefits:** Benefit payments to participants were recorded when paid.

**Notes Receivable from Participants:** Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses has been recorded as of March 23, 2025, and December 31, 2024.

**Uncertain Tax Positions:** GAAP required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 23, 2025, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan was no longer subject to income tax examinations for years prior to 2022.

#### NOTE 3: PLAN TERMINATION

Although it had not expressed any intent to do so, the Company had the right under the Plan to terminate it at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 4: TAX STATUS**

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, was in compliance with the applicable sections of the IRC. The Plan had not received a determination letter specific to the Plan itself and the Plan has been amended since the latest determination letter; however, the Plan Administrator believes that the Plan was designed and was currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

**NOTE 5: CERTIFICATION OF TRUSTEE**

The Plan Administrator had elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company and Newport Trust Company certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of period) are complete and accurate.

**NOTE 6: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan could access at the measurement date.

Level 2 - inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs that were unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following was a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at March 23, 2025, and December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

*Common/collective trusts:* Valued at the NAV of units of a collective trust. The NAV, as provided by the fund manager, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it was determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
