## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The National Checking Company Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to financial statements.

### 1. DESCRIPTION OF THE PLAN

The following description of The National Checking Company Employee Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution 401(k) plan covering all eligible employees of The National Checking Company (the Company or the Employer). Employees who have completed six months of service as defined by the Plan, and are age twenty-one or older as of an available Plan entry date are eligible for participation in the Plan. The Plan entry dates are the first day of the Plan Year (April 1) and the first day of the seventh month of the Plan Year (October 1). The Plan excludes employees who are covered under a collective bargaining agreement under which retirement benefits are negotiated, certain non-resident aliens, and leased employees. Effective April 1, 2025, the Plan is amended to exclude residents of Puerto Rico and include union employees of PPPWU Local 11-M Montreal and Lothenbach locations.

The Company is the Plan Sponsor and Plan Administrator. Capital Bank and Trust Company has been appointed custodian and provides recordkeeping services for the Plan. Dot•It Restaurant Fulfillment, LLC and The Always Food Safe Company, wholly owned subsidiaries of the Company, are participating employers in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Investments are held in mutual funds and a money market fund.

On June 3, 2019, the Company sold its interest in Advantage Chemical, LLC. On June 6, 2019, Advantage Chemical, LLC, ceased its participation in the Plan, however, participants with existing balances were able to keep their balances in the Plan.

The Plan was adopted effective June 15, 1964, and was restated effective April 1, 2022, to comply with Internal Revenue Service regulations. In 2025, the Plan was amended to implement certain provisions of the Secure Act 2.0.

**Contributions** - Participants are allowed to make elective pretax (traditional 401(k)) deferral contributions up to the lesser of IRS limits or 100% of annual compensation. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

Participants are eligible for safe harbor matching contributions once they have completed six months of service. Matching eligibility dates are the same as the entry dates described above. During 2025, the Company made safe harbor matching contributions equal to 100% of each participant's eligible contributions to the Plan up to 3% of that participant's compensation, plus 50% of each participant's elective deferrals in excess of 3% but not in excess of 5% of that participant's compensation. Each year the Company may make a discretionary non-elective profit-sharing contribution to the Plan which is allocated among eligible participants. Participants are eligible for the discretionary non-elective profit-sharing contribution once they have completed one year and 1,000 hours of service. During 2025, the Company did not make a discretionary non-elective profit-sharing contribution to the Plan.

**Participant Accounts** - Each participant's account is credited with the participant's contributions plus an allocation of (a) the Company's safe harbor matching contributions, (b) the Company's discretionary non-elective profit-sharing contributions, and (c) Plan earnings and changes in the value of investments, net of expenses. Allocations are based on account balances or participant earnings as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - The participant's elective deferrals and the Company's safe harbor matching contributions and earnings thereon are always 100% vested. For the Company's discretionary non-elective profit-sharing contributions and earnings thereon, vesting is based on years of service. A participant is 100% vested in these contributions and earnings thereon after six years of credited service which includes years of service with the Company prior to the effective date of the Plan. Notwithstanding the above, a participant's account will be fully vested upon death, disability or retirement.

**Forfeitures** - Forfeitures may be used to pay administrative expenses of the Plan, offset employer safe harbor matching contributions and/or reduce future employer discretionary non-elective profit-sharing contributions payable under the Plan. In 2025, no Plan expenses were paid out of forfeitures and no forfeitures were used to offset employer safe harbor matching contributions or reduce future employer discretionary non-elective profit-sharing contributions. Forfeited non-vested accounts totaled \$3,933 at March 31, 2025. There were no forfeitures at March 31, 2024.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at two percentage points above the prime rate determined at note inception. The interest rates on notes outstanding at March 31, 2025, range from 5.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits** - On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's account in either a lump-sum amount, or in annual installment options as specified in the Plan. For termination of service due to other reasons, participants with vested accounts of less than \$7,000 will have their vested balance distributed as soon as administratively possible. Participants with vested accounts greater than \$7,000 may receive the value of the vested interest in his or her account as a lump-sum distribution, partial withdrawal, or minimum required distribution.

**Investment Options** - Participants are allowed to direct the investment of their contributions among the various investment options offered by the Plan. Company contributions are allocated on the same basis as employee contributions.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements have been prepared on the accrual basis of accounting.

**Estimates** - The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates and assumptions that affect certain amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

**Valuation of Investments** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the Plan year.

**Notes Receivable from Participants** - Notes receivable from participants are stated at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of March 31, 2025 or 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - The Company pays certain administrative expenses on behalf of the Plan. Expenses that are paid from Plan assets are reflected in the statement of changes in net assets available for benefits.

### 3. INFORMATION CERTIFIED BY THE CUSTODIAN

The following information included in the accompanying financial statements was obtained from data that was prepared and certified as complete and accurate by Capital Bank and Trust Company, the custodian.

### 4. **INCOME TAX STATUS**

The volume submitter plan document adopted by the Plan obtained its latest advisory letter on June 30, 2020, in which the Internal Revenue Service stated that the volume submitter plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the advisory letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025, there are no uncertain positions taken or expected.

### 5. **FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the methodology used to measure the fair value of the Plan's investments. There have been no changes in the methodology used at March 31, 2025 and 2024.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money market fund:** Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is registered with the U.S. Securities and Exchange Commission. The fund is required to publish its daily NAV and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 6. **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their employer contributions and all of the assets will be distributed to the participants based upon the balance in their respective accounts.

### 7. **PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are held by American Funds, an affiliate of Capital Bank and Trust Company who is the Plan custodian and, therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants qualify as party-in-interest transactions.

The Plan's sponsor pays certain administrative expenses of the Plan.

### 8. **SUBSEQUENT EVENTS**

In May 2025, the Company acquired Orion Food Systems, LLC. Effective June 1, 2025, the Plan was amended to allow employees of Orion Food Systems, LLC to contribute if they have an original hire date prior to November 1, 2024.

Management has evaluated subsequent events through December 2, 2025, the date on which the financial statements were available for issue, and identified no further significant events or transactions to disclose.
