- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Queens Law Associates 401(k) Plan, (the "Plan") provides only general information. Readers should refer to the Plan document for a more complete description of the Plan's provisions.

A. **General** – The Plan, a defined contribution plan covering all eligible employees of Queens Law Associates Not-For-Profit Corporation d/b/a Queens Defenders (the "Sponsor"), was established on July 1, 1996, and subsequently restated and amended as of January 1, 2018, and May 1, 2020 and then restated January 1, 2023, to qualify as a profit-sharing plan under Section 401(a) and provide for a 401(k) option under Section 401(k) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), and subsequent amendments.

B. **Contributions**

Elective Deferrals Including Roth 401(k) Deferrals

Each year, participants may elect to make pre-tax or Roth 401(k) deferrals of their total compensation, to be deducted each pay period, up to the maximum amount allowed under the Internal Revenue Service ("IRS") rules. Participants who have attained age 50 or older before the end of the Plan year, and are making maximum contributions, are eligible to make catch-up contributions, up to the maximum as permitted by the IRC.

Safe-Harbor Contributions

Effective January 1, 2022, the Plan Sponsor makes a safe-harbor contribution of 3% of compensation to the Plan to eligible participants. For the year ended December 31, 2022 only, the Plan Sponsor made a 4% safe-harbor contribution to eligible participants.

Employer Profit-Sharing Contributions

Each year the Sponsor may make a discretionary profit-sharing contribution to the participants' accounts.

Rollover Contributions

The Plan accepts rollovers from another qualified retirement plan or an IRA.

C. **Eligibility** – Employees who are at least 18 years of age, and do not fall under any of the excluded employee categories, are eligible to participate in the Plan. Excluded employee categories are non-resident aliens who do not receive any compensation from U.S. sources, and leased employees. To participate in profit-sharing contributions, the employee must be either employed on the last day of the Plan year, or if terminated prior to the Plan year end, be credited with at least 500 hours of service. The entry date for profit-sharing contributions is defined as the first day of the month coinciding with or next following the date requirements are met.

D. **Participant Accounts** – Each participant's account is credited with the participant's contributions and allocations of (a) any Sponsor discretionary matching and or profit-sharing contributions, and (b) Plan earnings (losses), and charged with an allocation of administrative expenses.

E. **Vesting** – Participants are immediately vested in their elective basic contributions plus actual earning thereon. Participants are also immediately 100% vested in any Sponsor discretionary contributions.

Effective January 1, 2023, vesting in the Sponsor's discretionary contributions portion of their accounts is based on years of continuous service. A participant is vested 100% after two years of service. Therefore, effective January 1, 2023, the Plan has a forfeiture account.

**NOTE 1 – DESCRIPTION OF PLAN (Continued)**

- F. **Payments of Benefits** – On termination of service, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Partial withdrawals or installments are only permitted for participants or beneficiaries who must receive a required minimum distribution (“RMD”). The Plan provides that distributions of amounts in excess of \$5,000 require participant consent. For termination of service due to death, distributions will be made within five years of death for all beneficiaries. Hardship distributions are permitted from all participant accounts. In-service distributions are permitted to participants who have not separated from service upon attaining the age of 59 ½.
- G. **Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance and a participant may only have one loan outstanding at any time. The loans are secured by the balance in the participant’s account and bear interest at rates that range from 4.25% to 9.5%, which is commensurate with interest rates charged for similar types of loans by other lenders, as determined by the Plan administrator, and are generally payable in installments over periods ranging from one to five years (unless the loan is used for the purchase of a primary residence, in which case the repayment period may be up to ten years). Principal and interest is paid ratably through monthly payroll deductions.
- H. **Forfeited Accounts** – As of December 31, 2024 and 2023, the balance of available forfeitures for future use was \$201 and \$0, respectively. Any forfeiture amounts will be used to pay reasonable Plan expenses.
- I. **Regulatory Compliance Affecting Retirement Plans** – The Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE 1.0 Act) became law on December 20, 2019. The SECURE Act made major changes to the RMD rules, increasing the age from 70 ½ to 72 to participants over 72 after January 1, 2020. Plans were required to be formally amended for certain other changes if adopted on or before the last day of the 2023 Plan year.

The SECURE Act 2.0 (SECURE 2.0) was signed into law in December 2022, delivering dozens of new retirement-related provisions. These changes build on the original SECURE Act of 2019, which altered the rules around how employees can save and withdraw money from their retirement accounts. SECURE 2.0 further increased the age of RMDs, increased the catch-up contributions for older workers and required automatic enrollment for new plans. The SECURE 2.0 Act increased the age at which individuals must begin taking RMDs to 73 from 72, beginning January 1, 2023, as well as other increases starting in 2023. The SECURE 2.0 Act increases the limit for catch-up contributions for individuals ages 60 to 63, effective for taxable years beginning after December 31, 2024.

The SECURE 2.0 Act increases the limit for catch-up contributions for individuals ages 60 to 63, effective for taxable years beginning after December 31, 2024. In addition, the SECURE 1.0 Act and further by the SECURE 2.0 Act lowered the eligibility requirements to enable part-time workers to participate in 401(k) plans. These rules for long-term, part-time workers are expanded to apply to ERISA 403(b) plans, as well. The SECURE 2.0 Act changes the eligibility requirements under 401(k) so that it is easier for part-time employees to participate in them. The enacted law, the SECURE 1.0 Act, allows plans to limit eligibility for participation of part-time employees who reach the later of: (1) age 21 or completion of one 12-month period in which the employee worked at least 1,000 hours (pre-SECURE 1.0 Act rule); or (2) three consecutive years of service with 500 or more hours in each year. Under the SECURE 2.0 Act, a plan must allow a part-time employee to participate if the employee has either satisfied the above rule #1, or if the employee has completed two consecutive 12-month periods in which the employee worked at least 500 hours in each one of the two periods and reached age 21 by the end of the second 12-month period.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

- A. **Basis of Accounting** – The financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

- B. **Use of Estimates** – The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.
- C. **Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, a fair value hierarchy prioritizes observable and unobservable inputs used to measure fair value into three levels, as described in Note 4.
- Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.
- D. **Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. A loan that is considered in default is reported as a deemed distribution, which is a taxable event for the participant.
- E. **Payment of Benefits** – Benefits are recorded when paid.
- F. **Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. The Sponsor pays certain expenses related to the Plan, which are excluded from these financial statements. The administrative expenses charged by Alerus Financial, N.A. (“Alerus”) are paid directly by the Plan Sponsor on a quarterly basis. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in the administrative expenses in the accompanying financial statements. Investment related expenses are included in net appreciation in fair value of investments.
- G. **Due to Broker** – Represents amounts due to broker for mutual funds transactions not settled as of year end.

**NOTE 3 – INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN AS COMPLETE AND ACCURATE**

As noted in the independent auditors' report, the Plan administrator has elected the method of compliance in accordance with ERISA Section 103(a)(3)(C) as permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information was certified as complete and accurate by Alerus, the custodian of the Plan, and was not subjected to any auditing procedures performed by the independent auditors except for comparing such information to information included in the Plan’s financial statements.

Notes receivables from participants of \$138,733 and \$150,054 as of December 31, 2024 and 2023, respectively, and interest income on notes receivable from participants of \$7,032 and \$7,820, for the years then ended, respectively, have also been certified by the custodian.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Money Market Funds**

Money market funds are valued at the daily closing price as reported by the fund. Money market funds held by the Plan are for investments and benefit payments.

**Mutual Funds**

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments as of December 31, 2024 and 2023 are money market funds managed by Alerus. Alerus is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Net appreciation and interest earned by the Plan are net of fees charged by Alerus. Fees paid by the Plan to Alerus amounted to \$48,604 and \$40,375 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 6 – TAX STATUS**

The Plan has adopted a non-standardized pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the non-standardized pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the non-standardized pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. Plan management and the Plan administrator have analyzed the tax positions taken by the Plan, and have concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the balance of participant accounts will be distributed in a lump sum.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 – PROFIT-SHARING CONTRIBUTION RECEIVABLE**

Profit-sharing contributions receivable of \$1,046,390 and \$922,931 as of December 31, 2024, and 2023, respectively, represents the employer matching and profit-sharing contributions which were remitted to the Plan in the following year. All employer contributions are expected to be collected; no allowance is deemed necessary.

**NOTE 10 – SUBSEQUENT EVENTS**

Management has evaluated, for potential recognition and disclosure, events subsequent to the statement of net assets available for benefits date through December 8, 2025, the date the financial statements were available to be issued.

In 2025, numerous employees were terminated due to the Plan sponsor losing its Government funding source. These terminated employees were transferred to another organization that received the Government Funding. As a result of the terminations, a partial termination of the Plan occurred in 2025 and the terminated employees became fully vested in their employer contributions.
