Reason for not filing on time:

As a small business, we submitted our termination request to Paychex 12/7/22 due to lack of participation. Our plan was managed through Paychex, who sent reminder notices and helped me to file Form 5500 electronically through their website. After we cancelled, either they stopped sending that reminder and allowing me to use their system to file, or I just missed it. But I was not aware I needed to file any more after we cancelled. I filed a "Final" after receipt of this letter and working with Paychex support to complete the 5500.

We only have 5 full time employees today and are still paying off EIDL debt from the pandemic. Even though my fault, fines and penalties associated with this missing filing would be difficult to bear. Please let me know if it is possible to have them waived.
