## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements*

We have performed an audit of the financial statements of The Poca Valley Bank KSOP (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

## **The Poca Valley KSOP**

### **Notes to Financial Statements**

#### **Note 1. Plan Description**

The following description of The Poca Valley Bank KSOP (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering eligible employees of Poca Valley Bankshares and subsidiaries (the "Company") who have one year of service and are age 21 or older, except any employee covered by a collective bargaining agreement, any leased employee, or a non-resident alien who received no earned income. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

##### **Contributions**

Each year, participants may contribute an amount up to the maximum annual limits allowed by the Internal Revenue Code, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contribution into various investment options offered by the Plan. The Company matches 100% of employee's elective deferrals up to 3% of their eligible compensation, and 50% of elective deferrals between 3% and 5% of eligible compensation. The Company's matches are in the form of Company stock.

Additional amounts may be contributed at the option of the Company's Board of Directors. Employer matching contributions of \$254,382 and discretionary contributions of \$143,112 were made for plan year 2024, of which \$220,230 will be paid in the following year in the form of Company stock.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements

### Vesting

Participants are immediately vested in their deferral contributions, rollover contributions, plus actual earnings thereon. Vesting in the Company contribution portion of their accounts is based on years of continuous service as follows:

### Payment of Benefits

A participant, prior to separation from service, may elect a distribution of all or any portion (as permitted by the Plan) of a participant's account balance attributable to deferral contributions if the participant has either incurred a hardship in accordance with the safe harbor hardship rule or attained the age of 59½ or the later of normal retirement age. A participant who receives a distribution of elective deferrals on account of hardship shall be prohibited from making elective deferrals and employee contributions under this and all other plans of the employer for six months after receipt of the distribution.

Distribution of all or any portion of a participant's vested account balance is attributable to qualified non-elective contributions, qualified matching contributions, non-elective contributions, regular matching contributions, or safe harbor contributions if the Participant has attained the age of 59½ or the later of normal retirement age.

If a participant terminates employment and their vested eligible rollover account balance is not greater than \$5,000 (disregarding Rollover Contributions), they may elect to receive their distribution from the Plan in a lump-sum or to roll over the distribution to another retirement plan such as an individual retirement account (IRA). If the balance exceeds \$5,000 (disregarding Rollover Contributions), the participant may elect to receive their distribution of all or a portion of their benefits under the Plan in either a lump-sum or in installments not to exceed the life expectancy of the employee or beneficiary. If the value of the participant's vested eligible account balance is more than \$1,000 and the participant does not elect either to receive or to roll over their account balance, then the account will be automatically rolled over to an IRA. If the amount of the participant's vested eligible account balance is less than \$1,000 and the participant does not elect either to receive or to roll over their account balance, then a distribution will be automatically paid in a lump-sum to the participant. Distributions may be made in cash, Company stock, or both.

### Voting Rights

The Trustee shall vote all Company stock held by it as part of the Plan's assets.

Provided, however, that if any agreement entered into by the Trust provides for voting of any share of Company stock pledged as security for any obligation of the Plan, then such shares of Company stock shall be voted in accordance with such agreement. If the Trustee does not timely receive voting directions from a participant or beneficiary with respect to Company stock allocated to that participant's or beneficiary's Company stock account, the Trustee shall vote such Company stock.

### **Put Option**

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

### **Diversification**

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000. The maximum number of outstanding notes receivable is one. The notes receivable are secured by the balance in the participant's account, and bear interest at the Prime rate plus 1%. Notes must be repaid within five years, unless the purpose is to obtain a mortgage on a primary residence, whereas the loan must be repaid within thirty years. Principal and interest are prepaid or paid ratably through payroll deductions.

### **Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$13,085 and \$8,068, respectively. These accounts will be used to reduce future employer contributions and pay administrative expenses. There were no forfeited nonvested accounts utilized to reduce employer contributions and administrative expenses for the year ended December 31, 2024.

### **Administrative Expenses**

Administrative expenses incurred by the Plan may be paid by either the Company or the Plan on a discretionary basis.

## **Note 2. Summary of Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts acquired directly from the issuer. Contract value is the relevant measurement attribute for these fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that may affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts acquired directly from the issuer, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

### **Payment of Benefits**

Benefit payments are recorded when paid.

## Notes to Financial Statements

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

The Plan has evaluated subsequent events through December 9, 2025, the date the financial statements were available to be issued.

### Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The Plan's Company stock and pooled separate account investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of

different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair values as of December 31, 2024 and 2023. Classification in the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

### **Level 2 Fair Value Measurements**

The fair value of the pooled separate accounts is based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs for the pooled separate accounts include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs. The pooled separate accounts invest in securities that have observable Level 1 or Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While underlying assets values are publicly quoted prices, the net asset value (NAV) of a unit in a pooled separate account is not publicly quoted. Units can be issued or redeemed on any business day at the NAV. All earnings and gains and losses are reflected in the computation of the NAV and are realized by the participants upon withdrawal. No distributions of income and gains and losses are made to the participants.

### **Level 3 Fair Value Measurements**

The Plan Sponsor's common stock is reported at fair value, which is determined by the Board of Trustees of the Plan with the assistance of an independent valuation specialist using available financial data. As of December 31, 2024 and 2023, the valuation approach used to value the common stock were the net asset method, capitalization of earnings method, and the market approach. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and fair value of the Plan Sponsor assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability. Significant changes to these inputs could have resulted in significantly higher or lower fair value measurement for the common stock. The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the financial statements of the Plan Sponsor. The appraiser prepares a preliminary report which Plan management, along with the trustee, reviews in detail, discusses, and approves.

**Note 5. Investment Contract with Insurance Company**

Participants may also invest in the Talcott Fixed Account issued by the Great West Life and Annuity Insurance Company. Empower Retirement has assumed Talcott Life's obligations for this investment. Guarantees are based on claims-paying ability of the issuing company, Hartford Life Insurance Company. This investment meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Contributions to a participant's account provide a guaranteed amount of lifetime annuity income. The declared interest rate was 2.80% and 1.75% for the years ended December 31, 2024 and 2023, respectively. The actual average yield earned by the Plan was 2.80% and 1.77% for the years ended December 31, 2024 and 2023, respectively.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The following represents the total contract value of this investment contract held by the Plan.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**Note 6. Related Party Transactions and Party in Interest Transactions**

Certain Plan investments are managed by Empower Annuity Insurance Company of America, the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 8. Tax Status**

The Plan uses an individually designed document for its original plan documents and amendments. The individually designed plan provider has received an opinion letter from the IRS dated October 20, 2013, as to the plan's qualified status. The opinion letter has been relied upon by this Plan. The Plan has been amended since the opinion letter was received; however, the Plan Administrator believes the Plan is designed (including all amendments to the Plan) and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Certification**

Certain information related to investments, with the exception of Poca Valley Bankshares common stock, and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America, the custodian of the Plan.
